HOUSE AMENDMENT NO. 3 HOUSE BILL NO. 222

AMEND House Bill No.	. 222 after line	6 and before lin	ne 7 by ins	serting the following:

"(b) Before making changes in the boundaries of a reorganized school district, the State Board of Education shall must consult with the school boards of the districts affected by the proposed change. Thereafter, the State Board of Education shall must submit for approval or rejection the question of the change of boundary to the qualified voters of the district or districts affected at a special referendum to be held for that purpose, after 2 weeks' notice of the referendum and proposed change has been posted at the school or schools of the district or districts affected. The referendum shall must be conducted in each district by the school board of the district. Any person who possesses the qualifications prescribed in § 1077 of this title may vote at the referendum. The question shall must be determined by a majority of the total vote cast in each district affected. Each school board shall must immediately certify to the State Board of Education the result of the referendum in the district.

(c) Subject to subsection (a) of this section, the State Board of Education may change or alter the boundaries of any reorganized school district without a referendum of the voters if the written consent of the owners of the real property to be transferred has been obtained and if also the school boards of the districts affected by such change or alteration have adopted resolutions favoring such change or alteration."

FURTHER AMEND House Bill No. 222 by deleting lines 17 through 78 in their entirety and inserting in lieu thereof the following:

(3)a. In its decision and order to change or alter a school district boundary under this subsection, the State Board of Education shall adopt a transition, resource, and implementation plan. The plan shall be developed by the Wilmington Education Improvement Commission, for presentation to and approval by the State Board, and shall, at a minimum, provide for The State Board of Education shall make its decision and order to change or alter district boundaries under this subsection based on the recommendations of the Consortium as expressed in a transition, resource, and implementation plan for redistricting. The recommendation and plan developed by the Consortium for presentation to the State Board of Education must include all of the following:

24	a. 1. The orderly and minimally disruptive reassignment of students affected by the boundary change
25	and the reassignment of governance-responsibilities; responsibilities.
26	b. 2. Implications for educators, administrators, and other personnel that may lead to equitable
27	adjustments to local collective bargaining agreements; agreements.
28	e. 3. Recommendations on resources Resources that will be required, from state, district, and local
29	sources, to support the redistricting transition and provide for the effective ongoing education of all affected
30	students, and for the support of schools with high concentrations of low income students and English language
31	learners; <u>Learners.</u>
32	d. 4. Student-transportation; transportation.

37	The plan shall permit students to continue their attendance at the school they attended prior to the boundary
38	change, with tuition payments by the sending district as provided in Chapter 6 of this title, until such time as the pupils
39	complete the grade levels offered in that school. If the State Board does not approve the plan as submitted by the
40	Wilmington Education Improvement Commission, it shall notify the chairperson of the Commission in writing, give
41	reasons why the plan was not approved, and allow the Commission to resubmit the plan within 60 days of the chairperson
42	receiving the notice of denial.
43	(4) The State Board shall base its decision to change or alter school district boundaries on a record developed in
44	compliance with state open meetings laws.
45	(5) The authority of the Wilmington Education Improvement Commission and the State Board of Education to act
46	under the provisions of this subsection shall terminate on March 31, 2016.
47	7. Directives for improving secondary education options for City of Wilmington students, such as the
48	provision of additional secondary schools.
49	8. Redrawing of district boundaries in Wilmington and northern New Castle County to better serve
50	the educational interests of all students, including reducing the concentration of low-income students and
51	improving educational services and supports for English Learners and other students at risk.
52	9. An assessment of the educational needs of City of Wilmington students and the resources required

to meet those needs.

54	10. A stipulation that the funding statewide and locally will facilitate effective implementation of the
55	proposed comprehensive plan in a manner that will improve the educational outcomes for all of the students
56	impacted by that plan.
57	11. A timetable for implementing each element of the redistricting plan and the designated
58	responsibility for carrying out responsibilities until the date of full implementation.
59	12. A process for the ongoing monitoring and evaluation of the educational impacts and outcomes of
60	implementation, which will include an annual report by the Consortium to the Governor, the General
61	Assembly, the Secretary of Education, and the State Board of Education.
62	13. The plan must permit students to continue their attendance at the school they attended prior to the
63	boundary change with tuition payments made by the sending district as provided in Chapter 6 of this title until
64	such time as the pupils complete the grade levels offered in that school.
65	b. The Consortium's recommendation and plan may include all of the following:
66	1. Recommendations for changes in policies and practices that will improve the coordination and
67	collaboration among districts and charter schools serving students in the City of Wilmington and New Castle
68	County, including changes in the authorization of charter schools.
69	2. Recommendations for improvements to access to high-quality early education programs for all
70	students in the areas impacted by the proposed change in district boundaries.
71	3. Recommendations for improvements of the provision and coordination of before and after-school
72	services for students and families in the areas impacted by the proposed change in district boundaries.
73	4. Recommendations for policies and practices associated with student assignment and school choice.
74	5. Recommendations for addressing additional transportation costs generated by enabling students to
75	complete their studies in schools attended prior to the boundary changes.
76	c. All school districts, including the New Castle County Vocational-Technical School District, and all
77	charter schools operating in the City of Wilmington and New Castle County must cooperate fully with the
78	Consortium in the development of the redistricting plan, including the timely provision of student, financial,
79	personnel, and facilities data as well as other operational data.
80	d. The Consortium's recommendation and plan must be reviewed and acted upon by the State Board of
81	Education on or after January 1, 2021 and no later than April 1, 2021 to take effect on or after July 1, 2023 and no
82	later than July 1, 2025."
