HOUSE AMENDMENT NO. 2 TO HOUSE SUBSTITUTE NO. 1 FOR HOUSE BILL NO. 255

1	AMEND House Substitute No. 1 for House Bill No. 255 by deleting lines 64 through 66 in their entirety and
2	inserting in lieu thereof the following:
3	"(d) The Boiler Safety Program, with the approval of the General Assembly, shall establish appropriate fees for all
4	activities and services provided by the Program, including, but not limited to, commissions, inspections and examinations.".
5	FURTHER AMEND House Substitute No. 1 for House Bill No. 255 by deleting lines 67 through 71 in their
6	entirety and inserting in lieu thereof the following:
7	"The fees established in this subsection shall be credited to a dedicated Boiler Safety 4 Administration Fund. Any
8	monies remaining in the Boiler Safety Administration Fund at the end of the fiscal year will 5 remain in the Boiler Safety
9	Administration Fund. The Boiler Safety Administration Fund shall be maintained in a 6 separate interest-bearing account
10	and shall be administered by the Department.".
11	FURTHER AMEND House Substitute No. 1 for House Bill No. 255 by inserting after line 122 the following:
12	"Section 5. Amend Chapter 74B, Title 7 of the Delaware Code by making deletions as shown by strike through
13	and insertions as shown by underline as follows:
14	§ 7406B. Fees.
15	(a) The Department may charge fees as set forth in this section. A fee enumerated in this section supersedes any
16	previously enacted equivalent fee, whether codified or not. A previously enacted fee not included in this section remains in
17	effect to the extent they are levied by the Department and permitted by law.
18	(b) Boiler Safety.

20	Boiler 1-year Certification- \$30.00
21	Boiler 2-year Certification- \$60.00

SYNOPSIS

This amendment removes the authority for the Department to establish fees to approximate and reflect the costs to operate the Boiler Safety Program, establishes and updates the Boiler Safety Program fees to Chapter 74B, Title 7 of the Delaware Code. Also HA 1 is revised to make a technical change regarding the handling of fee payments.
