HOUSE BILL NO. 45

AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO CONSUMER PROTECTION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

- 3 § 2523. Administrative process and appeals
- 4 (f) Personal jurisdiction by acts of nonresident respondents. As to any administrative proceeding authorized by
- 5 this section, personal jurisdiction may be exercised over any nonresident respondent who, in person or through an agent,

6 commits any of the acts identified in § 3104(c) of Title 10 that would constitute legal presence in the State.

- 7 (g) Service of process to obtain personal jurisdiction. Any of the following methods of service of process shall be
- 8 sufficient to obtain personal jurisdiction over a respondent in an administrative proceeding authorized by this section:
- 9 (1) Personal hand delivery.
- 10 (2) Any method of service of process effective under Rule 4(f) of the Superior Court Rules of Civil
- 11 <u>Procedure.</u>
- 12 (3) Any method of service of process that would be effective to obtain personal jurisdiction in the
- 13 Superior Court under § 3104 of Title 10.
- 14 (h) Administrative hearing subpoenas. Upon the request of any party to an administrative proceeding authorized
- 15 by this section, the administrative hearing officer is empowered to issue subpoenas to non-parties to allow for witnesses or
- 16 <u>other evidence to be presented at an administrative hearing</u>. If the non-party fails to comply with the subpoena, the party
- 17 which requested the subpoena may seek an order from the Superior Court compelling the non-party to comply with the
- 18 subpoena. An order issued by the Superior Court pursuant to this subsection may be punished by the Superior Court as a
- 19 <u>contempt of Court.</u>

SYNOPSIS

This Act clarifies (i) how personal jurisdiction shall be obtained over nonresident respondents in administrative proceedings brought by the Director of Consumer Protection pursuant to Section 2523, Title 29 of the Code, and (ii) the manner in which service of process may be made upon respondents in those proceedings. This Act also empowers administrative hearing officers appointed under Section 2523(b), Title 29 to issue subpoenas upon request of the parties to the administrative proceeding, in order to enable the parties to present evidence not otherwise available to them.
