HOUSE CONCURRENT RESOLUTION NO. 10

RECOGNIZING MARCH 2017 AS NATIONAL EYE DONOR MONTH & THE 60TH ANNIVERSARY OF LIONS EYE BANK OF DELAWARE VALLEY.

1	WHEREAS, March 2017 is National Eye Donor Month and the 60th anniversary of Lions Eye Bank of Delaware
2	Valley; and
3	WHEREAS, the State of Delaware supports and promotes the health and welfare of its residents through various
4	statewide, neighborhood-based and national awareness initiatives; and
5	WHEREAS, vision is one of several important senses that contribute to the general well-being and quality of life
6	of Delaware's citizens and the gift of sight is deserved by all; and
7	WHEREAS, some residents of Delaware experience diminishing vision and blindness as a result of illnesses and
8	injuries affecting the corneal tissue of their eyes; and
9	WHEREAS, the Eye Bank Association of America (EBAA), the oldest transplantation association in the United
10	States, accredits Eye Banks and develops standards of practice in the recovery, preservation, storage and distribution of eye
11	tissue for transplantation and research, as determined by the ophthalmological medical community; and
12	WHEREAS, Delaware residents receive Eye Banking care and services from EBAA accredited facility, Lions Eye
13	Bank of Delaware Valley, whose mission is restoring sight through cornea transplantation since 1957; and
14	WHEREAS, each year, over 70,000 corneal transplantation surgeries are performed at EBAA accredited Eye
15	Banks; and
16	WHEREAS, it is recognized that the benevolent offer of organ, tissue and cornea donation and transplantation is
17	an act of heroism by donors and their families; and
18	WHEREAS, it is only through the generosity of donors and their families, who say 'yes' to cornea donation, in
19	the midst of their grief, that recipients of cornea transplants are able to regain vision; and
20	WHEREAS, the Eye Bank of Association of America honors each year in March donors and their families who
21	unselfishly consider members of the community in need of a sight-saving transplant.
22	NOW, THEREFORE:

- BE IT RESOLVED by the House of Representatives of the 149th General Assembly of the State of Delaware, the Senate concurring therein, that the month of March 2017 shall be recognized as "Eye Donor Month" and the General Assembly further recognizes and celebrates the 60th anniversary of the Lions Eye Bank of Delaware Valley in the State of
