HOUSE OF REPRESENTATIVES 149th GENERAL ASSEMBLY

HOUSE BILL NO. 117

AN ACT TO AMEND CHAPTER 17, TITLE 22 OF THE DELAWARE CODE RELATING TO MUNICIPAL TAX INCREMENT FINANCING.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

I	Section 1. Amend § 1/02, 11tle 22 of the Delaware Code by making deletions as snown by strike through and
2	insertions as shown by underline as follows:
3	§ 1702. Definitions.
4	(k) "Issuing Body" or "issuing body" means a municipality (other than the municipality issuing bonds under
5	this Chapter or Chapter 18 of this title), county or other political subdivision, department or agency of the State when it
6	acts to issue a bond, a note, or other similar instrument.
7	(1) "Municipality" or "municipality" means any town or city located in the State with a population in excess of
8	50,000 <u>35,000</u> people.
9	(1)(m) "Original assessed value" means the assessed value as of January 1 of that year preceding the effective
10	date of the resolution creating the TIF District under § 1706 of this title.
11	(n) "Other Obligations" or "Other Obligation" means a bond, a note, or other similar instrument issued by an
12	issuing body for any of the purpose stated in § 1705 of this title.
13	(m)(o) "Tax increment" means for any tax year the amount by which the assessed value as of January 1
14	preceding that tax year exceeds the original assessed value.
15	(n)(p) "Tax year" means the fiscal year for the municipality.
16	(o)(q) "TIF" District" means an area designated by a resolution described in § 1706 of this title.
17	Section 2. Amend § 1708, Title 22 of the Delaware Code by making deletions as shown by strike through and
18	insertions as shown by underline as follows and by redesignating accordingly:
19	§ 1708. Uses of special fund; issuance of general obligation bond.
20	(a) Uses of special fund when no bonds outstanding When no authorized by this chapter are outstanding
21	with respect to a TIF District and the governing body of the municipality so determines, moneys in the special fund for
22	that TIF District created pursuant to § 1707 of this title may be: Page 1 of 2

23	(4) Used to pay or to reimburse an issuing body for debt service which the municipality is obligated to pay
24	(whether such obligation is general or limited) on Other Obligations under an agreement described in subsection (b) of
25	this section; or
26	(4)(5) Paid to the municipality to provide funds to be used for any legal purpose as may be determined by the
27	municipality.
28	(b) Pledge agreement The municipality may pledge, by written agreement, that amounts deposited to the
29	special fund created for the TIF District pursuant to § 1707 of this title shall be paid over to secure the payment, or
30	reimbursement of a payment, of debt service on Other Obligations. Such agreement shall be between the municipality
31	and the issuing body, and shall run to the benefit of and be enforceable on behalf of any holder, of such Other
32	Obligations.
33	(b)(c) Restrictions on use of special funds. – When any bonds authorized by this chapter are outstanding with
34	respect to a TIF District and the governing body of the municipality so determines, moneys in the special fund for that
35	TIF District created pursuant to § 1707 of this title may be used as provided in subsection (a) or (b) of this section in
36	any fiscal year by the municipality, but only to the extent that:
37	Section 3. Amend Chapter 17, Title 22 of the Delaware Code by making deletions as shown by strike through and
38	insertions as shown by underline as follows:
39	§ 1708A. Pledge of revenue from taxes on tax increment into other fund.
40	The municipality may pledge, by written agreement, that some or all of its property taxes levied on the tax
41	increment shall be paid into a special fund created by an issuing body for the payment or reimbursement of the debt service
42	on Other Obligations. Such agreement shall be between the municipality and such issuing body and shall run to the benefit
43	of and be enforceable on behalf of any holder of such Other Obligations.
44	Section 4. This Act shall become effective upon its enactment into law.

SYNOPSIS

This Act amends the definition of "municipality" in the Municipal Tax Increment Financing Act to allow the City of Dover to take advantage of the economic development opportunities afforded by the Municipal Tax Increment Financing Act, and enables such municipality to pledge the tax levied on the tax increment to the payment of bonds issued by other issuers in the State for the purposes of the Municipal Tax Increment Financing Act.
