## DELAWARE STATE SENATE 149th GENERAL ASSEMBLY

## SENATE CONCURRENT RESOLUTION NO. 40

RECOMMENDING THE JOINT FINANCE COMMITTEE MAKE DESIGNATED CHANGES TO THE STATE OPERATING BUDGET FOR FISCAL YEAR 2018.

| 1  | WHEREAS, it is the desire of the Senate of the 149th General Assembly to lend assistance to Delaware's non-        |

| 2  | profit community in the delivery of services they provide to the citizens of The First State; and                  |
| 3  | WHEREAS, state assistance is delegated to non-profit agencies through the annual Grants-in-Aid bill; and           |
| 4  | WHEREAS, the Senate of the 149th General Assembly has a constitutional obligation to appropriate no more than      |
| 5  | 98% of projected revenues; and   |
| 6  | WHEREAS, complying with the state spending mandate, while financing the FY 2018 Grants-in-Aid Bill, will           |
| 7  | require that certain adjustments be made to the pending state operating budget (House Bill 275).                   |
| 8  | NOW, THEREFORE:  |
| 9  | BE IT RESOLVED by the Senate of the 149th General Assembly of the State of Delaware, the House of                  |
| 10 | Representatives concurring therein, that the General Assembly hereby requests the cooperation of the Joint Finance |
| 1  | Committee to redraft House Bill 275 to accomplish the following actions:   |
| 12 | 1. Fully adopt the governor's proposed state employee health care adjustments, including elimination of            |
| 13 | the "double share" benefit, (an additional reduction of \$6.4 million); and  |
| 14 | 2. Cut non-personnel costs of all state agencies by 1.1%, (an additional reduction of approximately \$22           |
| 15 | million); and  |
| 16 | 3. Reduce the House of Representatives' travel line item by \$5,000, (12.5%); and                                  |
| 17 | 4. Reduce the House of Representatives' mileage line item by \$7,000, (10%); and                                   |
| 18 | 5. Reduce the Senate's travel line item by \$2,500, (12.5%); and   |
| 19 | 6. Reduce the House of Representatives' mileage line item by \$4,000, (10%); and                                   |
| 20 | 7. Reduce the contractual services' line item in the Office of the Governor by 5% or \$7,635.                      |
