DELAWARE STATE SENATE 149th GENERAL ASSEMBLY

SENATE BILL NO. 143

AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO THE ESTABLISHMENT OF THE BEHAVIORAL HEALTH CONSORTIUM.

1	WHEREAS, the Behavioral Health Consortium, herein referred to as the Consortium, has met a total of two times
2	in 2017; and
3	WHEREAS, the Consortium will develop a statewide integrated plan for addressing the prevention and treatment
4	of substance use and mental health; and
5	WHEREAS, the Consortium has begun fostering collaboration between private and public partners who are
6	directly working in the field of behavioral and substance abuse; and
7	WHEREAS, the Consortium members, in conjunction with legislative partners, have identified the need for
8	additional partners to become members of the Consortium composition; and
9	WHEREAS, these additions to the Consortium's membership will only enhance the diversity of the stakeholders,
10	both subject matter experience and cultural competence;
1	NOW, THEREFORE,
12	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:
13	Section 1. Amend Chapter 51, Title 16 of the Delaware Code by making deletions as shown by strike through and
14	insertions as shown by underline as follows:
15	Subchapter VIII-A. Behavioral Health Consortium.
16	§ 5196. Organization and composition of the Consortium.
17	(a) The Consortium is composed of 21 23 members, as follows:
18	(1) Seven individuals, or their designees, who are members of the Consortium by virtue of their respective
19	positions, as follows:
20	c. The Chair of the Center for Health Innovation. The Chair of the Delaware Mental Health Association.
21	(3) One member of the Senate, appointed by the President Pro Tempore of the Senate, to serve at the pleasure of
22	the President Pro Tempore. Two members of the Senate appointed by the President Pro Tempore of the Senate,
23	one appointed from the majority caucus and one appointed from the minority caucus.

24 (4) One member of the House of Representatives, appointed by the Speaker of the House, to serve at the pleasure
25 of the Speaker. Two representatives appointed by the Speaker of the House of Representatives, one appointed
26 from the majority caucus and one appointed from the minority caucus.

This Bill amends the membership of the Behavioral Health Consortium to include two members of both the House and Senate and clarifies the name of the Delaware Mental Health Association.
