HOUSE CONCURRENT RESOLUTION NO. 59

RECOGNIZING THE EASTERSEALS/CAI VOLLEYBALL CHALLENGE AND THE VOLLEYBALL AMBASSADOR, EMILY HURST, IN THE 13TH YEAR OF DEMOCRAT AND REPUBLICAN TEAM PARTICIPATION.

1	WHEREAS, Easterseals provide services and support to people with disabilities or special needs and their
2	families, and have done so for 70 years, whether those disabilities or needs occurred at birth or resulted from traumatic
3	injury, disease, or the aging process; and
4	WHEREAS, Easterseals Delaware & Maryland's Eastern Shore annually support thousands of children and adults
5	through direct and indirect services such as physical, occupational and speech therapies, employment and adult day
6	programs, caregiver services, and assistive technology; and
7	WHEREAS, the Easterseals/CAI Volleyball Challenge is in its 37th year, and since 2001, Easterseals raised more
8	than \$5 million through the Volleyball Challenge, providing much-needed funding for services that benefit people with
9	disabilities; and
10	WHEREAS, Delaware Democrat and Republican teams have engaged in friendly competition against one another
11	for the past 12 years to raise awareness and generate funds for this great cause; and
12	WHEREAS, the Delaware Democrat and Republican teams have collectively raised more than \$49,000 in the last
13	12 years; and
14	WHEREAS, the Delaware Republican team is currently leading the Democrat team 7 matches to 5 matches; and
15	WHEREAS, an ambassador is selected annually to inform the public at the annual volleyball tournament about the
16	important services provided by Easterseals; and
