HOUSE RESOLUTION NO. 28

RECOGNIZING APRIL 28, 2018, AS WORKERS MEMORIAL DAY.

| 1 | WHEREAS, on April 28, 2018, the American Federation of Labor and Congress of Industrial Organizations |

| 2 | (AFL-CIO) and the American Federation of State, County & Municipal Employees (AFSCME), along with trade unions |
| 3 | around the county and the world, will observe Workers Memorial Day; and |
| 4 | WHEREAS, this day has been set aside every year since 1989 to honor and remember workers killed or injured |
| 5 | on the job, and to recommit to the fight for safe and healthful workplaces for all; and |
| 6 | WHEREAS, despite the creation of the Occupational Safety and Health Administration on April 28, 1971, and |
| 7 | great strides made to protect workers in the years since, the U.S. Bureau of Labor statistics show that 5,190 workers were |
| 8 | killed on the job in 2016; and |
| 9 | WHEREAS, the AFL-CIO, AFSCME, and their allies will use this Workers' Memorial Day to: |
| 10 | 1. Defend safety and health protections and workers' rights |
| 11 | 2. Support the passage of the federal Protecting America's Workers Act to provide OSHA protection for millions |
| 12 | of workers without it, stronger criminal and civil penalties for companies that seriously violate job safety laws, and |
| 13 | improved anti-retaliation protections for workers who raise job safety concerns |
| 14 | 3. Increase attention to the safety and health of Latino and immigrant workers who are at a much greater risk of |
| 15 | death and injury |
| 16 | 4. Ensure workers' right to have a voice on the job and to freely choose to form a union |
| 17 | 5. Demand higher wages for workers; |
| 18 | NOW, THEREFORE: |
| 19 | BE IT RESOLVED by the House of Representatives of the 149th General Assembly of the State of Delaware that |
| 20 | we do hereby join with the AFL-CIO and AFSCME in observing April 28, 2018, as Workers' Memorial Day and |
| 21 | remembering those who have suffered and died on the job. |
| 22 | BE IT FURTHER RESOLVED that we encourage the AFL-CIO and AFSCME in their ongoing efforts to protect |
