HOUSE OF REPRESENTATIVES 149th GENERAL ASSEMBLY

HOUSE BILL NO. 411

AN ACT TO AMEND TITLE 10 AND TITLE 29 OF THE DELAWARE CODE RELATING TO CONTINUITY OF GOVERNMENT OPERATIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all members elected to each house thereof concurring therein):

1 Section 1. Amend § 1801, Title 10 of the Delaware Code by making deletions as shown by strike through and 2 insertions as shown by underline as follows: 3 § 1801. Short title. 4 This chapter shall be is known and may be cited as the "Emergency Interim Judicial Succession Act." 5 Section 2. Amend § 1802, Title 10 of the Delaware Code by making deletions as shown by strike through and 6 insertions as shown by underline as follows: 7 § 1802. Statement of policy. 8 Because of the possibility of an attack upon the United States of unprecedented size and destructiveness, and in 9 order, in the event of such attack, The General Assembly finds and declares that in the event of an emergency event, it is 10 necessary to provide for special emergency judges who can exercise the powers and discharge the duties of judicial offices 11 if regular judges are unavailable. The General Assembly finds and declares that the creation of special emergency judges 12 does all of the following: 13 (1) to assure Assures continuity of government through legally constituted leadership, authority authority, and 14 responsibility in offices of the government of the State; State. 15 (2) to provide Provides for the effective operation of governments government during an emergency; 16 emergency. 17 (3) and to facilitate Facilitates the early resumption of functions temporarily suspended, it is found and 18 declared to be necessary to provide for special emergency judges who can exercise the powers and discharge the duties 19 of judicial offices in the event regular judges are unavailable suspended.

115	Assembly during an emergency event would be impracticable, would admit of undue delay cause undue delay, and
116	would jeopardize continuity of operation of a legally constituted General Assembly; and Assembly.
117	(3) That it is therefore It is necessary to adopt special provisions as set out in this chapter for the effective
118	operation of the General Assembly.
119	Section 10. Amend § 1703, Title 29 of the Delaware Code by making deletions as shown by strike through and

138	<u>Delaware</u> Constitution of the State.
139	(3) (5) "Unavailable" means absent from the place of session other than on official business of the General
140	Assembly or unable, for physical, mental mental, or legal reasons, to exercise the powers and discharge the duties of a
141	member of the General Assembly, whether or not such absence or inability would give rise to a vacancy under existing
142	constitutional or statutory provisions the Delaware Constitution or other law of this State.
143	Section 11. Amend § 1704, Title 29 of the Delaware Code by making deletions as shown by strike through and
144	insertions as shown by underline as follows:
145	§ 1704. Designation of emergency interim successors to members.
146	Each member shall do all of the following:
147	(1) designate Designate not fewer than 3 nor more than 7 emergency interim successors to the member's
148	powers and duties and duties.
149	(2) specify their Specify the order of succession of the individuals selected under paragraph (1) of this section.
150	(3) Each member shall review and, as necessary, promptly revise Review and revise the designations of
151	emergency interim successors to the member's powers and duties to insure ensure that at all times there are at least 3
152	such qualified emergency interim successors.
153	Section 12. Amend § 1705, Title 29 of the Delaware Code by making deletions as shown by strike through and
154	insertions as shown by underline as follows:
155	§ 1705. Status, qualifications qualifications, and term of emergency interim successors.
156	(a) An emergency interim successor is 4 an individual who is designated for possible temporary succession to the
157	powers and duties, but not the office, of a member.
158	(b) No person shall An individual may not be designated or serve as an emergency interim successor unless the
159	person may individual may, under the Constitution and statutes Delaware Constitution or other law of this State, hold the
160	office of the member to whose powers and duties the person individual is designated to succeed, but no constitutional or
161	statutory provision succeed. However, no provision of the Delaware Constitution or other law of this State prohibiting a
162	member from holding another office or prohibiting the holder of another office from being a member shall be is applicable
163	to an emergency interim successor.
164	(c) An emergency interim successor shall serve serves at the pleasure of the member designating the person

<u>individual</u> or of any subsequent incumbent of the legislative office.

166	Section 13. Amend § 1706, Title 29 of the Delaware Code by making deletions as shown by strike through and

168	§ 1706. Contingent method of designating emergency interim successors.
169	(a) Prior to an attack Before an emergency event, if a member fails to designate the required minimum number or
170	emergency interim successors within 30 days following July 11, 1961 of the member's taking of the oath of office, or, after
171	such period, if for any reason the number of emergency interim successors for any member falls below the required
172	minimum and remains below such minimum for a period of 30 days, then the required minimum number of emergency
173	interim successors shall be designated as follows must be designated under the following procedures:
174	(1) The President Pro Tempore of the Senate shall designate as many emergency interim successors for the
175	members of the majority party in the Senate as are required to achieve such minimum number.
176	(2) The Minority Leader of the Senate shall designate as many emergency interim successors for the
177	remaining members of the minority party in the Senate as are required to achieve such minimum number.
178	(3) The Speaker of the House of Representatives shall designate as many emergency interim successors for
179	the members of the majority party in the House of Representatives as are required to achieve such minimum number.
180	(4) The Minority Leader of the House of Representatives shall designate as many emergency interim
181	successors for the remaining members of the minority party in the House of Representatives as are required to achieve
182	such minimum number.
183	(b) The President Pro Tempore of the Senate, the Minority Leader of the Senate, the Speaker of the House of
184	Representatives Representatives, and the Minority Leader of the House of Representatives shall may not assign to any or
185	their designees a rank in order of succession higher than that of any remaining emergency interim successor previously
186	designated by a member for succession to the member's own powers and duties.

212	State and the Director of the General Assembly's Division of Research. All such data shall be open to public inspection.
213	(d) The Secretary of State shall inform the Governor, the State Office of Civil Defense Delaware Emergency
214	Management Agency, the Clerk of the House concerned and all emergency interim successors of all such designations,
215	removals removals, and changes in order of succession.
216	The Clerk of each House shall enter all information regarding emergency interim successors for the House in its
217	public journal at the beginning of each General Assembly and shall enter all changes in membership or order of succession
218	as soon as possible after their occurrence.

272	and assuming the duties of a member.

281	while traveling to and from a place of session and shall <u>must</u> be compensated for such travel in the same manner and

amount as a member.

SYNOPSIS

This Act amends Delaware's existing continuity of government laws as required in conjunction with the adoption of House Bill No. 410, which completes the process to amend Article II, § 5 and Article XVII, § 1 of the Delaware Constitution to adopt an "all hazards" approach to continuity of government planning.

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
