DELAWARE STATE SENATE 149th GENERAL ASSEMBLY

SENATE BILL NO. 210

AN ACT TO AMEND TITLES 2, 3, 4, 6, 7, 9, 11, 12, 13, 14, 15, 16, 18, 20, 21, 23, 24, 26, 29, 30 AND 31 OF THE DELAWARE CODE RELATING TO CRIMES AND CRIMINAL PENALTIES.

1 WHEREAS, the General Assembly established the Criminal Justice Improvement Committee in 2014 to review 2 opportunities for efficiencies, including a review of statutes in the Delaware code to identify "disproportionate, redundant, 3 outdated, duplicative, or inefficient statutes" and "crimes that should or should not constitute potential jail time"; 4 WHEREAS, the Criminal Justice Improvement Committee Working Group was created to accomplished the 5 Criminal Justice Improvement Committee's stated goals and has worked diligently for the last two years, in concert with 6 other criminal justice stakeholders, to restore the criminal code to a clear, readable, and proportional code; 7 WHEREAS, the Criminal Justice Improvement Committee has adopted the recommendations of the Working 8 Group to repeal and replace Title 11, Part I, Chapters 1 through 15 of the Delaware Criminal Code and make such 9 additional changes as are needed throughout the code to effectuate this change; 10 WHEREAS, this Act reflect the changes made to other parts of the Code as a result of the changes made by the repeal of Title 11, Part I, Chapters 1 through 15; 11 12 NOW, THEREFORE: 13 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all 14 members elected to each house thereof concurring therein): 15 Section 1. Amend § 309, Title 2 of the Delaware Code by making deletions as shown by strike through and 16 insertions as shown by underline as follows: 17 § 309 Dangerous flying; penalty. 18 Whoever, being an airperson or passenger, while in flight over a thickly inhabited area or over a public gathering

24	Chapter 11. Unmanned aircraft
25	§ 1101 Unlawful use of an unmanned aircraft system; unclassified misdemeanor; class B misdemeanor; class A
26	misdemeanor.
27	(a) Definitions. — The following terms shall have the following meanings as used in this section.
28	(1) "Critical infrastructure" means petroleum refineries, petroleum storage facilities, chemical storage
29	facilities, chemical manufacturing facilities, fuel storage facilities, electric substations, power plants, electric
30	generation facilities, military facilities, commercial port and harbor facilities, rail yard facilities, drinking water
31	treatment or storage facilities, correctional facilities, government buildings, and public safety buildings or facilities.
32	(2) "First responder" means federal, state, and local law-enforcement officers, fire, and emergency medical
33	services personnel, hazardous materials response team members, 9-1-1 dispatchers, or any individual who is
34	responsible for the protection and preservation of life and is directed to respond to an incident that could result in death
35	or serious injury.
36	(3) "Unmanned aircraft system" means a powered, aerial vehicle that:
37	a. Does not carry a human operator;
38	b. Uses aerodynamic forces to provide vehicle lift;
39	c. Can fly autonomously or be piloted remotely; and
40	d. Can be expendable or recoverable.
41	(b) Prohibited acts. — Except as provided in this section, no person shall knowingly operate, direct, or program an
42	unmanned aircraft system to fly:
43	(1) Over any sporting event, concert, automobile race, festival, or other event at which more than 1500 people
44	are in attendance; or
45	(2) Over any critical infrastructure; or
46	(3) Over any incident where first responders are actively engaged in response or air, water, vehicular, ground
47	or specialized transport.
48	(c) Exemptions. — The prohibitions set forth in subsection (b) of this section shall not apply to:
49	(1) An unmanned aircraft system used for law-enforcement purposes; or
50	(2) An unmanned aircraft system flying over property where written permission has been granted by the
51	property owner or occupier; or
52	(3) An unmanned aircraft system operated by an institution of higher education for educational purposes in
53	compliance with Federal Aviation Administration regulations; or

54	(4) An unmanned aircraft system that is being used for a commercial or other purpose if the operator is
55	authorized by the Federal Aviation Administration.
56	(d) Penalties. — Unlawful use of an unmanned aircraft system is an unclassified misdemeanor for a first offense
57	and a class B misdemeanor for a second or subsequent offense, except that in any case where physical injury to a person of
58	damage to property occurs as a result of a violation of this section unlawful use of an unmanned aircraft system is a class A
59	misdemeanor.
60	(e) Preemption. — Only the State may enact a law or take any other action to prohibit, restrict, or regulate the
61	testing or operation of an unmanned aircraft systems in the State. This section preempts the authority of a county of
62	municipality to prohibit, restrict, or regulate the testing or operating of unmanned aircraft systems and supersedes any
63	existing law or ordinance of a county or municipality that prohibits, restricts, or regulates the testing or operating or
64	unmanned aircraft systems.
65	Section 3. Amend § 1041, Title 3 of the Delaware Code by making deletions as shown by strike through and
66	insertions as shown by underline as follows:
67	§ 1041 Wilfully or maliciously starting fires.
68	(a) Whoever wilfully or maliciously sets fire to any woodlot, forest, wild land, property, material or vegetation
69	being or growing upon the lands of another shall be fined not less than \$200, nor more than \$5,000, or imprisoned not more
70	than 2 years, or both.
71	(b) This section shall not apply to the setting of a backfire under the direction of a state forest officer to extinguish
72	a fire then burning, nor to persons setting fire under §§ 1042 and 1043 of this title. [Deleted.]
73	Section 4. Amend § 1045, Title 3 of the Delaware Code by making deletions as shown by strike through and
74	insertions as shown by underline as follows:
75	§ 1045 Trees and shrubs of state forests; penalty.
76	(a) Notwithstanding any other provision of this title, whoever without the consent of the Department of
77	Agriculture wilfully, negligently or maliciously cuts bark from or cuts down, injures, destroys or removes trees or shrubs of
78	any part thereof growing in a state forest or wilfully, negligently or maliciously does or causes to be done any other act to
79	the damage of such forest shall be fined not more than \$1,000 or imprisoned not more than 3 months, or both.
80	(b) Any constable, police officer, forest officer or state officer may arrest without warrant any person found

94	§ 405 Registration of out-of-state liquor agents; violation.
95	(a) In order to promote and protect the public safety and the peace of the community, by reason of the presence of
96	many persons engaged in the enforcement of the laws of other states, any agent, employee, or representative of another
97	state shall register with the Delaware Alcoholic Beverage and Tobacco Enforcement not less than 30 days in advance of
98	each entry into a county for the purpose of observing any alcoholic beverage sales.
99	(b) At the time of registration the person shall provide the following information:
100	(1) A written statement setting forth the identity of the out-of-state official;
101	(2) The purpose of the intended entry into the county;
102	(3) The make, model and license number of each and every vehicle to be used in the conduct of any
103	surveillance activity;
104	(4) The specific establishments at which surveillance will be conducted; and
105	(5) The specific times for surveillance of each establishment.
106	(c) Any person who registers shall be issued a certificate of registration which must be retained in the possession
107	of the person during all investigative or surveillance activities.
108	(d) Any person who fails to register as required by this section, or who having registered violates any provision of
109	this section, shall lose the right to register or the person's registration, as the case may be, for a period of 6 months.
110	(e) Any person who, during the period imposed by subsection (d) of this section, violates this section is guilty of a
111	violation.
112	(f) Upon written request, the Delaware Alcoholic Beverage and Tobacco Enforcement shall release the
113	information regarding agencies and officers who have registered under this section.
114	Section 8. Amend Title 4 of the Delaware Code by making deletions as shown by strike through and insertions as

116	Chapter 8. Tobacco products.

117	§ 801 Definitions.
118	(1) "Coupon" means any card, paper, note, form, statement, ticket or other issue distributed for commercial or
119	promotional purposes to be later surrendered by the bearer so as to receive any tobacco product without charge or at a
120	discounted price.
121	(2) "Distribute" means give, deliver or sell, offer to give, deliver or sell, or cause or hire any person to give
122	deliver or sell, or offer to give, deliver or sell.
123	(3) "Health warning" means any tobacco product or tobacco substitute label mandated by federal law and intended
124	to alert all users of such tobacco product or tobacco substitute to the health risks associated with tobacco use, including, but
125	not limited to, warning labels imposed under the Federal Cigarette Labeling and Advertising Act (15 U.S.C. § 1331 et seq.
126	and the Comprehensive Smokeless Tobacco Health Education Act of 1986 (15 U.S.C. § 4401 et seq.).
127	(4) "Proof of age" means a driver's license or other identification with a photograph of the individual affixed
128	thereon that indicates that the individual is 18 years old or older.
129	(5) "Public place" means any area to which the general public is invited or permitted, including, but not limited to
130	parks, streets, sidewalks or pedestrian concourses, sports arenas, pavilions, gymnasiums, public malls and property owned
131	occupied or operated by the State or by any agency thereof.
132	(6) "Sample" means a tobacco product or tobacco substitute distributed to members of the general public at no cos
133	for the purpose of promoting the product.
134	(7) "Sampling" means the distribution of samples or coupons for redemption of tobacco products or tobacco
135	substitutes to members of the general public in a public place.
136	(8) "Tax stamp" means any required state or federal stamp imposed for the purpose of collecting excise tax
137	revenue.
138	(9) "Tobacco product" means any product that contains tobacco, including, but not limited to, cigarettes, cigars
139	pipe tobacco, snuff or smokeless tobacco and is intended for human consumption or use.
140	(10) "Tobacco store" means any retail establishment where 60% of the retail establishment's gross revenue come
141	from the retail sale of tobacco products and smoking paraphernalia.
142	(11) "Tobacco substitute" means any device employing a mechanical heating element, battery, or circuit
143	regardless of shape or size, that can be used to deliver nicotine into the body through inhalation and that has not been
144	approved by the United States Food and Drug Administration for tobacco cessation or other medical purposes, or any
145	noncombustible product containing nicotine intended for use in such a device that has not been approved by the United
146	States Food and Drug Administration for tobacco cessation or other medical purposes.
147	(12) "Vending machine" means any mechanical, electronic or other similar device which automatically dispense

tobacco products or tobacco substitutes, usually upon the insertion of a coin, token or slug.

149	§ 802 Sale or distribution of tobacco products or tobacco substitutes to minors.
150	(a) It shall be unlawful for any person to sell or distribute any tobacco product or tobacco substitute to another
151	person who has not attained the age of 18 years or to purchase any tobacco product or tobacco substitute on behalf of
152	another such person, except that this section shall not apply to the parent or guardian of another such person.
153	(b) A person engaged in the sale or distribution of tobacco products or tobacco substitutes shall have the right to
154	demand proof of age from a prospective purchaser or recipient of such products.
155	(c) A person engaged in the sale or distribution of tobacco products or tobacco substitutes shall demand proof of
156	age from a prospective purchaser or recipient of such products who is under 27 years of age.
157	§ 803 Notice.
158	A person engaged in the sale or distribution of tobacco products or tobacco substitutes shall post conspicuously at
159	each point of purchase and each tobacco vending machine a notice stating that selling tobacco products or tobacco
160	substitutes to anyone under 18 years of age is illegal, that the purchase of tobacco products or tobacco substitutes by anyone
161	under 18 years of age is illegal and that a violator is subject to fines. The notice shall also state that all persons selling
162	tobacco products or tobacco substitutes are required, under law, to check the proof of age of any purchaser of tobacco
163	products or tobacco substitutes under the age of 27 years. The notice shall include a toll-free telephone number to the
164	Department of Safety and Homeland Security for persons to report unlawful sales of tobacco products or tobacco
165	substitutes. The owners of an establishment who fail to post a notice in compliance with this section shall be subject to a
166	fine of \$100.
167	§ 804 Distribution of samples to minors.
168	(a) It shall be unlawful for any person to distribute tobacco product or tobacco substitute samples or coupons for
169	subsequent receipt of free or discounted tobacco products or tobacco substitutes to another person who has not attained the
170	age of 18 years.
171	(b) A person engaged in sampling shall have the right to demand proof of age from a prospective recipient of
172	samples or of coupons for the redemption of tobacco products or tobacco substitutes.
173	§ 805 Distribution of cigarettes or tobacco substitutes through vending machines.
174	(a) It shall be unlawful for any person to distribute or permit the distribution of tobacco products or tobacco
175	substitutes through the operation of a vending machine in a public place, except as provided in subsection (b) of this
176	section.
177	(b) Pursuant to subsection (a) of this section, a person may distribute or permit the distribution of tobacco products
178	or tobacco substitutes through the operation of a vending machine in a taproom, tavern, tobacco shop or in premises in

which a person who has not attained the age of 18 years is prohibited by law from entering. A tobacco vending machine

must be operated a minimum of 25 feet from any entrance to the premises and must be directly visible to the owner or supervisor of the premises.

(c) It shall be unlawful for any person who owns, operates or manages a business establishment where tobacco products or tobacco substitutes are offered for sale over the counter at retail to maintain such products in any display accessible to customers that is not under the control of a cashier or other employee. This prohibition shall not apply to business establishments to which persons under the age of 18 are not admitted unless accompanied by an adult, tobacco vending machines as permitted under subsection (b) of this section, or tobacco stores. As used in this subsection, "under the control" means customers cannot readily access the tobacco products or tobacco substitutes without the assistance of a cashier or other employee. A display that holds tobacco products or tobacco substitutes behind locked doors shall be constructed as under the control of a cashier or other employee.

§ 806 Distribution of tobacco products.

- (a) No person shall distribute a tobacco product for commercial purposes unless the product is in a sealed package provided by the manufacturer with the required health warning and tax stamp.
 - (b) No person shall distribute any pack of cigarettes containing fewer than 20 cigarettes.

194 <u>§ 807 Penalties.</u>

Notwithstanding any other provision of Delaware law, a person who violates § 802, § 804, § 805 or § 806 of this title shall be guilty of a violation and shall be fined \$250 for the first offense, \$500 for the second offense and \$1,000 for the third and all subsequent offenses. Additionally, and notwithstanding any other provision of Delaware law, in imposing a penalty for a second, third or other subsequent offense under this chapter, the court may order the Department of Finance to suspend the defendant's license for sale of tobacco products, issued pursuant to § 5307 of Title 30, for a period not to exceed 6 months. Upon the suspension of such license, the court shall advise the Department of Finance of the suspension in writing. The holder of the license shall surrender the license to the Department of Finance and no refund of fees shall be paid. For purposes of this subpart, a subsequent offense is one that occurs within 12 months of a prior like offense.

§ 808 Defense.

In any prosecution for an offense under this chapter, it shall be a defense that the purchaser or recipient of tobacco products or tobacco substitutes who had not reached the age of 18 years presented to the accused proof of age which set forth information that would lead a reasonable person to believe that such individual was 18 years of age or older.

§ 809 Liability of employer.

(a) If a sale or distribution of any tobacco product or tobacco substitute or coupon is made in violation of § 802, § 804, § 805 or § 806 of this title, the owner, proprietor, franchisee, store manager or other person in charge of the establishment where the violation occurred shall be guilty of the violation and shall be subject to the fine only if the retail licensee has received written notice of the provisions of §§ 802 through 807 of this title by the Department of Safety and

212	Homeland Security. For purposes of determining the hability of a person who owns or controls franchises or business
213	operations in multiple locations, for a second or subsequent violation of this subpart, each individual franchise or business
214	location shall be deemed a separate establishment.
215	(b) Notwithstanding any other provision of this subpart, in any prosecution for a violation of §§ 802, 804 and 806
216	of this title, the owner, proprietor, franchisee, store manager or other person in charge of the establishment where the
217	alleged violation occurred shall have a defense if such person or entity can establish that prior to the date of the violation:
218	(1) Had adopted and enforced a written policy against selling tobacco products or tobacco substitutes to
219	persons under 18 years of age;
220	(2) Had informed its employees of the applicable laws regarding the sale of tobacco products or tobacco
221	substitutes to persons under 18 years of age;
222	(3) Required employees to sign a form indicating that they have been informed of and understand the written
223	policy required herein;
224	(4) Required employees to verify the age of tobacco product or tobacco substitute customers by means of
225	photographic identification; and
226	(5) Had established and enforced disciplinary sanctions for noncompliance.
227	(c) The defense established in subsection (b) of this section may be used by an owner, proprietor, franchisee, store
228	manager or other person in charge of the establishment no more than twice at each location within any 12-month period.
229	§ 810 Purchase or receipt of tobacco products or tobacco substitutes by minors.
230	(a) It shall be unlawful for any person who has not attained the age of 18 years to purchase a tobacco product or
231	tobacco substitute, to accept receipt of a sample, to exchange a coupon for a tobacco product or tobacco substitute, or to
232	present or offer to another person a purported proof of age which is false, fraudulent or not actually that person's own proof
233	of age, for the purpose of purchasing or receiving any tobacco product or tobacco substitute or redeeming a coupon for a
234	tobacco product or tobacco substitute.
235	(b) A person who violates subsection (a) of this section shall be adjudged delinquent and shall for a first
236	adjudication be fined \$50 or ordered to perform 25 hours of community service work, and for a second adjudication and for
237	all subsequent adjudications be fined \$50 and ordered to perform 50 hours of community service work. A subsequent
238	adjudication of delinquency is one that occurs within 12 months of a prior like offense.
239	§ 811 Unannounced inspections; reporting; enforcement.
240	(a) The Department of Safety and Homeland Security or its delegates shall be responsible for conducting annual,
241	random, unannounced inspections at locations where tobacco products or tobacco substitutes are sold or distributed to test
242	and ensure compliance with and enforcement of §§ 802-806 and 810 of this title.

243	(b) Persons under the age of 18 may be enlisted by the Department of Safety and Homeland Security or its
244	delegates to test compliance with and enforcement of §§ 802-806 and 810 of this title, provided however, that such persons
245	may be used only under the direct supervision of the Department of Public Safety, its employees or delegates and only
246	where written parental consent has been provided.
247	(c) Participation in the inspection and enforcement activities of this section by a person under 18 years of age shall
248	not constitute a violation of this chapter for the person under 18 years of age, and the person under 18 years of age is
249	immune from prosecution thereunder, or under any other provision of law prohibiting the purchase of these products by a
250	person under 18 years of age.
251	(d) The Department of Safety and Homeland Security shall adopt and publish guidelines for the use of persons
252	under 18 years of age in inspections conducted pursuant to this section.
253	(e) The Department of Safety and Homeland Security may enter into an agreement with any local law-enforcement
254	agency for delegation of the inspection and enforcement activities of this section within the local law-enforcement agency's
255	jurisdiction. The contract shall require the inspection and enforcement activities of the local law-enforcement agency to
256	comply with this subpart and with all applicable laws.
257	(f) In cases where inspection and enforcement activities have been delegated to a local law-enforcement agency
258	pursuant to this section, any inspection or enforcement by the Department of Safety and Homeland Security in the
259	jurisdiction of the local law-enforcement agency shall be coordinated with the local law enforcement agency.
260	(g) The Delaware Department of Health and Social Services shall annually submit to the Secretary of the United
261	States Department of Health and Human Services the report required by § 1926 of the federal Public Health Service Act (42
262	U.S.C. § 300x-26). A copy of this report shall be available to the Governor and the General Assembly.
263	§ 812 Smoking on trolleys and buses.
264	Whoever in any trackless trolley coach, or gasoline or diesel-engine-propelled bus being used as a public
265	conveyance for carrying passengers within this State, smokes or carries a lighted cigarette, cigar or pipe shall be fined not
266	less than \$5.00 nor more than \$25.
267	§ 813 Jurisdiction.
268	The Justices of the Peace Court shall have jurisdiction over violations of this chapter, except in the instance of
269	violations by a person who has not attained the age of 18, in which case the Family Court shall have jurisdiction.
270	§ 814 Preemption.
271	The provisions of this chapter shall preempt and supersede any provisions of any municipal or county ordinance or
272	regulation on the subject of this subpart enacted after June 30, 1996.
273	Section 9. Amend Chapter 22, Subtitle II, Title 6 of the Delaware Code by making deletions as shown by strike
274	through and insertions as shown by underline as follows:

275	§ 2206 Identity theft passport; application; issuance.
276	(a) The Office of the Attorney General, in cooperation with any law-enforcement agency, may issue an identity
277	theft passport to a person who is a victim of identity theft in this State and who has filed a police report citing that such
278	person is a victim of a violation of § 1129(a)(1) of Title 11. A person who has filed with a law-enforcement agency a police
279	report alleging identity theft may apply for an identity theft passport through any law-enforcement agency. The agency
280	shall send a copy of the application and the supporting police report to the Office of the Attorney General. After processing
281	the application and police report, the Office of the Attorney General may issue to the victim an identity theft passport in the
282	form of a card or certificate which may include photo identification.
283	(b) A victim of identity theft may present that victim's identity theft passport issued under subsection (a) of this
284	section to the following:
285	(1) A law-enforcement agency to help prevent the victim's arrest or detention for an offense committed by
286	someone other than the victim who is using the victim's identity;
287	(2) Any of the victim's creditors to aid in a creditor's investigation and establishment of whether fraudulent
288	charges were made against accounts in the victim's name or whether accounts were opened using the victim's identity;
289	(3) A consumer reporting agency, as defined in § 603(f) of the federal Fair Credit Reporting Act (15 U.S.C. §
290	1681a(f)), which must accept the passport as an official notice of a dispute and must include notice of the dispute in all
291	future reports that contain disputed information caused by the identity theft.
292	(c) Acceptance or rejection of an identity theft passport presented by the victim to a law-enforcement agency or
293	creditor pursuant to paragraph (b)(1) or (2) of this section is at the discretion of the law-enforcement agency or creditor. In
294	making a decision for acceptance or rejection, a law-enforcement agency or creditor may consider the surrounding
295	circumstances and available information regarding the offense of identity theft pertaining to the victim.
296	(d) An application made with the Office of the Attorney General pursuant to subsection (a) of this section,
297	including any supporting documentation, is confidential criminal justice information, is not a public record, and is
298	specifically exempted from public disclosure under the Freedom of Information Act, Chapter 100 of Title 29. However, the
299	Office of the Attorney General may provide access to applications and supporting documentation filed pursuant to this
300	section to other criminal justice agencies in this or another State.
301	(e) The Office of the Attorney General shall adopt regulations to implement this section. The regulations must

Where the trier of fact, after such hearing, is not satisfied that the defendant had a mental illness at the time of the offense, or determines that the facts do not support a "guilty, but mentally ill" plea, the trier of fact shall strike such plea, or permit such plea to be withdrawn by the defendant. A defendant whose plea is not accepted by the trier of fact shall be entitled to a jury trial, except that if a defendant subsequently waives the right to a jury trial, the judge who presided at the hearing on mental illness shall not preside at the trial.

(b) In a trial under this section a defendant found guilty but mentally ill, or whose plea to that effect is accepted, may have any sentence imposed which may lawfully be imposed upon any defendant for the same offense. Such defendant shall be committed into the custody of the Department of Correction, and shall undergo such further evaluation and be given such immediate and temporary treatment as is psychiatrically indicated. The Commissioner shall retain exclusive jurisdiction over such person in all matters relating to security. The Commissioner shall thereupon confine such person in the Delaware Psychiatric Center, or other suitable place for the residential treatment of criminally culpable persons with a mental illness under the age of 18 who have been found nonamenable to the processes of Family Court. Although such person shall remain under the jurisdiction of the Department of Correction, decisions directly related to treatment for the mental illness for individuals placed at the Delaware Psychiatric Center, shall be the joint responsibility of the Director of the Division of Substance Abuse and Mental Health and those persons at the Delaware Psychiatric Center who are directly responsible for such treatment. The Delaware Psychiatric Center, or any other residential treatment facility to which the defendant is committed by the Commissioner, shall have the authority to discharge the defendant from the facility and return the defendant to the physical custody of the Commissioner whenever the facility believes that such a discharge is in the best interests of the defendant. The offender may, by written statement, refuse to take any drugs which are prescribed

(c) When the Psychiatric Center or other treating facility designated by the Commissioner discharges an offender prior to the expiration of such person's sentence, the treating facility shall transmit to the Commissioner and to the Parole Board a report on the condition of the offender which contains the clinical facts; the diagnosis; the course of treatment, and prognosis for the remission of symptoms; the potential for the recidivism, and for danger to the offender's own person or the public; and recommendations for future treatment. Where an offender under this section is sentenced to the Psychiatric Center or other facility, the offender shall not be eligible for any privileges not permitted in writing by the Commissioner (including escorted or unescorted on-grounds or off-grounds privileges) until the offender has become eligible for parole. (d) No individual under the age of 18 shall be placed at the Delaware Psychiatric Center. Nothing herein shall prevent either the transfer to or placement at the Delaware Psychiatric Center any person who has reached the age of 18 following any finding of guilty, but mentally ill.

§ 3706 Verdict of "guilty, but mentally ill" — Parole; probation.

- (a) A person who has been adjudged "guilty, but mentally ill" and who during incarceration is discharged from treatment may be placed on prerelease or parole status under the same terms and laws applicable to any other offender. Psychological or psychiatric counseling and treatment may be required as a condition for such status. Failure to continue treatment, except by agreement of the Department of Correction, shall be a basis for terminating prerelease status or instituting parole violation hearings.
- (b) If the report of the Delaware Psychiatric Center or other facility recommends parole, the paroling authority shall within 45 days or at the expiration of the offender's minimum sentence, whichever is later, meet to consider the offender's request for parole. If the report does not recommend parole, but other laws or administrative rules of the Department permit parole, the paroling authority may meet to consider a parole request. When the paroling authority considers the offender for parole, it shall consult with the State Hospital or other facility at which the offender had been treated, or from which the offender has been discharged.
- (c) If an offender who has been found "guilty, but mentally ill" is placed on probation, the court, upon recommendation by the Attorney General, shall make treatment a condition of probation. Reports as specified by the trial judge shall be filed with the probation officer, and the sentencing court. Treatment shall be provided by an agency of the State or, with the approval of the sentencing court and at individual expense, private agencies, private physicians or other mental health personnel.

Section 196. This Act shall take effect subject to the enactment of the revised Criminal Code.

SYNOPSIS

Delaware's existing Criminal Code was adopted in 1973 and was based on the Model Penal Code. Since that time, the Criminal Code has quadrupled in size and expanded to other parts of the Code without consideration to the general effects of the change on the Criminal Code's overall structure, its terminology, or its application, creating numerous inconsistencies, redundancies, ambiguities and contradictions. This Act is one of two bills that seek to bring back clarity and consistency to the Criminal Code.
