DELAWARE STATE SENATE 149th GENERAL ASSEMBLY

SENATE BILL NO. 253

AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO FIREARM RECOVERY PROGRAMS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

7	§ 10501. Purpose.
8	The purpose of this chapter is to provide a mechanism to safely remove unwanted assault weapons from local
9	communities.
10	§ 10502. Definitions.
11	For purposes of this chapter:
12	(1) "Assault long gun" means any of the following or a copy, regardless of the producer or manufacturer:

84	1. A semiautomatic centerfire rifle that can accept a detachable magazine and has any 2 of the
85	<u>following:</u>
86	A. A folding stock.
87	B. A grenade launcher or flare launcher.
88	C. A flash suppressor.
89	2. A semiautomatic centerfire rifle that has a fixed magazine with the capacity to accept more than 10
90	rounds.
91	3. A semiautomatic centerfire rifle that has an overall length of less than 29 inches.
92	4. A semiautomatic pistol with a fixed magazine that can accept more than 10 rounds.
93	5. A semiautomatic shotgun that has a folding stock.
94	6. A shotgun with a revolving cylinder.
95	(5) "Detachable magazine" means an ammunition feeding device that can be removed readily from a firearm
96	without requiring disassembly of the firearm action or without the use of a tool, including a bullet or cartridge.
97	(6) "Flash suppressor" means a device that functions, or is intended to function, to perceptibly reduce or
98	redirect muzzle flash from the shooter's field of vision.
99	(7) "Secretary" means the Secretary of the Department of Safety and Homeland Security.
100	§ 10503. Community Assault Weapon Recovery Program.
101	(a) The Secretary shall establish and administer a Community Assault Weapon Recovery Program ("Program") to
102	allow a Delaware resident in possession of an assault weapon to relinquish the assault weapon to the Department of Safety
103	and Homeland Security or a participating local law enforcement agency in exchange for a monetary payment established
104	under this section.
105	(b) The Secretary shall adopt rules to implement the Program, including the following:
106	(1) That the Program be implemented at locations in regions throughout the State. The Secretary shall
107	coordinate with local law enforcement agencies in implementing the Program.
108	(2) That the Program permit an individual to relinquish an assault weapon to the Department of Safety and
109	Homeland Security, or a local law enforcement agency participating in the program, in exchange for \$400.
110	(3) That establishes the method for providing the monetary payment and reimbursing a participating law
111	enforcement agency for payments made to individuals under the Program.
112	(4) That the Program is subject to the availability of funds appropriated for this specific purpose. This section
113	does not create a right or entitlement in a person to receive a monetary payment under the Program.

114	§ 10504. Immunity.
115	Notwithstanding any other law to the contrary, an individual participating in the Program is immune from criminal
116	prosecution under this section if the person is, in good faith, on an immediate direct route to relinquish an assault weapon
117	under this subsection.
118	Section 4. The sum of \$100,000 is appropriated from the General Fund in Fiscal Year 2019 to the Department of
119	Safety and Homeland Security for the purpose of providing compensation under this Act.
120	Section 5. This Act takes effect on January 1, 2019.

This Act creates and funds, in Fiscal Year 2019, a Community Assault Weapon Recovery Program.
