## HOUSE OF REPRESENTATIVES 150th GENERAL ASSEMBLY

## HOUSE BILL NO. 222

AN ACT TO AMEND TITLE 14 OF THE DELAWARE CODE RELATING TO REORGANIZATION OF SCHOOL DISTRICTS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

Section 1. Amend § 1026, Title 14 of the Delaware Code by making deletions as shown by strike through and
 insertions as shown by underline as follows:

3 § 1026 Changing boundaries; vocational-technical school districts; City of Wilmington.

4 (a) The State Board of Education may, in accordance with this section, change or alter the boundaries of any

5 reorganized school district-except the reorganized district of the City of Wilmington, the boundaries of which shall at all

6 times be the same as the boundaries the City of Wilmington.

(d)(1) Notwithstanding the provisions of subsections (b) and (c) of this section, the State Board of Education may
change or alter the boundaries of school districts in New Castle County in a manner consistent with some or all of the
redistricting recommendations made by the Wilmington Education Advisory Committee in the report issued March 31,
2015 Redding Consortium for Educational Equity ("Consortium"), provided that the General Assembly passes, and the
Governor signs, a Joint Resolution supporting the proposed changes in school district boundaries. Passage of such a Joint
Resolution does not constitute support or approval of any particular measure for revenue or spending proposed in the plan
described in this subsection.

- (2) Prior to ordering a change or alteration of a school district boundary under this subsection, the State Board
   or the Consortium-or the Wilmington Education Improvement Commission, shall conduct at least 1 public hearing in
   each of the school districts to be affected, including at least two 2 in the City of Wilmington.
- 17 (3) In its decision and order to change or alter a school district boundary under this subsection, the State Board 18 of Education shall adopt a transition, resource, and implementation plan. The plan shall be developed by the 19 Wilmington Education Improvement Commission, for presentation to and approval by the State Board, and shall, at a 20 minimum, provide for The State Board of Education shall make its decision and order to change or alter district

22	resource, and implementation plan for redistricting. The recommendation and plan developed by the Consortium for
23	presentation to the State Board, must, at a minimum, provide for all of the following:
24	a. The orderly and minimally disruptive reassignment of students affected by the boundary change and
25	the reassignment of governance-responsibilities; responsibilities.
26	b. Implications for educators, administrators, and other personnel that may lead to equitable adjustments
27	to local collective bargaining-agreements; agreements.
28	e. Recommendations on resources Resources that will be required, from state, district, and local sources,
29	to support the redistricting transition and provide for the effective ongoing education of all affected students, and
30	for the support of schools with high concentrations of low income students and English language learners;
31	Learners.
32	d. Student-transportation; transportation.
33	e. Distribution of capital-assets; and assets and financial obligations or a process for such distribution.
34	f. Engagement of educators, staff, parents, district personnel, and community members throughout the
35	transition.
36	The plan shall permit students to continue their attendance at the school they attended prior to the boundary change, with
37	tuition payments by the sending district as provided in Chapter 6 of this title, until such time as the pupils complete the
38	grade levels offered in that school. If the State Board does not approve the plan as submitted by the Wilmington Education
39	Improvement Commission, it shall notify the chairperson of the Commission in writing, give reasons why the plan was not
40	approved, and allow the Commission to resubmit the plan within 60 days of the chairperson receiving the notice of denial.
41	(4) The State Board shall base its decision to change or alter school district boundaries on a record developed
42	in compliance with state open meetings laws.
43	(4)a. The Consortium's plan must be reviewed and acted upon by the State Board of Education by April 1,
44	2020 and include all of the following:
45	1. Directives for improving secondary education options for City of Wilmington students, such as the
46	provision of additional secondary schools.
47	2. Redrawing of district boundaries in Wilmington and northern New Castle County to better serve
48	the educational interests of all students, including reducing the concentration of low-income students and
49	improving educational services and supports for English Learners and other students at risk.
50	3. An assessment of the educational needs of City of Wilmington students and the resources required
51	to meet those needs.

52	4. A stipulation that the funding statewide and locally will facilitate effective implementation of the
53	proposed comprehensive plan in a manner that will improve the educational outcomes for all of the students
54	impacted by that plan.
55	5. A timetable for implementing each element of the redistricting plan and the designated
56	responsibility for carrying out responsibilities until the date of full implementation.
57	6. A process for the ongoing monitoring and evaluation of the educational impacts and outcomes of
58	implementation, which will include an annual report by the Consortium to the Governor, the General
59	Assembly, the Secretary of Education, and the State Board of Education.
60	b. The Consortium's plan may include all of the following:
61	1. Recommendations for changes in policies and practices that will improve the coordination and
62	collaboration among districts and charter schools serving students in the City of Wilmington and New Castle
63	County, including changes in the authorization of charter schools.
64	2. Recommendations for improvements to access to high-quality early education programs for all
65	students in the areas impacted by the proposed change in district boundaries.
66	3. Recommendations for improvements of the provision and coordination of before and after-school
67	services for students and families in the areas impacted by the proposed change in district boundaries.
68	4. Recommendations for policies and practices associated with student assignment and school choice.
69	(5) The authority of the Wilmington Education Improvement Commission and the State Board of Education to
70	act under the provisions of this subsection shall terminate on March 31, 2016. All school districts, including the New
71	Castle County Vocational-Technical School District, and all charters operating in the City of Wilmington and New
72	Castle County must cooperate fully with the Consortium in the development of the redistricting plan, including the
73	timely provision of student, financial, personnel, and facilities data as well as other operational data.
74	(6) The plan must permit students to continue their attendance at the school they attended prior to the
75	boundary change with tuition payments made by the sending district as provided in Chapter 6 of this title until such
76	time as the pupils complete the grade levels offered in that school. The plan should also include recommendations for
77	addressing additional transportation costs generated by enabling students to complete their studies in schools attended
78	prior to the boundary changes.
79	(e) If the State Board does not approve the plan as submitted by the Consortium, it must notify the Chairperson of
80	the Consortium in writing, give reasons why the plan was not approved, and allow the Consortium to resubmit the plan
81	within 30 days of the Chairperson receiving the notice of denial.

- 82 (f) The State Board must base its decision to change or alter school district boundaries on a record developed in
- 83 <u>compliance with State open meetings laws.</u>
- 84 (g) The authority of the Consortium and the State Board of Education to act under the provisions of this subsection
- 85 shall continue until the confirmation of a State Board of Education approved plan by the Governor and the General
- 86 Assembly.
- 87 (h) The General Assembly shall establish and fund a redistricting transition fund to provide resources needed for
- 88 the implementation of the redistricting plan, including any additional analysis, facility, and program requirements.
- 89 (e)(i) Notwithstanding subsection (b) of this section, the State Board of Education may change or alter the
- 90 boundaries of any reorganized vocational-technical school district if the school boards of the districts affected by such
- 91 change or alteration have adopted resolutions favoring such change or alteration.

## **SYNOPSIS**

This Act allows the State Board of Education to change or alter boundaries of reorganized school districts. It allows the State Board of Education to do so based upon redistricting recommendations from the newly formed Redding Consortium for Educational Equity ("Consortium"). It requires the Consortium to provide its recommendations through a transition, resource, and implementation plan for redistricting, the contents of which are specified in the Act.
