## HOUSE CONCURRENT RESOLUTION NO. 44

DESIGNATING THE THIRD WEEK OF SEPTEMBER, IN 2017 AS "AWARENESS WEEK FOR THE PREVENTION, RECOGNITION, AND TREATMENT OF PRENATAL SUBSTANCE EXPOSURE IN INFANTS AND TO SUPPORT HEALTHY FAMILIES IN DELAWARE.

WHEREAS, abuse of and dependence on prescription painkillers, opioids, alcohol, marijuana, and other drugs

2 have led to an epidemic across this state and throughout the nation; and 3 WHEREAS, substance use disorder is a chronic disease that needs a variety of supportive services and 4 engagement to prevent and overcome; and 5 WHEREAS, the rate of opioid abuse and drug dependency among pregnant women has increased in our nation; 6 and 7 WHEREAS, prenatal exposure to opioids and other drugs may cause infants to be born with an dependency 8 condition known as Neonatal Abstinence Syndrome (NAS), which is an expected and treatable condition; and 9 WHEREAS, prenatal exposure to alcohol may cause infants to be born with Fetal Alcohol Spectrum Disorder, 10 which may result in a lifetime of health problems; and 11 WHEREAS, many pregnant women have received false information, or no information at all, about how substance 12 use could impact their pregnancy; and 13 WHEREAS, it is vital to avoid stigmatization of pregnant women suffering from substance use disorders and to 14 offer compassion and understanding so that they may feel safe in seeking prenatal care and substance use treatment 15 services; and 16 WHEREAS, the Division of Family Services received approximately 295 notifications of infants with prenatal 17 substance exposure in 2015, and approximately 430 notifications in 2016; and 18 WHEREAS, prevention, education, public awareness, and knowledge of available treatment resources and 19 services are crucial to reducing the physical, social and economic impact of addiction in families and prenatal substance 20 exposure; and 21 WHEREAS, the State of Delaware is committed to promoting health and recovery by ensuring that our citizens 22 have access to quality prevention and treatment for substance use and promoting safe environments and the compassionate 23 care necessary to give every infant the best possible start in life; Page 1 of 2
