

FY24 HDF activities include:

- Approximately \$15.5 million leveraged \$34.6 million in LIHTC equity
- HAD Administrative Grant \$230,031
- SERP \$850,000
- Pre-purchase housing counseling funding \$300,000
- Home4Good \$575,000 (FHLB provides \$500k)

#### SUPPORTING AT-RISK DELAWAREANS

### STATE RENTAL ASSISTANCE PROGRAM

- Helps low-income individuals who require affordable housing and supportive services to live safely and independently in the community
- Program participants contribute 28% of their monthly income for rent, and SRAP subsidizes the remaining portion
- Applications must be referred to DSHA by DHSS or DSCYF




### SUPPORTING AT-RISK DELAWAREANS

- **2,608** households assisted (units leased) since the launch of the program in 2011
- Special Initiatives
  - DOC: New Pilot started April 2024; DOC refers clients existing State Correctional Facilities or recently released whereas all other housing options have been exhausted, and they meet the established criteria.
  - PBH: Started in early 2023, Family PBH Prevention and behavioral health focuses on mental health and substance abuse treatment and prevention (where SRAP Family focuses on reuniting families).
