## [2023 Final Report Now Available](#)

The Joint Legislative Oversight and Sunset Committee ("JLOSC" or "Committee") reviewed 6 entities (continued 3, terminated 2, and held over 1), adopted a total of 18 recommendations, introduced 9 bills, and selected entities for 2024 review.

## [2024 Full Reviews](#)

JLOSC selected the following 4 entities for full review at their March 2, 2023 meeting.

- Controlled Substance Advisory Committee (Dept. of State).
- Delaware Cemetery Board (Dept. of Health and Social Services).
- Professional Standards Board (Dept. of Education).
- Public Integrity Commission (Dept. of State).

These entities have completed the first stage of the full review process and submitted their self report. All self reports have been uploaded to the [2024 review tab](#).

## 2024 Focused Reviews

JLOSC selected the following 4 topics for focused review at their March 2 and June 8, 2023 meetings.

- Lead Poisoning Prevention Program (Dept. of Health and Social Services).
- Division of Unemployment Insurance Claimant Services (Department of Labor).
- Assisting the Office of the State Court Administrator with Relocation Options for Non-Judicial Agencies (Courts).
- Different Methods that Several State Entities Apply in Implementing the Public Comment Requirements of the Administrative Procedures Act.

Focused reviews focus on a specific issue, rule, regulation, statute, policy, or program component and do not follow the same review schedule and process as full reviews. Check out the [2024 review tab](#) for more information.
