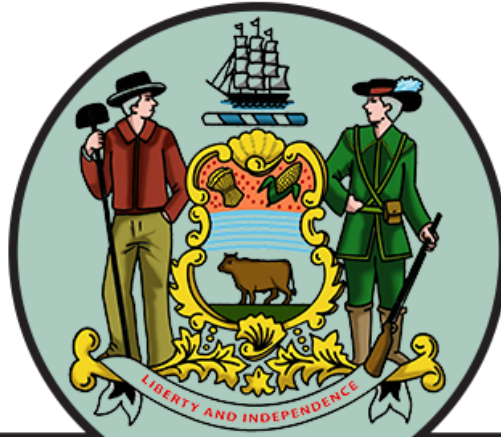
## Public Comment Information

- **Comments are limited to 2 minutes and must be on the subject at hand (which is the council, commission, or committee under review).**
  - Each Staff Report outlines the scope of review.
- If attending virtually, Zoom meeting registration is required to provide a comment during the presentation meeting.
