JLOSC SELECTS ENTITIES FOR FULL REVIEW IN 2024

The Joint Legislative Oversight and Sunset Committee ("JLOSC") has selected the following 4 entities for legislative oversight and sunset review:

- Controlled Substance Advisory Committee (Division of Professional Regulation: DOS).
- Delaware Cemetery Board (Division of Public Health: DHSS).
- Public Integrity Commission (DOS).
- Professional Standards Board (DOE).

JLOSC selected these reviews based on a list prepared by its staff which included a proactive list of boards and commissions never reviewed by JLOSC or related to entities created in the last several decades. A full legislative oversight and sunset review is a periodic, performance evaluation of an entity with the purpose of determining whether there is a public need for the entity and, if so, whether the entity is effectively performing to meet that need. Selection for this review is not indicative of any operational issues within the entity. Each state has similar processes in place for performance review or legislative oversight. The review mechanism aids in bringing strength and support to the entity under review that is found to be meeting a recognized state need. Reviews also offer an opportunity for the entity under review to ask the General Assembly for changes that require legislation. JLOSC staff is here to help during the review process.
