JOINT LEGISLATIVE OVERSIGHT AND SUNSET COMMITTEE

Meeting Minutes – May 6, 2021

1 Chair Gay called the meeting to order at 9:03 a.m. Committee members present included
2 Vice-Chair Dorsey Walker; Senators Hansen, Pinkney, and Richardson, and Representatives
3 Griffith, Spiegelman, and Yearick. Staff present included Mark Brainard, Jr. and Amanda McAtee,
4 Joint Legislative Oversight and Sunset Committee (“JLOSC”) Analysts; Holly Vaughn Wagner,
5 Legislative Attorney for the JLOSC and Deputy Director of the Division of Research; Natalie
6 White, Administrative Specialist; and Elliot Gray, Legislative Fellow. A quorum was met.

7 Chair Gay welcomed everyone to the meeting and called for Committee and staff introductions.

8 Chair Gay moved to item 2 on the agenda, the approval of the May 4, 2021 JLOSC meeting
9 minutes. Senator Hansen motioned to approve the May 4, 2021 minutes as written, and Senator
10 Pinkney seconded the motion. The motion carried with Senators Gay, Hansen, Pinkney, and
11 Richardson, and Representatives Dorsey Walker, Spiegelman, and Yearick voting in favor, none
12 opposed. Not present to vote was Senator Pettyjohn, and Representatives Griffith and Johnson.

13 Chair Gay moved to item 3 on the agenda, presentation, and discussion of JLOSC draft legislation.
14 Legislative Attorney Holly Vaughn Wagner presented draft legislation for consideration. During
15 the presentation, Senator Gay, and Representatives Dorsey Walker and Yearick asked questions.
16 Holly Vaughn Wagner and Mark Brainard provided clarification.

17 Representative Dorsey Walker motioned to release the DHIN technical corrections legislation, and
18 Senator Pinkney seconded the motion. The motion carried with Senators Gay, Hansen, Pinkney,
19 and Richardson, and Representatives Dorsey Walker, Spiegelman, and Yearick voting in favor,
20 none opposed. Not present to vote was Senator Pettyjohn, and Representatives Griffith and
21 Johnson.

22 Representative Dorsey Walker motioned to release the legislation regarding Council on
23 Corrections from committee, and Representative Yearick seconded the motion. The motion carried
24 with Senators Gay, Hansen, Pinkney, and Richardson, and Representatives Dorsey Walker,
25 Spiegelman, and Yearick voting in favor, none opposed. Not present to vote was Senator
26 Pettyjohn, and Representatives Griffith and Johnson.

27 Representative Dorsey Walker motioned to release the legislation regarding Delaware
28 Interscholastic Athletic Association from committee, and Representative Yearick seconded the
29 motion. The motion carried with Senators Gay, Hansen, Pinkney, and Richardson, and

30 Representatives Dorsey Walker, Griffith, Spiegelman, and Yearick voting in favor, none opposed.
31 Not present to vote was Senator Pettyjohn and Representative Johnson.

32 Chair Gay moved to item 4 on the agenda, an update on current JLOSC reviews. Mark Brainard
33 and Amanda McAtee delivered the presentation providing updates.

34 Chair Gay moved to item 5 on the agenda, presentation of the proposed schedule for JLOSC in
35 2022. Amanda McAtee delivered the presentation outlining the proposed schedule. After the
36 presentation, Representative Griffith asked a question. Senator Gay, Representative Dorsey
37 Walker, and Amanda McAtee provided clarification.
