SENATE BILL NO. 277

AN ACT TO AMEND TITLE 16 AND TITLE 24 OF THE DELAWARE CODE RELATING TO DENTISTRY AND DENTAL HYGIENE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend § 1121, Title 24 of the Delaware Code by making deletions as shown by strike through and  
2 insertions as shown by underline as follows:

3 § 1121. License required.

4 (c) A licensed dental hygienist may practice under the general supervision of the State Dental Director, or the State  
5 Dental Director's designee, who shall be a licensed Delaware dentist, in schools and state institutions. A licensed dental  
6 hygienist may also practice under the general supervision of the State Dental Director, or the State Dental Director's  
7 designee, who shall be a Delaware licensed dentist, in federally qualified health centers, nonprofit ~~organizations~~  
8 organizations, and other locations as designated by the Delaware Health Care Commission in consultation with ~~DIDER.~~  
9 Delaware Institute for Dental Education and Research. The protocols under which hygienists practice in these settings will  
10 be established by the State Dental Director and shall be subject to the approval of the Delaware State Board of Dentistry  
11 and Dental Hygiene.

12 (d) The State Dental Director ~~shall must be a Delaware licensed dentist. In the event that the State Dental Director~~  
13 ~~does not have a Delaware dental license when hired, the State Dental Director must obtain a Delaware license within 2~~  
14 ~~years of assuming the position. The Board may grant a temporary license for a period no longer than 2 years to the State~~  
15 ~~Dental Director, provided the State Dental Director has met all the licensure requirements except successful completion of~~  
16 ~~the practical exam. The authority to practice dentistry under such a temporary license will be limited to the performance of~~  
17 ~~the duties as the State Dental Director.~~ dentist or have a community health license under § 1132B of this title. The State  
18 Director is an employee of a government-operated dental clinic.

19 Section 2. Amend § 1122, Title 24 of the Delaware Code by making deletions as shown by strike through and  
20 insertions as shown by underline as follows:

23 (a) An applicant who is applying for licensure as a dentist under this ~~chapter section~~ shall submit evidence,  
24 verified by oath and satisfactory to the Board, that ~~such person~~ the applicant meets all of the following:

25 (1) Has received a degree in dentistry from an accredited dental college or university accredited by the  
26 Commission on Dental Accreditation of the American Dental Association.

27 (2) Before matriculating in a dental college or university, has completed at least 2 years of undergraduate  
28 study in an accredited college or university.

29 (3) ~~Has acquired 1 year's~~ Meets 1 of the following:

30 a. Has acquired 1 year's experience as a dental intern within a general practice residency accredited by  
31 the Commission on Dental Accreditation of the American Dental Association (~~CODA~~) or ("CODA").

32 b. ~~has completed~~ Has completed a ~~CODA-approved~~ CODA-approved specialty residency with those  
33 specific rotations identified in the Board's rules and ~~regulations, or if applying by reciprocity has had 3 years of~~  
34 ~~active dental practice in another state or territory of the United States.~~ regulations.

35 (4) Has achieved ~~the a~~ a passing score on ~~all examinations prescribed by the Board.~~ the Delaware jurisprudence  
36 and National Board of Dental Examiners' examinations.

37 (5) Has successfully completed the Delaware practical examination under § 1123 of this title.

38 Section 3. Amend § 1123, Title 24 of the Delaware Code by making deletions as shown by strike through and  
39 insertions as shown by underline as follows:

40 § 1123 Examinations.

41 (a)(1) An applicant applying to ~~take the Delaware practical (clinical) examination~~ shall submit evidence, verified  
42 ~~by oath satisfactory to the Board, that such persons:~~ for licensure by examination shall successfully pass, with a score  
43 established by the Board, a validated practical examination prepared and administered by the Board.

44 (2) The examination required under paragraph (a)(1) of this section must be validated as to content and  
45 scoring by a member of the faculty of an accredited school of dentistry who meets all of the following:

46 a. Is not licensed to practice dentistry in this State.

47 b. Is selected by the Division and the Board.

48 (2)(3) ~~When applying as a dental hygienist, has fulfilled the requirements set forth within § 1122 (b)(1)-(3) of~~  
49 ~~this title.~~ An applicant who has failed the practical examination 3 times may not take the examination again unless the  
50 applicant can provide evidence of mitigating circumstances to the satisfaction of the Board.

51 ~~(b) An applicant applying for licensure shall~~ An applicant applying for licensure by examination shall submit  
52 evidence, verified by oath satisfactory to the Board, that the person meets the following:

53 (1) ~~Successfully pass, with a score established by the Board a validated practical examination prepared and~~  
54 ~~administered by the Board. A practical test in dentistry or dental hygiene prepared by the Board and its method of~~  
55 ~~administration shall be validated as to content and scoring by a member of the faculty of an accredited school of~~  
56 ~~dentistry. Such faculty member shall not be licensed to practice dentistry in Delaware and shall be agreed upon by the~~  
57 ~~Division and the Board. An applicant who has failed the practical examination 3 times may not take the examination~~  
58 ~~again unless the applicant can provide evidence of mitigating circumstances to the satisfaction of the Board.~~ If applying  
59 for licensure as a dentist, that the person meets all of the following:

60 a. Has received a degree in dentistry from a dental college or university accredited by the Commission on  
61 Dental Accreditation of the American Dental Association.

62 b. Has submitted proof satisfactory to the Board that the applicant has successfully completed the  
63 National Board of Dental Examiners' examinations in dentistry with a passing score established by the Board.

82 (a) ~~Upon~~ On payment of the appropriate fee and submission and acceptance of a written application on forms  
83 provided by the Board, the Board shall grant a license to practice dentistry or dental hygiene to each ~~applicant~~, applicant  
84 who ~~shall present~~ presents proof of current licensure in “good standing” in another state, the District of Columbia, or  
85 territory of the United States, States and who meets all of the following criteria:

86 (1) Has maintained the applicant’s license in “good standing” and has satisfied all requirements of §  
87 1122(c)(2)-(7)(2) through (7) of this title.

88 (2) ~~Shall subject to subsection (b) of this section, have~~ For licensure as a dental hygienist, meet all of the

127 § 1132B. ~~Provisional license~~ Community health license to care for underserved populations – Dentists practicing  
128 in federally qualified health centers (“FQHCs”) or in ~~the Division of Public Health~~ government-operated dental clinics.

129 (a) ~~Upon~~ On completion of an application approved by the Board and payment of a fee established by the  
130 Division, the Board shall issue a ~~provisional license~~ community health license to care for underserved populations to an  
131 applicant for licensure as a dentist who has fulfilled the requirements of § 1122(a)(1), (2) and (3) of this title, ~~has completed~~  
132 ~~a general practice residency, or holds both a license in another jurisdiction and 3 years of practice experience, and who~~  
133 furnishes proof satisfactory to the Board that the applicant has contracted to be an employee with a federally qualified  
134 health center (FQHC) or with the Division of Public Health. ~~General supervision by a Delaware licensed dentist must be~~

216 c. Dental provider type and scope of practice.

217 d. Dental provider recruitment and retention strategies.

218 e. Dental insurance networks and coverage, including for the uninsured and underinsured.

219 (2) The Task Force is comprised of the following members, or a designee selected by a member serving by  
220 virtue of position:

221 a. A State Senator from the Majority Caucus, appointed by the President Pro Tempore of the Senate. This  
222 member is a Co-Chair of the Task Force.

223 b. A State Representative from the Majority Caucus, appointed by the Speaker of the House of  
224 Representatives. This member is a Co-Chair of the Task Force.

225 c. A State Senator from the Minority Caucus, appointed by the President Pro Tempore of the Senate.

226 d. A State Representative from the Minority Caucus, appointed by the Speaker of the House of  
227 Representatives.

228 e. The Secretary of the Department of Health and Social Services.



- 229 f. The Director of the Division of Medicaid and Medical Assistance.
- 230 g. The Director of the Division of Professional Regulation.

251 (3) A member serving by virtue of position who is granted the ability to designate another individual to attend  
252 a Task Force meeting must provide the designation in writing to the Chair. An individual attending a meeting for a  
253 member serving by virtue of position has the same duties and rights as the member serving by virtue of position.

254 (4) A quorum of the Task Force is a majority of the members of the Task Force.

255 (5) Official action by the Task Force, including making findings and recommendations, requires the approval  
256 of a majority of the members of the Task Force.

257 (6) The Task Force may adopt rules necessary for its operation.

258 (7) The co-chairs of the Task Force are responsible for guiding the administration of the Task Force by doing,  
259 at a minimum, all of the following:

260 a. Setting a date, time, and place for the initial organizational meeting.

261 b. Supervising the preparation and distribution of meeting notices, agendas, minutes, correspondence, and  
262 reports of the Task Force.

263 c. Sending to the President Pro Tempore of the Senate, the Speaker of the House of Representatives, and  
264 the Director of the Division of Research of Legislative Council, after the first meeting of the Task Force, a list of  
265 the members of the Task Force and the person who appointed them.

266 d. Providing meeting notices, agendas, and minutes to the Director of the Division of Research of  
267 Legislative Council.

268 e. Ensuring that the final report of the Task Force is submitted to the President Pro Tempore of the Senate  
269 and the Speaker of the House of Representatives, with copies to all members of the General Assembly; the  
270 Governor; the Director and the Librarian of the Division of Research of Legislative Council; and the Delaware  
271 Public Archives.

272 (8) The Task Force shall hold its first meeting no later than September 15, 2022.

273 (9) The General Assembly is responsible for providing reasonable and necessary support staff, including a  
274 legislative attorney, and materials for the Task Force to carry out its mission.

275 (10) The co-chairs of the Task Force shall compile a report containing a summary of the Task Force's work  
276 regarding the issues assigned to it under paragraph (1) of this Section, including any findings and recommendations  
277 related to those issues, and submit the report no later than February 1, 2023.

278 (11) This Section expires on the date the Task Force submits the report under paragraph (10) of this Section.

279 Section 9. Each federally qualified health center shall provide a report to the Secretary of the Department of Health  
280 and Social Services on the federally qualified health center's retention and recruitment outcomes 1 year after the effective  
281 date of Sections 1 through 7 of this Act.

282 Section 10. Sections 1 through 7 of this Act take effect 90 days after enactment.

283 Section 11. Sections 8 and 9 of this Act take effect on enactment.

#### SYNOPSIS

This Act increases opportunities for federally qualified health centers ("FQHC") and government-operated dental clinics to serve the indigent and other underserved communities with dental care and improves flexibility with updated provisional licensing processes for FQHC and government-operated dental clinic applicants.

This Act assists FQHCs and government-operated dental clinics in recruiting dentists to serve those most in need.

This Act adds FQHCs to the Delaware Institute for Dental Education and Research Board.

This Act creates the Dental Care Access Task Force (“Task Force”) to examine and recommend a course of action to address all of the following:

- (1) Dental care access, including for underserved populations and communities.
  - (2) Dental licensure practices and requirements.
  - (3) Dental provider type and scope of practice.
  - (4) Dental provider recruitment and retention strategies.
  - (5) Dental insurance networks and coverage, including for the uninsured and underinsured.
- The Task Force must submit its report no later than February 1, 2023.

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
