HOUSE OF REPRESENTATIVES 152nd GENERAL ASSEMBLY

HOUSE BILL NO. 87

AN ACT TO AMEND TITLE 3 OF THE DELAWARE CODE RELATING TO A DELAWARE AGRICULTURAL PRODUCTION INSURANCE ASSISTANCE PROGRAM.

1	WHEREAS, the United States Department of Agriculture's Risk Management Agency ("RMA") manages the
2	Federal Crop Insurance Corporation ("FCIC") to provide crop yield and revenue insurance products to America's farmers
3	and ranchers and Approved Insurance Providers ("AIP") sell and service federal crop yield and revenue insurance policies
4	in Delaware through a public-private partnership with RMA; and
5	WHEREAS, the insurance premium options for relevant levels of crop and revenue insurance can be a deterrent to
6	a producer obtaining adequate coverage; and
7	WHEREAS, in prior legislative sessions the General Assembly approved funding for a multi-peril crop insurance
8	assistance program, but the program was not sufficiently funded to sustain the program; and
9	WHEREAS, to ensure agricultural production in Delaware, for the long-term, it is necessary to compliment the
10	highly successful Agricultural Land Preservation Program by adopting and implementing an effective agricultural
11	production insurance assistance program.
12	NOW, THEREFORE:
13	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:
14	Section 1. Amend Title 3 of the Delaware Code by making deletions as shown by strike through and insertions as
15	shown by underline and by creating a new chapter as follows:
16	Chapter 8. Delaware Agricultural Production Insurance Assistance Program.
17	§ 801. Title.
18	This chapter shall be known as the "Delaware Agricultural Production Insurance Assistance Program".
19	§ 802. Purpose.
20	It is the declared purpose of this Program to support, encourage, and promote agriculture production in Delaware
21	as a valued and viable occupation. Promoting and supporting the State's agricultural producers is essential to maintaining
22	agriculture as a viable industry and important contributor to Delaware's economy. To ensure long-term agricultural

23	production in Delaware it is necessary to adopt and implement an effective permanent program for yield and revenue
24	insurance assistance for Delaware agricultural producers. It is further recognized that a need exists to create sufficient
25	economic incentives to encourage agricultural production given its vulnerability to weather, environmental and economic
26	conditions that can result in low crop yields, and insufficient revenue, making farming unprofitable and unsustainable. It is
27	the purpose and intent of the General Assembly to provide for the creation of a permanent yield and revenue insurance
28	assistance program to serve the long-term needs of producers in Delaware.
29	§ 803. Definitions.
30	As used in this chapter:
31	(1) "Approved Insurance Providers" means those insurance providers approved by the United States
32	Department of Agriculture's Risk Management Agency to sell multi-peril crop insurance and whole farm revenue
33	protection insurance to Delaware's eligible producers.
34	(2) "Department" means the Department of Agriculture.
35	(3) "Eligible producer" means a producer of agricultural commodities, in this State, who qualifies for
36	coverage under the Federal Crop Insurance Act, and is qualified with the Department, in accordance with this chapter.
37	(4) "Federal Crop Insurance Corporation" means the entity established in 7 U.S.C. §1508 (c) (8) of the
38	Federal Crop Insurance Act, which administers the multi-peril crop insurance and whole farm revenue protection
39	programs for agricultural producers.
40	(5) "Program" means the Delaware Agricultural Production Insurance Assistance Program.
41	§ 804. Program Administration.
42	(a) This Program is to be administered by the Department and is contingent on the ongoing existence of the
43	Federal Crop Insurance Corporation or a comparable federally funded program.
44	(b) The Department is authorized to enter into agreements with the United States Department of Agriculture's Risk
45	Management Agency, the Federal Crop Insurance Corporation, and the Approved Insurance Providers Federal Crop
46	Insurance Corporation, for purposes of implementing this Program.
47	(c) Disbursements by the Department, under this Program, shall be made directly to the Federal Crop Insurance
48	Corporation subject to established bilateral or multi-lateral agreements.
49	(d) The Department, in conjunction with the Federal Crop Insurance Corporation, must promote this Program,
50	including providing information on the Department's website, so as to educate and inform all eligible producers, in the
51	State, of the availability and details of this Program.

52	(e) The Department must keep all records, related to the Program, including all records and information received
53	from the Federal Crop Insurance Corporation
54	§ 805. Premium Subsidy and Eligibility Requirements.
55	(a) Any eligible producer who has already purchased or who shall purchase, prior to the appropriate sales closing
56	date, a multi-peril crop insurance policy, or whole farm revenue protection policy, in excess of the catastrophic risk
57	protection level of coverage, shall be eligible to receive a State subsidy of up to 30% of the eligible producers' premium
58	cost, up to a maximum of \$10.00 per acre, under this Program.
59	(b) The subsidy under this Program is only for covered commodities during the policy coverage period.
50	(c) In order to participate in this Program, the eligible producer must comply with all the requirements of this
51	Program, as established by the Department.
52	§ 806. Funding.
53	Funding appropriated through the annual Appropriations Act may be used for the implementation and
54	administration of this Program. Any annual unexpended funds appropriated for this Program will remain with the Program
55	and will not revert to the General Fund of the State of Delaware.
66	§ 807. Annual Reporting.
67	(a) By the end of each year, the Department must provide a report to the Chairs of the House and Senate
58	Agriculture Committees of the General Assembly which must include the following:
59	(1) The number of participating farmers.
70	(2) A list of all approved participating insurance providers.
71	(3) The total amount of acreage in the State, broken down by County, that is insured under the Program.
72	(4) The total amount of net book premium charged to the eligible farmers participating in the Program.
73	(5) The total paid out by the Department, over the last year, in premium subsidies and incurred Program
74	administrative expenses.
75	§ 808. Rules and Regulations.
76	The Department may adopt and promulgate such rules and regulations as will be necessary for the implementation
77	of this Program.
78	Section 2. This Act shall be effective upon appropriation by the General Assembly.

<u>SYNOPSIS</u>

This Act establishes the Delaware Agricultural Production Assistance Program. The Program will provide a subsidy of up to 30% of the premium for eligible producers' multi-peril crop insurance premium, or whole farm revenue protection premium up to a maximum of \$10.00 per acre. The subsidy would be directly paid by the Delaware Department of Agriculture to the Federal Crop Insurance Corporation on behalf of Delaware eligible producers. The Department would
