HOUSE BILL NO. 288

AN ACT TO AMEND THE DELAWARE CODE AND CHAPTER 168 OF VOLUME 84 OF THE LAWS OF
DELAWARE RELATING TO THE DIVISION OF RESEARCH.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend § 211, Title 1 of the Delaware Code by making deletions as shown by strike through and
2 insertions as shown by underline as follows:

3 § 211. Scope of editorial revision; omissions.

4 (c)(1) The Revisors shall use gender silent techniques to ensure that masculine and feminine pronouns are not used
5 and shall ensure that a solely masculine or feminine designation occurs only when it applies to 1 gender.

6 (3) If the Revisors cannot determine how to apply paragraph (c)(1) of this section to masculine and feminine
7 pronouns used in a law, the Revisors shall report this to the Director of the Division of ~~Research~~ Legislative Services for
8 possible correction through the legislative process.

9 Section 2. Amend § 1504, Title 2 of the Delaware Code by making deletions as shown by strike through and
10 insertions as shown by underline as follows:

11 § 1504. Powers; duties.

12 (a) The Council shall do all of the following:

13 (6) Submit an annual report of the Council's activities and recommendations to the Governor, General
14 Assembly, and the Director and the Librarian of the Division of ~~Research of Legislative Council~~ Legislative Services.
15 The Council shall also provide copies of the annual report to each affected state agency or municipality and make the
16 report available on the Council's website.

17 Section 3. Amend § 10004, Title 7 of the Delaware Code by making deletions as shown by strike through and
18 insertions as shown by underline as follows:

19 § 10004. Climate Action Plan.

20 (g) *Presentation of the Climate Action Plan.* —

21 Each updated Climate Action Plan shall be presented to the General Assembly by providing it to the Chief Clerk
22 of the House of Representatives, the Secretary of the Senate, the Director and the Librarian of the Division of ~~Research~~ of

23 ~~Legislative Council, Legislative Services,~~ and the chairs of the Natural Resources and Agriculture Committees of the House
24 of ~~Representatives~~ Representatives, and the chairs of the Environment, Energy and Transportation and Agriculture
25 Committees of the Senate.

26 Section 4. Amend § 10006, Title 7 of the Delaware Code by making deletions as shown by strike through and
27 insertions as shown by underline as follows:

28 § 10006. All of government implementation.

29 (d) *Climate Action Plan Implementation Report.* — (1) The Department, working with the Office of the Governor,
30 shall provide to the General Assembly by providing it to the Chief Clerk of the House of Representatives, the Secretary of
31 the Senate, the Director and the Librarian of the Division of ~~Research of Legislative Council, Legislative Services,~~ the
32 Chairs of the Natural Resources and Agriculture Committees of the House of ~~Representatives~~ Representatives, and the
33 Chairs of the Environment, Energy and Transportation and Agriculture Committees of the ~~Senate~~ Senate, a Climate Action
34 Plan Implementation Report by January 1, 2024, and thereafter shall provide this Implementation Report to the ~~Legislature~~
35 General Assembly in the same manner every 2 years. Each Implementation Report shall summarize the State's progress on
36 the strategies outlined in the most recent Climate Action Plan, and shall summarize, at minimum, the following:

37 Section 5. Amend § 1129, Title 9 of the Delaware Code by making deletions as shown by strike through and

39 § 1129. Local service functions; Local Service Function Review Committee.

40 (e) The Local Service Function Review Committee must provide an annual report containing a summary of the
41 review conducted under this section and any recommendations for improvements to all members of the County Council,
42 each municipality in New Castle County, all members of the General Assembly who represent New Castle County, and the
43 Director and the Librarian of the Division of ~~Research~~ Legislative Services by September 15 of each year.

44 Section 6. Amend § 787, Title 11 of the Delaware Code by making deletions as shown by strike through and
45 insertions as shown by underline as follows:

46 § 787. Trafficking an individual, forced labor and sexual servitude; class D felony; class C felony; class B felony;
47 class A felony.

48 (l) *Display of public awareness sign; civil penalty for failure to display.* —

49 (6) a. The Department shall submit to the General Assembly and the Council an annual written report that
50 contains all of the following information:

51 b. For purposes of submitting the report to the General Assembly, the Department shall submit the report to
52 the Secretary of the Senate, Chief Clerk of the House, the Director and the Librarian of the Division of ~~Research,~~
53 Legislative Services, and the Controller General of the Office of the Controller General.

54 Section 7. Amend § 4107, Title 11 of the Delaware Code by making deletions as shown by strike through and
55 insertions as shown by underline as follows:

56 § 4107. Annual report.

57 (e) The reports by the Administrative Office of the Courts and the Delaware Criminal Justice Information System
58 must be submitted to the President Pro Tempore of the Senate and the Speaker of the House of Representatives, with copies
59 to all members of the General Assembly, the Governor, the Chief Justice, the Attorney General, the Chief Defender, the
60 Director and the Librarian of the Division of ~~Research of Legislative Council,~~ Legislative Services, and the Delaware
61 Public Archives.

62 Section 8. Amend § 6605, Title 11 of the Delaware Code by making deletions as shown by strike through and
63 insertions as shown by underline as follows:

64 § 6605. Annual report.

65 No later than 30 days before the end of each fiscal year, the Commissioner of the Department of Correction shall
66 submit a written report to the Office of the Governor, the Chairs of the House Corrections Committee and the Senate
67 Corrections and Public Safety Committee, the Director and the Librarian of the Division of ~~Research of Legislative~~
68 ~~Council,~~ Legislative Services, and the Public Archives that certifies compliance with this chapter and includes an account
69 of every instance where restraints were used on a prisoner who is pregnant, in labor, in delivery, or in the immediate
70 postpartum period, other than the use of wrist restraints fastened in front of the body. The written report shall not contain
71 any individually identifying information of any prisoner. Such reports shall be made available for public inspection.

77 Education, the Governor, the Chairs of the Education Committees of the Senate and House of Representatives, the Director
78 and the Librarian of the Division of ~~Research of Legislative Council,~~ Legislative Services, and the Delaware Public
79 Archives. The report must also be available to the public on the Department's website.

91 Legislative Services, and the Delaware Public Archives at least once each fiscal year. It shall annually present a report to a

132 (d) Every 3 years, the Department shall prepare a written report, no later than July 31, that includes the educational
133 programming provided under this section and how the school districts and charter schools implemented the standards under
134 this section. The Department shall send this report to the President Pro Tempore of the Senate and the Speaker of the House
135 of Representatives, with copies to all members of the General Assembly, the Governor, the Director and the Librarian of
136 the Division of ~~Research of Legislative Council~~, Legislative Services, and the Delaware Public Archives.

137 Section 17. Amend § 4147, Title 14 of the Delaware Code by making deletions as shown by strike through and

152 how the curriculum has been implemented by each school district and charter school under subsection (d) of this
153 section.

154 Section 19. Amend § 4167, Title 14 of the Delaware Code by making deletions as shown by strike through and
155 insertions as shown by underline as follows:

156 § 4167. Consent education.

157 (b) *Reporting.* —

158 (3) The Department of Education shall submit a written report to the Governor, the members of the General
159 Assembly, and the Director and the Librarian of the Division of ~~Research~~ Legislative Services no later than January 15
160 of each year. The report must include the educational programing provided under subsection (a) of this section and
161 how the curriculum has been implemented by each school district and charter school under subsection (a) of this
162 section.

178 The Division of Public Health shall annually, on or before January 1, provide a report on elevated blood lead
179 levels to the General Assembly by delivering a copy of the report to the Secretary of the Senate, Chief Clerk of the House
180 of Representatives, and the Director and the Librarian of the Division of ~~Research~~ Legislative Services.

181 Section 23. Amend § 5195, Title 16 of the Delaware Code by making deletions as shown by strike through and

193 (c) The Attorney General and Governor, or their designees, shall co-chair the Commission and shall be responsible
194 for guiding the administration of the Commission by, at a minimum, doing all of the following:

195 (5) Ensuring that any reports produced by the Commission ~~is~~ are distributed to members of the Delaware
196 General Assembly, the Governor, the Director and the Librarian of the Division of ~~Research of Legislative Council~~,
197 Legislative Services, and the Delaware Public Archives.

198 Section 25. Amend § 6202, Title 16 of the Delaware Code by making deletions as shown by strike through and

210 Section 27. Amend § 10213A, Title 16 of the Delaware Code by making deletions as shown by strike through and

213 (d) The Secretary of the Department of Health and Social Services shall provide a written report not later than the
214 second Tuesday of January each year to all of the following regarding each expenditure made under the Fund in the
215 previous fiscal year and to what extent the expenditure accomplished the intended purpose of the expenditure:

216 (5) The Director and the Legislative Librarian of the Division of ~~Research~~. Legislative Services.

235 resolutions are to be produced in a manner approved by the State Archivist and Records Administrator and the Director of
236 ~~Research of the Legislative Council~~, the Division of Legislative Services, or the Director's designee, for permanency and
237 legibility.

244 (2) In preparing the engrossed copy of a bill or resolution, the Division of ~~Research~~ Legislative Services may
245 correct manifest clerical, typographical, and grammatical errors created during the amendment process.

246 (3) In preparing the engrossed copy of a bill or resolution, the Division of ~~Research~~ Legislative Services shall
247 proofread the engrossed copy before release to ensure accurate engrossment.

248 (b) The Secretary of the Senate or the Chief Clerk of the House, as appropriate, shall do all of the following:

249 (3) Report to their respective Houses and the Division of ~~Research~~ Legislative Services on each bill or
250 resolution presented under paragraph (b)(1) of this section.

251 (c) The Secretary of the Senate and the Chief Clerk of the House shall report to their respective Houses on a bill or
252 resolution that becomes law without the Governor's signature under § 18 of Article III of the Delaware Constitution. The
253 Division of ~~Research~~ Legislative Services shall publish the bill or resolution under § 906 of this title in the same manner as
254 if the Governor had signed it.

255 Section 32. Amend § 905, Title 29 of the Delaware Code by making deletions as shown by strike through and

257 § 905. Legislative journal; compiling; publication; content; disposition of originals.

258 (h) The publication of the legislative journals is to be done under contract made by the Director of ~~Research of the~~

260 Senate and Chief Clerk of the House of Representatives, as appropriate. The Secretary of the Senate and the Chief Clerk of

262 communications, petitions, and other related papers to the State Archivist and Records Administrator for proper disposition.

279 Section 35. Amend § 1106, Title 29 of the Delaware Code by making deletions as shown by strike through and
280 insertions as shown by underline as follows:

281 § 1106. Director of ~~Research~~ the Division of Legislative Services; qualifications; compensation; removal.

282 (a) The Council shall appoint, with the consent of a majority of the members elected to each House of the General
283 Assembly, a Director of ~~Research~~ the Division of Legislative Services ("Director") who shall serve full time. The Director
284 shall:

285 (b) The Director of ~~Research~~ shall receive such compensation as shall be determined by the Council, subject to the
286 limitations contained in the annual appropriation act.

287 (c) ~~The Director of Research,~~ Director, upon appointment, shall serve for so long as the Director properly performs
288 the duties of Director and shall not be removed except for cause and only then upon the affirmative vote of 8 members of

SYNOPSIS

This Act changes the name of the Division of Research to the "Division of Legislative Services" (Division) to more fully reflect the tasks that the Division performs. In addition to legislative research, the Division's tasks include drafting bills, editing the Delaware Code, staffing task forces, printing bills and other materials for the General Assembly, providing constituent and legislator services through the Legislative Information Office, and publishing the Register of Regulations and Administrative Code.

This Act also gives the Director of the Division a consistent job title throughout the Code.

Section 28 and Section 43 of this Act change "Legislative Council" to the Division to conform the law to current practice.

For reports that must be submitted to the Division, this Act makes consistent that those reports must be submitted to the Librarian of the Division, in addition to the Director.

Section 62 delays the effect of this Act until November 6, 2024, to coincide with the start of the 153rd General Assembly.

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
