## HOUSE OF REPRESENTATIVES 152nd GENERAL ASSEMBLY

## HOUSE BILL NO. 280

AN ACT TO AMEND TITLES 11 AND 16 OF THE DELAWARE CODE RELATING TO CIVIL ASSET FORFEITURE.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

other assets of the defendant as may be available, limited in value to those assets that would otherwise be forfeited
under this paragraph. Upon petition of the defendant, the court may authorize redemption of assets forfeited under
this paragraph, provided the assets described in this paragraph are surrendered or otherwise remitted by such
defendant to the jurisdiction of the court; and

84	(j) Property seized pursuant to this section that is not summarily forfeited pursuant to subsection (f) (g) or (h) of

86	must include, for each item requested to be forfeited, a statement of the unlawful act or omission to which it is alleged to be

100	§ 4785. Burden of proof; liabilities. liabilities; attorneys fees.
101	(a) It is not necessary for the State to negate any exemption or exception in this chapter in any complaint,
102	information, indictment or other pleading or in any trial, hearing or other proceeding under this chapter. The burden of
103	going forward with the evidence to establish any exemption or exception is upon the person claiming it. The State has the
104	burden to prove all material facts in a forfeiture proceeding by a preponderance of the evidence.
105	(b) In the absence of proof that a person is the duly authorized holder of an appropriate registration or order form
106	issued under this chapter, such person is presumed not to be the holder of the registration or form. The burden of proof is
107	upon the person to rebut the presumption. Where the property subject to a proceeding is claimed to be the property of a
108	person who is not a criminal defendant, that person has the burden of production to show one of the following:
109	(1) The person held a legal right, title, or interest in the property seized at the time the illegal conduct that

gave rise to the seizure of the property occurred.

111	(2) The person acquired as a bona fide purchaser for value a legal right, title, or interest in the property subject
112	to forfeiture after the commission of the crime that gave rise to the seizure of the property.
113	(c) If a person meets the burden of production to show they are an innocent owner pursuant to subsection (b) of
114	this section, the State must prove by a preponderance of the evidence that the owner had knowledge of or consented to the
115	unlawful acts or omissions that gave rise to the forfeiture.
116	(c) (d) No Other than the liability set forth in § 4784(l) of this title, no liability is imposed by this chapter upon any
117	authorized state, county or municipal officer engaged in the lawful performance of the officer's duties.
118	(e) In any civil proceeding to forfeit property in which the claimant property owner substantially prevails, the State
119	shall be liable for reasonable attorney fees and other litigation costs reasonably incurred by the claimant.
120	§ 4788. Public reporting.
121	(a) The Department of Justice shall compile and publish on its website an annual report that includes all of the
122	following information:
123	(1) The number of seizures made pursuant to this subchapter or any other provision of Delaware law and
124	whether the property seized was currency, a conveyance, real estate, or other property.
125	(2) The amount of currency seized in each instance, or where the property seized is non-monetary, an
126	estimated value of the seized property.
127	(3) The lead charge in the criminal case associated with each seizure.
128	(4) Aggregate data on the race, ethnicity, age, and gender of persons whose property was seized.
129	(5) The number of seizures where the associated criminal case ended in each of the following:
130	a. A conviction, guilty or no contest plea, or entry into a pretrial diversion program.
131	b. A dismissal, acquittal, or non-prosecution.
132	(6) The number of cases where each of the following occurred:
133	a. Property was ordered forfeited by the Court.
134	b. Property was forfeited pursuant to a plea or non-prosecution agreement.
135	c. Property was ordered by the Court to be returned to the owner.
136	d. Property was returned to the owner without a court order.
137	(7) The number of seizures by each law enforcement agency in the State.
138	(8) The number of seizures referred, transferred, or otherwise diverted to a federal agency for prosecution or
139	forfeiture proceedings and a description of the property and an accounting of any funds returned to any State or local
140	agency as a result of the federal forfeiture.

141	(9) In forfeiture proceedings that were contested, the number of petitioners who were represented by counsel
142	and the number who proceeded pro se.
143	(10) The total number of applications for forfeiture made by the State and the number of applications in which
144	any party filed a petition for return of property. For this purpose, where an application for forfeiture contains property
145	from more than 1 seizure, the property from each separate seizure should be counted as 1 application.
146	(11) Total value of proceeds collected from the sale of forfeited property and total proceeds delivered to the
147	General Fund from the sale of forfeited property.
148	(b) The Department of Justice shall deliver a copy of the annual report to the Governor, the Chief Justice, the
149	Office of Defense Services, the Chair of the Senate Corrections & Public Safety Committee, the Chair of the House Public
150	Safety and Homeland Security Committee, the Director and Librarian of the Division of Research, and the Public Archives.
151	Section 2. Amend Subchapter II, Chapter 23, Title 11 of the Delaware Code by making deletions as shown by

153	§ 2323. Transportation of controlled substances as grounds for seizure.
154	Whenever any vehicle, as defined in this subchapter, is used or intended for use to transport or in any manner to
155	facilitate the transportation of any controlled substance in violation of subchapter IV of Chapter 47 of Title 16, it shall
156	forthwith be seized and taken into custody by the peace officer or officers having knowledge of the facts of such use, but:
157	and any forfeiture proceeding shall be conducted in accordance with subchapter VI of Chapter 47 of Title 16.
158	(1) No vehicle used by any person as a common carrier in the transaction of business as a common carrier is
159	subject to forfeiture under this section unless it appears that the owner or other person in charge of the vehicle is a
160	consenting party or privy to a violation of the Controlled Substances Act;
161	(2) No vehicle is subject to forfeiture under this section by reason of any act or omission established by the
162	owner thereof to have been committed or omitted without the owner's knowledge or consent;

166	§ 2324. Condemnation proceedings; rule-making power of Superior Court.
167	The vehicle seized under this subchapter shall be proceeded against by the Attorney General on behalf of this
168	State, by libel in the Superior Court for the condemnation and forfeiture of the vehicle to this State. The Superior Court
169	may by rule provide for the practice and procedure under this subchapter, including the giving of notice of the pendency of
170	the libel of condemnation to all parties in interest, and in any event notice by registered United States mail to the last known

post-office address of the party in interest, or by publication in a newspaper of general circulation in this State as the Court by rule or order prescribes shall be sufficient. State in accordance with the procedure set forth in subchapter VI of Chapter 47 of Title 16.

This subchapter with respect to condemnation and forfeiture shall does not apply to or against the owner of a vehicle unless the State proves that the owner who has not knowingly used or permitted the vehicle to be used in, or in connection with, the commission of a felony, or who has not knowingly and voluntarily used or permitted the vehicle to be used in, or in connection with, the flight or escape of any person who has committed any such felony or in the transporting of cigarettes in violation of Chapter 53 of Title 30, or in a violation of § 1343 of this title, or in a violation of § 4172 of Title 21 in a manner meeting the criteria set forth in § 4172(g) of Title 21. Nothing in this subchapter shall may be construed as authorizing the condemnation and forfeiture of the interest of any bona fide mortgagee or lienholder with respect to the vehicle but the burden in all such cases shall be upon such unless the State proves that the mortgagee or lienholder to show that it did not know or have cause to know, knew or had cause to know, at the time its interest accrued, of a contemplated unlawful use of such the vehicle.

Section 3. This Act takes effect January 1 following its enactment into law.

## **SYNOPSIS**

This Act makes several changes to the civil asset forfeiture proceedings of this state.

It repeals the legal presumption that money, negotiable instruments or securities found in close proximity to controlled substances or records or with trace amounts of controlled substances are forfeitable. Such evidence is still admissible and may be considered by the Court in a forfeiture proceeding.

It puts the burden of proof on the State to prove all elements of a forfeiture case by a preponderance of the evidence. Under the existing statute, it is the burden of an innocent owner to prove that they did not have knowledge of or consent to the use of their property in an unlawful act.

It prohibits the forfeiture of currency less than \$500.

It prohibits forfeiture unless a criminal charge is brought.

It requires the person holding seized property to be financially responsible for all fees associated therewith in the event the property is ordered by the Court to be returned.

It allows a claimant property owner who substantially prevails in a forfeiture proceeding to recover reasonable attorney's fees and costs. The language in this section is modeled after a provision of the federal forfeiture statute, at 28 U.S.C. § 2465 that was put in place in 2000 as part of federal civil asset forfeiture reforms.

It aligns forfeiture provisions in Title 11 with the forfeiture provisions in Title 16.

It requires the Department of Justice to collect and annually report statistics regarding civil asset forfeiture.
