DELAWARE STATE SENATE 152nd GENERAL ASSEMBLY

SENATE CONCURRENT RESOLUTION NO. 147

RECOGNIZING APRIL 2024 AS "LIMB LOSS AND LIMB DIFFERENCE AWARENESS MONTH" IN THE STATE OF DELAWARE.

WHEREAS, there are more than 5.6 million individuals living with limb loss and limb difference in the United

2	States; and
3	WHEREAS, more than 2.2 million individuals live with a form of limb loss, and more than 3.4 million were born
4	with a form of limb difference; and
5	WHEREAS, each year, over 500,000 individuals in the United States experienced limb loss or are born with limb
6	difference; and
7	WHEREAS, diabetes, peripheral vascular disease, and trauma are cited as the leading causes of amputation with
8	approximately 90% of cases being contributed to them; and
9	WHEREAS, studies have shown that behaviors such as diabetes management, properly treating wounds, and
10	observing safety practices can be effective in preventing amputations; and
11	WHEREAS, access to appropriate prosthetic care for people living with limb loss or limb difference is vital to
12	enable individuals to reach their full potential, remain physically active, live independently, and live well; and
13	WHEREAS, the Amputee Coalition provides education, support and advocacy through the National Limb Loss
14	Resource Center for the benefit of persons who have limb loss and limb difference, their families, and health care providers
15	throughout the United States; and
16	WHEREAS, April is an appropriate month to designate as Limb Loss and Limb Difference Awareness as spring is
17	a time of renewal and inspiration.
18	NOW, THEREFORE:
19	BE IT RESOLVED by the Senate of the 152nd General Assembly of the State of Delaware, the House of
20	Representatives concurring therein, that the members of the General Assembly hereby recognize the month of April 2024
21	as "Limb Loss and Limb Difference Awareness Month" in the State of Delaware.
22	BE IT FURTHER RESOLVED that Delawareans are encouraged to join in recognizing the importance of this
23	month by celebrating people living with limb loss and limb difference, learning about issues affecting people with limb loss
