HOUSE CONCURRENT RESOLUTION NO. 140

RECOGNIZING SPEECH-LANGUAGE PATHOLOGISTS AND AUDIOLOGISTS AND COMMENDING THEIR SKILLS AND CONTRIBUTIONS TOWARDS IMPROVING THE QUALITY OF LIFE FOR THE CITIZENS OF DELAWARE.

1 WHEREAS, the citizens of Delaware place a high value on one of our greatest treasures, the ability to 2 communicate effectively, and celebrate the speech-language pathologists and audiologists who help us guard that treasure; 3 and 4 WHEREAS, an estimated 40 million Americans have some type of communication disorder, costing the United 5 States approximately \$154 to \$186 billion annually due to lost work productivity, special education, and medical treatment; 6 and 7 WHEREAS, the most prevalent disability category of children ages 3 through 5 and the second most prevalent 8 disability category for students ages 6 through 21 served under IDEA part B were speech-language impairments, according 9 to the 37th Annual Report to Congress on the Implementation of the Individuals with Disabilities Education Act, 2015; and 10 WHEREAS, Delaware recognizes and values the efforts of all speech-language pathologists and audiologists 11 throughout Delaware who work to help these individuals with communication disorders across their lifespan, from birth to 12 adult, to lead independent, productive, and fulfilling lives; and 13 WHEREAS, speech-language pathologists and audiologists employed by the public schools in this State help 14 students who have difficulty understanding and producing spoken language, producing speech sounds, speaking fluently, 15 and speaking with a strong and clear voice due to developmental delays or disorders, cognitive impairments, learning 16 disabilities, hearing disabilities, emotional disabilities, physical disabilities, or other acquired impairments so that they can 17 communicate with others, use language to learn to read and write, solve problems, make decisions, and effectively 18 participate in the educational process with a sense of pride and confidence; and 19 WHEREAS, through the services of dedicated speech-language pathologists and audiologists, citizens of this State 20 have improved their communication abilities, and the efforts of the speech-language pathologists and audiologists should be

22	WHEREAS, in the fall of 2016 the College of Health Sciences at the University of Delaware welcomed the first
23	class of students for the master's program in Speech-Language Pathology. Until then, there was no master's level program
24	in Delaware, forcing people to study outside the State and contributing to a shortage of services for Delawareans; and
25	WHEREAS, 76% of graduates from the class of 2021 gained employment in Delaware and 97% became employed
26	in the region; and
27	WHEREAS, graduates of the master's program in Speech-Language Pathology at the University of Delaware have
28	a 100% pass rate on the Praxis exam on the first attempt and have had a 99% employment rate over the past three years;

30	WHEREAS, Delaware is proud and honored to have certified speech-language pathologists and audiologists who
31	currently possess the highest provider qualifications for assessment and treatment of communication disorders, which
32	include the Certificate of Clinical Competence from the American Speech-Language-Hearing Association; and
33	WHEREAS, May is National Better Speech and Hearing Month, a time to recognize the effect of hearing loss and
34	speech disorders on individual wellness; and
35	WHEREAS, Delaware is extremely fortunate to have specialists of this impressive caliber serving its citizens.
36	NOW, THEREFORE:
37	BE IT RESOLVED that the House of Representatives of the 152nd General Assembly of the State of Delaware,
38	the Senate concurring therein, express their deepest gratitude to speech-language pathologists and audiologists for the
39	caring and professional service to the citizens of Delaware.
40	BE IT FURTHER RESOLVED that the members of the House of Representatives and Senate recognize and
41	commend the skills and contributions of speech-language pathologists and audiologists in improving the quality of life for
42	Delaware citizens with communication disorders.

SYNOPSIS

This concurrent resolution recognizes and commends speech-language pathologists and audiologists throughout this State for their work with citizens of this State to lead independent, productive, and fulfilling lives.
