HOUSE OF REPRESENTATIVES 152nd GENERAL ASSEMBLY

HOUSE BILL NO. 425

AN ACT TO AMEND TITLES 4 AND 16 RELATING TO MEDICAL MARIJUANA.

1	WHEREAS, the Office of the Marijuana Commissioner (OMC) currently exists within the Department of Safety
2	and Homeland Security (DSHS) and the Office of Medical Marijuana (OMM) currently exists within the Division of Public
3	Health (DPH) under the Department of Health and Social Services (DHSS); and
4	WHEREAS, the State of Delaware regulated marijuana industry should be centralized under a single authority;
5	and
6	WHEREAS, the merging of the OMM under the direction of the OMC will streamline the regulatory structure,
7	improve coordination between medical and recreational marijuana programs, promote consistent public policy and efficient
8	resource allocation, and improve oversight; and
9	WHEREAS, it is the responsibility of the General Assembly to ensure that fiscal resources are optimized to reduce
10	redundancy through combining administrative functions, such as budget management, human resources, and data analysis,
11	which will lead to cost savings and operational efficiencies; and
12	WHEREAS, the creation of a single authority to regulate the entire marijuana industry has been successful in
13	neighboring states including New York, New Jersey, and Maryland; and
14	WHEREAS, The Office of Medical Marijuana shall move its mission, personnel, positions, and resources under
15	the Office of the Marijuana Commissioner in the Department of Safety and Homeland Security. The Office of Medical
16	Marijuana shall become a unit under the supervision and control of the Office of the Marijuana Commissioner.
17	NOW, THEREFORE:
18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:
19	Section 1. Amend Chapter 49A, Title 16 of the Delaware Code by making deletions as shown by strike through
20	and insertions as shown by underline as follows:
21	Chapter 49A. THE DELAWARE MEDICAL MARIJUANA ACT
22	§ 4902A. Definitions [For application of this section, see 82 Del. Laws, c. 246, § 5].
23	For purposes of this chapter:

24	(1) "Cannabidiol-rich medical marijuana" or "CBD-rich" means a marijuana strain or product formulization
25	that has elevated levels of cannabidiol ("CBD") and contains the profile of CBD and tetrahydrocannabinol ("THC")
26	concentrations approved by the Department. Commissioner.
27	(2) "Cardholder" means a qualifying patient or a designated caregiver who has been issued and possesses a
28	valid registry identification card.
29	(3) "Commissioner" means as defined in § 1302 of Title 4.
30	(3) (4) "Compassion center agent" means a principal officer, board member, employee, or agent of a
31	registered compassion center who is 21 years of age or older and has not been convicted of an excluded felony offense
32	or drug misdemeanor within 5 years.
33	(4) (5) "Debilitating medical condition" means 1 or more of the following:
34	a. Terminal illness, cancer, positive status for human immunodeficiency virus, acquired immune
35	deficiency syndrome, decompensated cirrhosis, amyotrophic lateral sclerosis, agitation of Alzheimer's disease,
36	post-traumatic stress disorder, intractable epilepsy, seizure disorder, glaucoma, chronic debilitating migraines, new
37	daily persistent headache, or the treatment of these conditions.
38	b. A chronic or debilitating disease or medical condition or its treatment that produces 1 or more of the
39	following: cachexia or wasting syndrome; severe, debilitating pain that has not responded to previously prescribed
40	medication or surgical measures for more than 3 months or for which other treatment options produced serious
41	side effects; intractable nausea; seizures; severe and persistent muscle spasms, including those characteristic of
42	multiple sclerosis.
43	c. Any other medical condition or its treatment added by the Department, Commissioner, as provided for
44	in § 4906A of this title.
45	(5) (6) "Department" means the Delaware Department of Health and Social Services Safety and Homeland
46	Security or its successor agency.
47	(6) (7) "Designated caregiver" means a person who:
48	a. Is at least 21 years of age unless the person is the parent or legal guardian of a minor who is a
49	qualifying patient;
50	b. Has agreed to assist with a patient's medical use of marijuana;
51	c. Has not been convicted of an excluded felony offense; and
52	d. Assists no more than 5 qualifying patients with their medical use of marijuana.

53	(7) (8) "Enclosed, locked facility" means a greenhouse, building, or other enclosed area equipped with locks
54	or other security devices that is on a registered compassion center's property and permits access only to the compassion
55	center agents working for the registered compassion center.
56	(8) (9) "Excluded felony offense" means:
57	a. A violent crime defined in § 4201(c) of Title 11, that was classified as a felony in the jurisdiction
58	where the person was convicted; or
59	b. A violation of a state or federal controlled substance law that was classified as a felony in the
60	jurisdiction where the person was convicted, not including:
61	1. An offense for which the sentence, including any term of probation, incarceration, or supervised
62	release, was completed 10 or more years earlier; or
63	2. An offense that consisted of conduct for which this chapter would likely have prevented a
64	conviction, but the conduct either occurred prior to July 1, 2011, or was prosecuted by an authority other than
65	the State of Delaware.
66	(9) (10) "Health-care practitioner" means an individual who is licensed and authorized to write medical orders
67	under Title 24 as a physician, advanced practice registered nurse, or physician assistant, except as otherwise provided
68	in this paragraph. If the qualifying patient is younger than 18 years of age, the health-care practitioner must be a
69	physician who is a pediatric neurologist, pediatric gastroenterologist, pediatric oncologist, pediatric psychiatrist
70	developmental pediatrician, or pediatric palliative care specialist.
71	(10) (11) "Intractable epilepsy" means an epileptic seizure disorder for which standard medical treatment does
72	not prevent or significantly ameliorate recurring, uncontrolled seizures or for which standard medical treatment results
73	in harmful side effects.
74	(11) (12) "Labor organization" means a bona fide labor organization of any kind, including an employee
75	representation committee, group, or association, in which employees participate and which exists and is constituted for
76	the purpose, in whole or in part, of collective bargaining or otherwise dealing with compassion center or safety
77	compliance facility employers concerning grievances, labor disputes, terms or conditions of employment, including
78	wages and rates of pay, or other mutual aid or protection in connection with employment, and is characterized by 1 or
79	more of the following:
80	a. Being a party to 1 or more executed collective bargaining agreements with medical or personal use
81	marijuana employers, in this State or another state.
82	b. Having a written constitution or bylaws in the 3 immediately preceding years.

83	c. Filing the annual financial report required of labor organizations under 29 U.S.C. § 431(b) or having at
84	least 1 audited financial report in the 3 immediately preceding years.
85	d. Being affiliated with any regional or national association of unions, including state and federal labor
86	councils.
87	e. Being a member of a national labor organization that has at least 500 general members in a majority of
88	the 50 states of the United States.
89	(12) (13) "Labor peace agreement" means an agreement between a labor organization and a registered
90	compassion center or registered safety compliance facility employer that, at a minimum, includes all of the following:
91	a. Prohibits the labor organization and members from engaging in picketing, work stoppages, boycotts, or
92	any other economic interference with the business of the employer.
93	b. Prohibits the employer from disrupting efforts by the labor organization to communicate with and
94	attempt to organize and represent employees.
95	c. Provides the labor organization access at reasonable times to areas in which the employees work, for
96	the purpose of meeting with employees to discuss their right to representation, employment rights under state law,
97	and terms and conditions of employment.
98	(13) (14) "Marijuana" has the meaning given that term in § 4701 of this title.
99	(14) (15) "Medical marijuana oil" means any of the following:
100	a. "Cannabidiol oil" which is a processed Cannabis plant extract that contains at least 15% cannabidiol
101	but no more than 7% tetrahydrocannabinol, or a dilution of the resin of the Cannabis plant that contains at least 50
102	milligrams of cannabidiol per milliliter but not more than 7% tetrahydrocannabinol.
103	b. "THC-A oil" which is a processed Cannabis plant extract that contains at least 15%
104	tetrahydrocannabinol acid but not more than 7% tetrahydrocannabinol, or a dilution of the resin of the Cannabis
105	plant that contains at least 50 milligrams of tetrahydrocannabinol acid per milliliter but not more than 7%
106	tetrahydrocannabinol.
107	c. Any change in the oil formulation which is made by the Department. Commissioner.
108	(15) (16) "Medical use" means the acquisition; administration; delivery; possession; transportation; transfer;
109	transportation; or use of marijuana or paraphernalia relating to the administration of marijuana to treat or alleviate a
110	registered qualifying patient's debilitating medical condition or symptoms associated with the patient's debilitating

medical condition.

112	(16) (17) "Physician" means a properly licensed physician subject to Chapter 17 of Title 24 except as
113	otherwise provided in this paragraph. If the qualifying patient is younger than 18 years of age, the physician must be a
114	pediatric neurologist, pediatric gastroenterologist, pediatric oncologist or pediatric palliative care specialist.
115	(17) (18) "Qualifying patient" means an individual who meets the qualifications to receive a registry
116	identification card under this chapter.
117	(18) (19) "Registered compassion center" means a not-for-profit entity registered pursuant to § 4914A of this
118	title that acquires, possesses, cultivates, manufactures, delivers, transfers, transports, sells, supplies, or dispenses
119	marijuana, paraphernalia, or related supplies and educational materials to registered qualifying patients who have
120	designated the dispenser to cultivate marijuana for their medical use and the registered designated caregivers of these
121	patients.
122	(19) (20) "Registered safety compliance facility" means a nonprofit entity registered under § 4915A of this
123	title by the Department Commissioner to provide 1 or more of the following services: testing marijuana produced for
124	medical use or under Chapter 13 of Title 4 for potency and contaminants; and training cardholders, compassion center
125	agents, and owners and employees of entities operating under Chapter 13 of Title 4. The training may include, but need
126	not be limited to, information related to 1 or more of the following:
127	a. The safe and efficient cultivation, harvesting, packaging, labeling, and distribution of marijuana;
128	b. Security and inventory accountability procedures; and
129	c. Up-to-date scientific and medical research findings related to medical marijuana.
130	(20) (21) "Registry identification card" means a document issued by the Department Commissioner that
131	identifies a person as 1 of the following:
132	a. A registered qualifying adult patient.
133	b. A registered designated caregiver for a qualifying adult patient.
134	c. A registered designated caregiver for a pediatric patient.
135	d. A registered compassionate use adult patient.
136	e. A registered designated caregiver for an adult compassionate use patient.
137	f. A registered designated caregiver for a pediatric compassionate use patient.
138	g. A registered CBD-rich patient.
139	h. A registered designated caregiver for a CBD-rich patient.

140	(21) (22) "Safety compliance facility agent" means a principal officer, board member, employee, or agent of a
141	registered safety compliance facility who is 21 years of age or older and has not been convicted of an excluded felony
142	offense.
143	(22) (23) "Terminal illness" means any disease, illness or condition sustained by any human being:
144	a. For which there is no reasonable medical expectation of recovery;
145	b. Which, as a medical probability, will result in the death of such human being regardless of the use of
146	discontinuance of medical treatment implemented for the purpose of sustaining life or the life processes; and
147	c. As a result of which, the human being's health-care practitioner would not be surprised if death were to
148	occur within 12 months.
149	(23) (24) "Usable marijuana" means the dried leaves and flowers of the marijuana plant and any mixture of
150	preparation of those dried leaves and flowers, including but not limited to tinctures, ointments, other preparations
151	including medical marijuana oil, but does not include the seeds, stalks, and roots of the plant. It does not include the
152	weight of any nonmarijuana ingredients combined with marijuana, such as ingredients added to prepare a topical
153	administration, food, or drink.
154	(24) (25) "Verification system" means a phone or Web-based system that is available to law-enforcement
155	personnel and compassion center agents on a 24-hour basis for verification of registry identification cards.
156	(25) (26) "Written certification" means a document dated and signed by a health-care practitioner, stating tha
157	in the health-care practitioner's professional opinion the patient is likely to receive therapeutic or palliative benefit
158	from the medical use of marijuana to treat or alleviate the patient's debilitating medical condition or symptoms
159	associated with the debilitating medical condition. A written certification shall be made only in the course of a bona
160	fide health-care practitioner-patient relationship where the qualifying patient is under the health-care practitioner's care
161	for the patient's primary care or for the patient's debilitating medical condition after the health-care practitioner has
162	completed an assessment of the qualifying patient's medical history and current medical condition. The bona fide
163	health-care practitioner-patient relationship may not be limited to authorization for the patient to use medical marijuana
164	or consultation for that purpose. The written certification must specify the qualifying patient's debilitating medical
165	condition.
166	§ 4903A. Protections for the medical use of marijuana.
167	(b) A registered designated caregiver shall not be subject to arrest, prosecution, or denial of any right or privilege
168	including but not limited to civil penalty or disciplinary action by a court or occupational or professional licensing board or

bureau:

170	(1) For assisting a registered qualifying patient to whom he or she is connected through the Department's
171	Commissioner's registration process with the medical use of marijuana if the designated caregiver does not possess
172	more than 6 ounces of usable marijuana for each qualifying patient to whom he or she is connected through the
173	Department's Commissioner's registration process; and
174	(2) For receiving compensation for costs associated with assisting a registered qualifying patient's medical use
175	of marijuana if the registered designated caregiver is connected to the registered qualifying patient through the
176	Department's Commissioner's registration process.
177	(i) A registered compassion center shall not be subject to prosecution; search or inspection, except by the
178	Department Commissioner pursuant to § 4919A(u) of this title; seizure; or penalty in any manner, or be denied any right or
179	privilege, including but not limited to civil penalty or disciplinary action by a court or business licensing board or entity,
180	for:
181	(1) Acting pursuant to this chapter and Department Commissioner regulations to acquire, possess, cultivate,
182	manufacture, deliver, transfer, transport, supply, sell, or dispense marijuana or related supplies and educational
183	materials to registered qualifying patients who have designated the compassion center to provide for them, to registered
184	designated caregivers on behalf of the registered qualifying patients who have designated the registered compassion
185	center, or to other registered compassion centers;
186	(2) Selling or transferring marijuana seeds to entities that are licensed or registered in another jurisdiction to

- (2) Selling or transferring marijuana seeds to entities that are licensed or registered in another jurisdiction to dispense marijuana for medical purposes; or
- (3) Transferring marijuana to and from a registered safety compliance facility for the purposes of analytical testing.
- (j) A compassion center agent shall not be subject to prosecution, search, or penalty in any manner, or be denied any right or privilege, including but not limited to civil penalty or disciplinary action by a court or business licensing board or entity, for working or volunteering for a registered compassion center pursuant to this chapter and Department Commissioner regulations to perform the actions on behalf of a registered compassion center that are authorized by this chapter.
- (k) A Delaware facility which meets FDA-accepted security and operational standards shall not be subject to prosecution; search, except by the Department Commissioner under § 4919A(u) of this title; seizure; or penalty in any manner, or be denied any right or privilege, including civil penalty or disciplinary action by a court or business licensing board or entity, solely for acting in accordance with this chapter, Department Commissioner regulations, or federal law for

199	the purposes of conducting research on marijuana under § 4928A of this title and pursuant to all applicable federal law on
200	medical marijuana.
201	(1) A registered safety compliance facility and safety compliance facility agents acting on behalf of a registered
202	safety compliance facility shall not be subject to prosecution; search, except by the Department Commissioner pursuant to §
203	4919A(u) of this title; seizure; or penalty in any manner, or be denied any right or privilege, including but not limited to
204	civil penalty or disciplinary action by a court or business licensing board or entity, solely for acting in accordance with this
205	chapter and Department Commissioner regulations to provide the following services:
206	(1) Acquiring or possessing marijuana obtained from registered compassion centers;
207	(2) Returning the marijuana to the same registered compassion centers;
208	(3) Transporting marijuana that was produced by registered compassion centers to or from those registered
209	compassion centers;
210	(4) Cultivating, manufacturing, and possessing marijuana for training and analytical testing;
211	(5) The production or sale of educational materials related to medical marijuana;
212	(6) The production, sale, or transportation of equipment or materials other than marijuana to registered
213	compassion centers, including lab equipment and packaging materials, that are used by registered compassion centers;
214	(7) Testing of medical marijuana samples, including for potency and contamination;
215	(8) Providing training to prospective compassion center agents and compassion center agents, provided that
216	only compassion center agents and safety compliance facility agents may be allowed to possess or cultivate marijuana
217	and any possession or cultivation of marijuana must occur on the location registered with the Department;
218	Commissioner; and
219	(9) Receiving compensation for actions allowed under this section.
220	(m) An entity that is registered to dispense marijuana for medical use in other jurisdictions shall not be subject to
221	prosecution; search or inspection, except by the Department Commissioner pursuant to § 4919A(u) of this title; seizure; or
222	penalty in any manner or be denied any right or privilege, including but not limited to civil penalty or disciplinary action by
223	a court or business licensing board or entity, for providing marijuana seeds to registered compassion centers.
224	§ 4904A. Limitations.
225	(a) This chapter does not authorize any person to engage in, and does not prevent the imposition of any civil,
226	criminal, or other penalties for engaging in, the following conduct:
227	(1) Undertaking any task under the influence of marijuana, when doing so would constitute negligence or

professional malpractice;

229	(2) Except as provided in subsection (b) of this section, possessing marijuana, or otherwise engaging in the
230	medical use of marijuana:
231	a. In a school bus;
232	b. On the grounds of any preschool or primary or secondary school; or
233	c. In any correctional facility.
234	d. In any health care or treatment facility operated by the Department of Health and Social Services or
235	funded contractually through the Department. Department of Health and Social Services.
236	(3) Smoking marijuana:
237	a. In any form of transportation; or
238	b. In any public place.
239	(4) Operating, navigating, or being in actual physical control of any motor vehicle, aircraft, or motorboard
240	while under the influence of marijuana, except that a registered qualifying patient shall not be considered to be under
241	the influence of marijuana solely because of the presence of metabolites or components of marijuana.
242	(5) Using marijuana if that person does not have a serious or debilitating medical condition.
243	(6) Transferring marijuana to any person who is not allowed to possess marijuana under this chapter.
244	§ 4906A. Addition of debilitating medical conditions.
245	Once the regulations have been adopted pursuant to this chapter, any citizen may petition the Department
246	Commissioner to add conditions or treatments to the list of debilitating medical conditions listed in § 4902A(4) § 4902A(5)
247	of this title. The Department Commissioner shall consider petitions in the manner required by Department Commissioner
248	regulation, including public notice and hearing, as provided by § 4923A of this title. The Department Commissioner shall
249	approve or deny a petition within 180 days of its submission. The approval or denial of any petition is a final decision of the
250	Department Commissioner subject to judicial review. Jurisdiction and venue are vested in the Superior Court.
251	§ 4908A. Registration of qualifying patients and designated caregivers [For application of this section, see 82 Del
252	Laws, c. 246, § 5].
253	(a) The Department Commissioner shall issue registry identification cards to qualifying patients who submit all of
254	the following, in accordance with the Department's Commissioner's final regulations:
255	(1) A written certification issued by a health-care practitioner within 90 days immediately preceding the date
256	of an application.
257	(2) The application or renewal fee.

258	(3) The name, address, and date of birth of the qualifying patient, except that if the applicant is homeless no
259	address is required.
260	(4) The name, address, and telephone number of the qualifying patient's health-care practitioner.
261	(5) The name, address, and date of birth of the designated caregiver, if any, chosen by the qualifying patient.
262	(6) For a compassionate use card, the patient's informed consent and health-care practitioner verification
263	under subsection (c) of this section.
264	(7) A statement signed by the qualifying patient, pledging not to divert marijuana to anyone who is not
265	allowed to possess marijuana pursuant to this chapter.
266	(8) A signed statement from the designated caregiver, if any, agreeing to be designated as the patient's
267	designated caregiver and pledging not to divert marijuana to anyone who is not allowed to possess marijuana pursuant
268	to this chapter.
269	(b) Registry identification card applications shall be available no later than the day the Department Commissioner
270	publishes final regulations.
271	(c) The Department Commissioner shall issue a compassionate use card to an individual who is eligible for a
272	compassionate use card and who submits all of the following, in accordance with the Department's Commissioner's final
273	regulations, in addition to the requirements under subsection (a) of this section:
274	(1) A signed statement from the patient's health-care practitioner that includes statements attesting to all of the
275	following:
276	a. The patient has a severe and debilitating condition.
277	b. All current standard care practices and treatments have been exhausted and have been ineffective or the
278	side effects are prohibitive with continued use.
279	c. The health-care practitioner will re-evaluate and document the efficacy of medical marijuana treatment.
280	d. There are grounds supporting the potential for the patient to benefit from using medical marijuana.
281	(2) a. If the patient is an adult, a signed statement from the patient acknowledging the patient's informed
282	consent to treatment with medical marijuana and that the patient knows that there is limited or no evidence associated
283	with medical marijuana's effectiveness in treating a condition that is not a debilitating medical condition under this
284	chapter.
285	b. If the patient is under 18 years of age, a signed statement from the patient's parent or legal guardian

acknowledging the patient's informed consent to treatment with medical marijuana and that the patient's parent or

287	legal guardian knows that there is limited or no evidence associated with medical marijuana's effectiveness in
288	treating a condition that is not a debilitating medical condition under this chapter.
289	(d) (1) An adult is eligible for a CBD-rich card if the individual complies with subsection (a) of this section and
290	the written certification from the patient's health-care practitioner recommends medical marijuana for the treatment of
291	anxiety or other condition approved by the Department Commissioner for treatment with cannabidiol-rich medical
292	marijuana.
293	(2) A patient who qualifies for a CBD-rich card may only receive cannabidiol-rich medical marijuana
294	products.
295	§ 4909A. Issuance of registry identification cards [For application of this section, see 82 Del. Laws, c. 213, § 7].
296	(a) Except as provided in subsection (b) of this section, the Department Commissioner shall:
297	(1) Verify the information contained in an application or renewal submitted pursuant to this chapter, and shall
298	approve or deny an application or renewal within 45 days of receiving a completed application or renewal application.
299	(2) Issue registry identification cards to a qualifying patient and his or her designated caregiver, if any, within
300	30 days of approving the application or renewal. A designated caregiver must have a registry identification card for
301	each of his or her qualifying patients.
302	(3) Enter the registry identification number of the registered compassion center the patient designates into the
303	verification system.
304	(b) The Department Commissioner may not issue a registry identification card to a qualifying patient who is under
305	18 years of age, except if any of the following apply:
306	(1) The qualifying patient has any of the following related to a terminal illness:
307	a. Pain.
308	b. Anxiety.
309	c. Depression.
310	(2) The qualifying patient has intractable epilepsy or seizure disorder.
311	(3) The qualifying patient has a chronic or debilitating disease or medical condition where the patient has
312	failed treatment involving 1 or more of the following symptoms: cachexia or wasting syndrome; intractable nausea;
313	severe, painful and persistent muscle spasms; chronic debilitating migraines and new daily persistent headache that are
314	refractory to conventional treatment and interventions.
315	(4) Any other medical condition or its treatment added by the Department, Commissioner as provided for in §

316

4906A of this title.

317	(5) The qualifying patient is eligible for a compassionate use card under § 4908A(c) of this title.
318	(c) A qualifying patient who is under 18 years of age may only receive marijuana oil.
319	§ 4910A. Denial of registry identification cards [For application of this section, see 82 Del. Laws, c. 213, § 7].
320	(a) The Department Commissioner shall deny an application or renewal of a qualifying patient's registry
321	identification card only if the applicant:
322	(1) Did not provide the required information and materials;
323	(2) Previously had a registry identification card revoked; or
324	(3) Provided false or falsified information.
325	(b) The Department Commissioner shall deny an application or renewal for a designated caregiver chosen by a
326	qualifying patient whose registry identification card was granted only if:
327	(1) The designated caregiver does not meet the requirements of § 4902A(6) § 4902A(7) of this title;
328	(2) The applicant did not provide the information required;
329	(3) The designated caregiver previously had a registry identification card revoked; or
330	(4) The applicant or the designated caregiver provides false or falsified information.
331	(c) A prospective designated caregiver shall obtain a background check in compliance with § 4927A of this title to
332	enable the Department Commissioner to comply with subsection (b) of this section. Once a prospective designated
333	caregiver has been granted a registry identification card, the designated caregiver must obtain a background check in
334	compliance with § 4927A of this title every 3 years.
335	(d) The Department Commissioner shall notify the qualifying patient who has designated someone to serve as his
336	or her designated caregiver if a registry identification card will not be issued to the designated caregiver.
337	(e) (1) Denial of an application or renewal is considered a final Department Commissioner action.

SYNOPSIS

This Act moves the Office of Medical Marijuana, which is currently under the Department of Health and Social Services to the Office of the Marijuana Commissioner within the Department of Safety and Homeland Security. Under this Act, the Marijuana Commissioner, rather than DHSS, will be responsible for administering the Delaware Medical Marijuana Act, which includes the following tasks: (1) Registration and certification of safety compliance facilities and compassion centers; (2) Issuance of registry identification cards; (3) Registration of qualifying patients and designated caregivers; and (4) Updating rules and regulations under the Delaware Medical Marijuana Act.
