## DELAWARE STATE SENATE 149th GENERAL ASSEMBLY

## SENATE BILL NO. 207

AN ACT OPPOSING DRILLING OFF DELAWARE'S COAST AND DIRECTING CERTAIN STATE OFFICIALS AND STATE AGENCIES TO ENFORCE DELAWARE'S RIGHTS RELATING TO OFFSHORE DRILLING UNDER FEDERAL AND STATE ENVIRONMENTAL LAWS.

1	WHEREAS, Delaware has 28 miles of Atlantic coastline; and
2	WHEREAS, Delaware is home to one of the largest remaining expanses of tidal salt marsh in the mid-Atlantic
3	region; and
4	WHEREAS, Delaware serves as an important refuge and breeding ground for migrating birds and other wildlife,
5	including 86 endangered species; and
6	WHEREAS, many species rely on the health of Delaware's aquatic ecosystem; and
7	WHEREAS, the Delaware coastline provides numerous social and economic benefits to Delawareans; and
8	WHEREAS, the Delaware coastline draws millions of tourists to Delaware each year; and
9	WHEREAS, more than 60,000 jobs are tied to tourism and recreation along Delaware's coastline; and
10	WHEREAS, coastal-related activities contribute \$7 billion annually to Delaware's economy; and
11	WHEREAS, at least one-tenth of the Delaware economy, including jobs, taxes, and production, is directly
12	generated by coastal-related activities; and
13	WHEREAS, permitting leases for offshore drilling endangers the health of Delaware's aquatic ecosystem due to
14	the risk of industry-caused environmental degradation, such as an oil spill or ecosystem disruption; and
15	WHEREAS, a threat to the health of Delaware's aquatic ecosystem is a direct threat to the health of the Delaware
16	economy and the livelihood of Delawareans.
17	NOW, THEREFORE:
18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:
19	Section 1. The General Assembly and Governor oppose the sale of oil and gas leases in federal waters off of
20	Delaware's coast, as proposed by the Bureau of Ocean Energy Management's 2019 - 2024 National Outer Continental
21	Shelf Oil and Gas Leasing Draft Proposed Program ("Draft Proposed Program").

Section 3. The General Assembly and Governor direct the Attorney General and the Department to e	nforce

Section 3. The General Assembly and Governor direct the Attorney General and the Department to enforce Delaware's rights under the Coastal Zone Management Act, 16 U.S.C. § 1451 et seq., including ensuring that the sale of leases under any final action by the Secretary of the U.S. Department of the Interior approving an oil and gas leasing program are consistent with Delaware's Coastal Management Program, 7 Del. Admin. C. § 108.

Section 4. The General Assembly and Governor direct the Department and the Coastal Zone Industrial Control Board to enforce compliance with the Coastal Zone Act, Chapter 72 of Title 7 of the Delaware Code.

Section 5. The General Assembly and Governor direct the Department to do the following:

- (1) Review the Delaware Coastal Management Program and other Delaware laws to ensure these laws properly reflect Delaware's environmental policy objectives for purposes of their use in the consistency review process under the Coastal Zone Management Act.
- (2) Report to the Chair of the Senate Environmental, Natural Resources, and Energy Committee and the Chair of the House Natural Resources Committee any legislative changes that are identified as necessary under paragraph (1).

Section 6. The General Assembly directs the Secretary of the Senate to transmit copies of this Act to the President and Vice President of the United States, the Secretary of the United States Department of the Interior, the Director of the Bureau of Ocean Energy Management, the members of Delaware's Congressional delegation, the Attorney General, the Secretary of the Department, and the Chair of the Coastal Zone Industrial Control Board.

## **SYNOPSIS**

This Act does all of the following:

- (1) Expresses the General Assembly's and Governor's opposition to the 2019-2024 National Outer Continental Shelf Oil and Gas Leasing Draft Proposed Program ("Draft Proposed Program").
- (2) Directs the Attorney General and Department of Natural Resources and Environmental Control ("Department") to review the Draft Proposed Program and any final proposed program, and, if necessary, seek judicial review of the final proposed program.
- (3) Directs the Attorney General and Department to enforce Delaware's rights under the Outer Continental Shelf Lands Act, the Coastal Zone Management Act, and Delaware's Coastal Zone Act.
- (4) Directs the Department and the Coastal Zone Industrial Control Board to enforce compliance with the Coastal Zone Act.
- (5) Directs the Department to review Delaware law to ensure these laws properly reflect Delaware's environmental policy objectives for purposes of their use in the consistency review process under the Coastal Zone Management Act.
- (6) Directs the Department to report to the Chair of the Senate Environmental, Natural Resources, and Energy Committee and the Chair of the House Natural Resources Committee any legislative changes that are identified as necessary.
