HOUSE BILL NO. 25

AN ACT TO AMEND TITLE 15 OF THE DELAWARE CODE RELATING TO ELECTIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend Subchapter V of Chapter 20, Title 15 of the Delaware Code by making deletions as shown by
2 strike through and insertions as shown by underline as follows and by redesignating accordingly:

3 § 2036. Deadline to register to vote: primary and general elections.

4 The last date to register to vote for any presidential primary, primary, special and general election shall be the
5 ~~fourth Saturday prior to the date of the election~~ day of that election. A person may register to vote at his or her polling place
6 from 7 am to 8 pm by submitting with that person's application, a copy of a current and valid government issued photo
7 identification and a current government document displaying the name and address of the person registering to vote, such as
8 a utility bill, bank statement, government check, or paycheck. The term "current" as used in this section to forms of
9 identification other than those that are government issued shall mean the documents must be dated within 60 days prior to
10 the registration date.

11 (1) Mail applications ~~postmarked~~ received on or before the deadline shall be considered to be on-time and
12 shall be immediately processed by the departments of elections; and

13 (2) Applications taken by agencies in accordance with subchapter VII of this chapter and received by the
14 Department on or before the deadline shall be considered on-time and shall be processed by the Department immediately
15 upon receipt.

16 ~~§ 2037. Deadline to register to vote: special elections.~~

17 ~~The last day to register to vote for any special election shall be 10 days prior to the date of the special election.~~

18 § 2037. Registration applications received after a the deadline.

19 Registration applications received after a the deadline ~~and on or before the date of a primary or general election~~
20 shall be held and processed following that election.

21 § 2038. Registration applications that update a registrant's record.

22 Notwithstanding any other provision in this title, the Department may process registration applications that change
23 a registrant's address or name until the day ~~prior to a primary or general~~ of any presidential primary, primary, special, or
24 general election.

25 Section 2. This Bill shall take effect on January 1, 2022.

SYNOPSIS

This bill provides for election day registration for presidential primary, primary, special, and general elections whereas currently the deadline is the fourth Saturday prior to the date of the election. Moreover, same day registration at polling places will be permitted with submission of all of the following documents: an application, a copy of current valid government issued photo identification, and a current document displaying the name and address of that person.

The effective date is January 1, 2022.
