### HOUSE BILL NO. 119

### AN ACT TO AMEND TITLE 1 OF THE DELAWARE CODE RELATING TO LEGAL HOLIDAYS.

# BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1	Section 1. Amend § 501, Title 1 of the Delaware Code by making deletions as shown by strike through and
2	insertions as shown by underline as follows and by redesignating accordingly:
3	§ 501 Designation
4	(a) The following days shall be legal holidays in this State:
5	(1) January 1, known as New Year's <del>Day;</del> <u>Day.</u>
6	(2) the The third Monday in January, known as Martin Luther King, Jr. Day; Day.
7	(3) Good Friday; Friday.
8	(4) June 19, known as Juneteenth.
9	(5) July 4, known as Independence <del>Day;</del> <u>Day.</u>
10	(6) the The first Monday in September, known as Labor Day; Day.
11	(7) November 11, known as Veterans' Day; Day.
12	(8) the The fourth Thursday in November, known as Thanksgiving Day; Day.
13	(9) the The Friday following Thanksgiving Day; Day.
14	(10) December 25, known as Christmas; Christmas.
15	(11) Saturdays; Saturdays.
16	(12) the The day of the General Election as it biennially occurs; and
17	(13) in In Sussex County, Return Day, the second day after the General Election, after 12:00 Noon.
18	$(\underline{b})$ If any of the legal holidays fall on Sunday, the Monday following shall be a legal holiday. If any of the legal
19	holidays other than Saturday fall on Saturday, the Friday preceding shall be a legal holiday.
20	(c) The last Monday in May shall be the legal holiday, known as Memorial Day, in the State.

- 21 (d) Veteran's Day shall be a legal holiday for all public school students and the employees of public school 22 districts and charter schools. If Veteran's Day falls on a Sunday, the following Monday shall be a legal holiday. If 23 Veteran's Day falls on a Saturday, the preceding Friday shall be a legal holiday.
  - (e) The Director of the Office of Management and Budget shall promulgate policies and procedures to implement 2 floating holidays 1 floating holiday.

#### **SYNOPSIS**

This Act establishes Juneteenth as a State holiday. Juneteenth commemorates the emancipation of the last enslaved African Americans in the United States. The Act adds Juneteenth as a legal holiday and reduces the number of floating holidays from 2 to 1. The two floating holidays were created by the 145th General Assembly as replacements for Presidents Day and Columbus Day. This Act replaces the floating holiday that replaced Columbus Day with a legal holiday to celebrate Juneteenth. This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
