HOUSE BILL NO. 382

AN ACT TO AMEND TITLE 14, TITLE 29, AND TITLE 31 RELATING TO PEOPLE WHO ARE VISUALLY IMPAIRED.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend § 206, Title 14 of the Delaware Code by making deletions as shown by strike through and  
2 insertions as shown by underline as follows:

3 § 206. Braille literacy rights and education.

4 (a) In developing the individualized written education program for each student ~~who is blind~~ with blindness or  
5 visual impairment, it is the presumption ~~shall be~~ that proficiency in Braille reading and writing is essential for each student  
6 to achieve satisfactory educational progress. The assessment required for each student ~~shall include~~ includes a Braille skills  
7 inventory, including a statement of strengths and weaknesses.

8 (1) ~~This section does not require~~ Braille instruction and its use ~~are not mandated by this section~~ if, in the  
9 course of developing the student's individualized educational program, ~~all members~~ each member of the team ~~concur~~  
10 concurs that the student's visual impairment does not affect reading and writing performance commensurate with  
11 ability.

12 (2) ~~Nothing in this section requires~~ This section does not require exclusive use of Braille if other special  
13 education services are appropriate to the student's needs. The provision of other appropriate services ~~shall~~ does not  
14 preclude Braille use or instruction.

15 (b) Instruction in Braille reading and writing ~~shall be~~ are sufficient to enable each student ~~who is blind~~ with  
16 blindness or visual impairment to communicate effectively and efficiently with the same proficiency expected of the  
17 student's peers of comparable ability and grade level. The student's individualized educational plan ~~shall~~ must specify at  
18 least all of the following:

19 (1) The results obtained from the inventory required in subsection (a) of this ~~section;~~ section.

20 (2) How Braille will be implemented as the primary mode for learning through integration with other  
21 classroom ~~activities;~~ activities.

22 (3) The date on which Braille instruction will commence; commence.

23 (4) The length of the period of instruction and the frequency and duration of each instructional ~~session;~~  
24 session.

25 (5) The level of competency in Braille reading and writing to be achieved by the end of the period, and the  
26 objective assessment measures to be ~~used; and~~ used.

27 (6) The evidence used to determine that the student's ability to read and write effectively without special  
28 education services will not be impaired if a decision has been made under subsection (a) of this section that Braille  
29 instruction or use is not required for the student.

30 (c) Each publisher of ~~textbooks purchased by Delaware School Districts~~ a textbook that a local education agency  
31 purchases must, in addition to granting copyright permission for transcription into Braille, large ~~print~~ print, or tape for  
32 ~~visually impaired students~~ students with visual impairments as already established by law, ~~must~~ furnish to the Division for  
33 the Visually ~~Impaired;~~ Impaired a print ~~copy, and when requested, with computer diskettes or electronic copy~~ in the  
34 American Standard Code for Information Interchange (ASCII) from which Braille versions of the texts can be produced.  
35 The print copy is also required since the accompanying graphics must be reproduced by ~~hand;~~ hand and some subject  
36 matter, such as ~~mathematics~~ mathematics, must still be hand transcribed.

37 (d) ~~As part of the certification process, all newly certified teachers of the visually impaired, after enactment of this~~  
38 ~~section shall be required to demonstrate competence in reading and writing Braille. The Department of Education which~~  
39 ~~certifies teachers shall require proof of a passing score on the Library of Congress Braille Competency Test (when it is~~  
40 ~~completed and validated), or any comparable, nationally recognized validated test. Until that time, the Department of~~  
41 ~~Education will continue to certify teachers of the visually impaired through its existing standards. All newly hired teacher~~  
42 ~~aides will be required to achieve certification as Braille transcribers through the Library of Congress within 2 years of~~  
43 ~~employment. [Repealed.]~~

44 (e) In order to meet the instructional needs of ~~students who are blind~~ each student with blindness or visual  
45 impairment, the Division for the Visually Impaired shall hire an itinerant teacher of the visually impaired for every 28  
46 ~~students (or students, or a major fraction thereof) thereof,~~ who are registered and receiving instruction from ~~the Agency a~~  
47 local education agency. At least 2 of these teacher units ~~shall~~ must be 12-month employees in order to insure competent  
48 Braille instruction during the summer months.

49 Section 2. Amend § 7913, Title 29 of the Delaware Code by making deletions as shown by strike through and  
50 insertions as shown by underline as follows:

51 § 7913. Council on the Blind.

52 (a) ~~There is established the~~ The Council on the Blind is established.

53 (b) The Council on the Blind ~~shall serve~~ (“Council”) serves in an advisory capacity to the ~~Administrator~~ Director  
54 of the Division for the Visually Impaired and ~~shall consider~~ considers matters relating to the ~~general supervision and~~  
55 ~~control of the education, training and welfare of persons who are blind residing in the State. The Council shall also consider~~  
56 ~~such~~ supervision of the training of a person with blindness or a person with visual impairment, as defined in § 2101 of Title  
57 31, and other matters as may be referred to it by ~~that~~ the Governor, the Secretary of the ~~Department~~ Department, or the  
58 ~~Administrator of the Division for the Visually Impaired~~ Director may refer to it. The Council may study, research, ~~plan and~~  
59 ~~plan, or~~ advise the ~~Administrator~~ Director, ~~Secretary and~~ Secretary, or Governor on matters it deems appropriate to enable  
60 the Division to function in the best possible manner.

61 (c) ~~The Council on the Blind shall be composed of 7 members who shall be appointed for 3 year terms by is~~  
62 comprised of 7 members who are appointed by the Governor.

63 (d) ~~At least 3, but no more than 4, members of the Council shall be affiliated with 1 of the major political parties~~  
64 ~~and at least 2, but no more than 3, of the newly appointed members shall be affiliated with the other major political party;~~  
65 ~~provided, however, there shall be no more than a bare majority representation of 1 major political party over the other~~  
66 ~~major political party. Any person who declines to announce such person’s political affiliation shall also be eligible for~~  
67 ~~appointment as a member of the Council. [Repealed.]~~

68 (e) ~~Members of the Council shall serve without compensation, except that they may be reimbursed for reasonable~~  
69 ~~and necessary expenses incident to their duties as members of the Council. A Council member does not receive~~  
70 compensation but may be reimbursed for the member’s actual and necessary expenses incurred in the performance of the  
71 member’s official duties.

72 (f) ~~A Chairperson of the Council shall be chosen by the members of the Council from among its members and~~  
73 ~~shall serve in that capacity for a term of 1 year and shall be eligible for reelection. The Council shall annually elect a chair~~  
74 from among its members. A chair is eligible for reelection.

75 (g) ~~Any replacement appointment to the Council to fill a vacancy prior to the expiration of a term shall be filled for~~  
76 ~~the remainder of the term. Each Council member is appointed for a term of 3 years. Each term of office expires on the date~~  
77 specified in the appointment; however, a member remains eligible to participate in Council proceedings until the Governor  
78 replaces that member. The Governor may appoint a member for a term of less than 3 years to ensure that members’ terms  
79 expire on a staggered basis.

80 (h) The number of members who must be present at a Council meeting in order to have quorum and conduct  
81 official business is a majority of appointed members. Counting for quorum does not include member positions that are  
82 vacant.

83 (i) The Governor may remove a member for gross inefficiency, misfeasance, malfeasance, or neglect of duty in  
84 office. A member is deemed in neglect of duty if the member is absent from 3 consecutive, regular Council meetings or  
85 attends less than 50% of Council meetings in a calendar year. The Governor may consider the member to have resigned and  
86 may accept the member's resignation.

87 Section 3. Amend § 7929, Title 29 of the Delaware Code by making deletions as shown by strike through and  
88 insertions as shown by underline as follows:

89 § 7929. Division for the Visually Impaired.

90 (a) ~~The Division for the Visually Impaired is established having the power to perform and be responsible for the~~  
91 ~~performance of all powers, duties and functions heretofore vested in the Delaware Commission for the Blind, pursuant to~~  
92 ~~Chapters 21 and 23 of Title 31 as formerly vested in the Division of Social Services. (“Division”)~~ has the power, duties, and  
93 functions necessary to provide persons with blindness and persons with visual impairment, including the powers, duties,  
94 and functions under this section, Chapter 21 of Title 31, and Chapter 23 of Title 31.

95 (b) ~~The Division for the Visually Impaired shall have the power to~~ may establish, ~~monitor~~ monitor, and oversee  
96 the operation of business programs for the purpose of providing training and employment for Delaware residents who are  
97 visually impaired under the Randolph-Sheppard Act [20 U.S.C. 107 et seq.]. ~~These business programs may include, but~~  
98 ~~shall not be limited to, vending, engraving, retail food services, meal preparation and distribution, concession stands and~~  
99 ~~any other such business programs as may be deemed appropriate by the Director of the Division for the Visually Impaired.~~  
100 ~~Such programs shall be known as either Delaware Industries for the Blind or Business Enterprise Program. The business~~  
101 ~~programs are known collectively as the “Business Enterprise Program” and may include vending, retail food services, meal~~  
102 ~~preparation and distribution, concession stands, or other business programs that the Director of the Division may deem~~  
103 appropriate.

104 (1) ~~The Division for the Visually Impaired shall be authorized to~~ may promulgate rules and regulations to  
105 implement and operate the ~~programs~~ Business Enterprise Program. ~~These~~ The rules and regulations ~~shall include, but~~  
106 ~~not be limited to, must include~~ provisions relating to participant eligibility, personnel management, fiscal controls,  
107 marketing ~~plans~~ plans, and enforcement of production quality standards.

108 (2) ~~Participants in the business programs shall be employees of a particular program~~ A participant in the  
109 Business Enterprise Program is not an employee of the Business Enterprise Program and may continue in that program  
110 ~~only pursuant to the program only under~~ the rules of the program. ~~All participants~~ Each participant shall adhere to the  
111 rules and regulations ~~promulgated by that~~ the Division for the Visually Impaired promulgates.

112 (c) The Director of the Division ~~Director shall be~~ is an exempt employee, and must be knowledgeable and skilled  
113 in the field of services to the visually impaired and responsive to the needs and concerns of that population.

114 (d) ~~The~~ This State accepts the provisions and benefits of the Vocational Rehabilitation Act of 1973 (P.L. 93-112)  
115 [29 U.S.C. § 701 et seq.], as amended. The Department of Health and Social Services ~~shall act as the sole state agency~~ is a  
116 designated State agency, with the Secretary of the Department as the State ~~Officer,~~ Officer and the Division of the Visually  
117 Impaired as ~~the Designated State Unit~~ a designated State unit for all moneys from the act Act that are designated for  
118 persons with visual impairment ~~and~~ or persons with blindness. This is defined in a cooperative agreement dated December  
119 1985 ~~between~~ among the Department of Labor, Division for the Visually Impaired ~~Impaired~~, and the Division of  
120 Vocational Rehabilitation. The Department of Health and Social Services shall cooperate with the U.S. United States  
121 Department of Education, Rehabilitation Services Administration, and, in accordance with all state laws, prepare the state  
122 plan and carry out the Rehabilitation Act of 1973 and ~~amendments thereto~~ its amendments.

123 Section 4. Amend § 8210, Title 29 of the Delaware Code by making deletions as shown by strike through and  
124 insertions as shown by underline as follows:

125 § 8210. State Council for Persons with Disabilities.

126 (J) For purposes of this section, the operations and activities of the Division for the Visually Impaired and the  
127 ~~Governor's Advisory~~ Council on the Blind ~~shall be~~ are exempt from the purview of the State Council for Persons with  
128 Disabilities.

129 Section 5. Amend Chapter 21, Title 31 of the Delaware Code by making deletions as shown by strike through and  
130 insertions as shown by underline as follows:

131 CHAPTER 21. ~~Delaware Commission for the Blind~~ Division for the Visually Impaired.

132 Section 6. Amend § 2101, Title 31 of the Delaware Code by making deletions as shown by strike through and  
133 insertions as shown by underline as follows and by redesignating accordingly:

134 § 2101. Definitions.

135 As used in this chapter:

136 (1) ~~“Commission” or “Delaware Commission for the Blind” or “Department”~~ means the Department of Health  
137 and Social Services.

138 ( ) “Division” means the Division for the Visually Impaired under § 7929 of Title 29, a division of the  
139 Department of Health and Social Services.

140 (2) ~~“Person who is blind” means one who is totally blind or has~~ “Person with blindness” means an individual  
141 with total blindness or visual acuity of not more than 20/200 in the better better-seeing eye with best conventional  
142 correction or whose vision is limited in field so that the widest diameter subtends an angle no greater than 20 degrees.

143 ( ) “Person with visual impairment” means an individual who has a visual acuity of not more than 20/70 to  
144 20/200 in the better-seeing eye with the best conventional correction.

145 Section 7. Amend § 2102, Title 31 of the Delaware Code by making deletions as shown by strike through and  
146 insertions as shown by underline as follows:

147 § 2102. ~~Persons who are blind; supervision, training and welfare.~~ Supervision of training.

148 The ~~Department shall have~~ Division, through the Department, has ~~supervision and control of the education,~~  
149 ~~training and welfare of persons who are blind residing in the State~~ supervision of the training of a person with blindness or  
150 a person with visual impairment.

151 Section 8. Amend § 2103, Title 31 of the Delaware Code by making deletions as shown by strike through and  
152 insertions as shown by underline as follows:

153 § 2103. ~~Duties; appointment of instructor of persons who are blind; expenditures.~~ Division authority; instructors of  
154 persons with blindness or visual impairment.

155 ~~The Commission shall have general supervision and control of the education, training and welfare of persons who~~  
156 ~~are blind residing in the State, and for that purpose shall from time to time select and appoint suitable persons to be~~  
157 ~~instructors of persons who are blind. The instructors shall at all times be under the sole control of the Commission and shall~~  
158 ~~be employed upon such terms and shall do and perform such duties for such periods and in such manner as is determined by~~  
159 ~~the Commission.~~ The Division has sole authority over the selection, appointment, employment terms, and performance of  
160 an instructor of persons with blindness or persons with visual impairment.

161 Section 9. Amend § 2104, Title 31 of the Delaware Code by making deletions as shown by strike through and

225 ~~and 18 years residing in this State shall cause the child who is blind to receive instruction and training adapted for persons~~  
226 ~~who are blind for at least 6 months in each year until the child has attained the age of 18 years.~~

227 (b) Any child who is blind may be excused by the Commission from receiving instruction and training upon the  
228 presentation to the Commission of satisfactory evidence that the child is not in proper physical or mental condition to  
229 receive instruction and training.

230 (c) A parent, guardian or other person having custody or control of any child who is blind shall make application  
231 to the Commission for instruction and training for the child upon receipt of a notice from the Commission to that effect.  
232 The Commission shall grant or refuse such application at its discretion.

233 (d) The amount paid by the Commission to any school or institution outside Delaware for the education of each  
234 Delaware child who is blind enrolled therein shall not be greater than the amount paid by the state in which the institution is  
235 located for each of its children who are blind enrolled therein.

236 Section 15. Amend § 2110, Title 31 of the Delaware Code by making deletions as shown by strike through and  
237 insertions as shown by underline as follows:

238 § 2110. Visitation of institutions outside of State. [Repealed.]

239 ~~The Commission shall appoint a representative to visit the institutions outside this State wherein children who are~~

251 receiving an appropriate voucher, the State Treasurer shall make a payment authorized under this section.

258 (b) ~~Justices of the peace shall have jurisdiction of offenses under this section.~~

259 (c) ~~Any person convicted under this section shall have the right of an appeal to the Court of Common Pleas of the~~  
260 ~~county in which the conviction was had, upon giving bond in the sum of \$100 to the State with surety satisfactory to the~~  
261 ~~justice of the peace by whom the person was convicted. Such an appeal shall be taken and bond given within 3 days from~~

277 ~~the Commission; provided, that such persons are qualified and the service rendered is of standard quality and price.~~

278 (c) ~~When convenience or emergency requires it the executive secretary of the Commission may upon request of~~  
279 ~~the purchasing officer of any institution or agency relieve the purchasing officer from the obligation of this section.~~

280 (d) ~~Any purchasing officer who violates this section shall be guilty of a misdemeanor and punished accordingly.~~

#### SYNOPSIS

This Act is a result of the Joint Legislature Oversight and Sunset Committee's ("JLOSC") review of the Division for the Visually Impaired ("DVI") and represents the collaboration of several state agencies and other stakeholders.

The General Assembly originally codified DVI in 1909 as the Delaware Commission for the Blind, Delaware's first state agency. DVI was established in § 7929, Title 29 in 1978 and housed under the Department of Health and Social Services. The JLOSC review and subsequent task force on DVI revealed changes needed under Title 14, 29, and 31.

This Act modernizes the portions of Titles 14, 29, and 31 relating to persons with blindness, including:

- Updating sections language pertaining to the federal Vocational Rehabilitation ("VR") program, which includes the Business Enterprise Program. DVI is an approved VR agency under the federal program. The Rehabilitation Services Administration (RSA) is the federal agency who oversees DVI's VR program. The RSA completes audits on DVI's VR program and provides ongoing guidance and support. This Act makes amendments to areas identified in the JLOSC review process and by RSA during their recent audit.

- Updating language in Title 14 relating to teacher certification. Teachers that DVI employs are certified teachers of the visually impaired and must meet all Department of Education ("DOE") requirements. This area of law is extensively regulated under the DOE's regulations relating to educational services to all children with disabilities, including blindness. See Regulation 925 of Title 14 of the Delaware Administrative Code. DVI worked in collaboration with the Department of Education on updates to Title 14 and removed outdated information on teacher certification.

- Repealing Chapter 23, Title 31. Chapter 23 is outdated language that codified the duties of the previous entity, the Commission for the Blind. DVI does not provide the services under Chapter 23.

- Correcting the title of the Council on the Blind in § 8210, Title 29.

- Removing remaining references to the Commission on the Blind.

- Replacing antiquated language with the appropriate phrase, "person with blindness" or "person with visual impairment."

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
