HOUSE CONCURRENT RESOLUTION NO. 77

RECOGNIZING THE MONTH OF MAY 2022 AS MENTAL HEALTH AWARENESS MONTH.

| 1 | WHEREAS, I in 5 adults in the United States experience mental liliness each year, but less than half of them |

| 3 | WHEREAS, over 100 Americans, teens through older adults, die by suicide each day, and suicide is the second |
| 4 | leading cause of death among Americans aged 10-34; and |
| 5 | WHEREAS, mental illness and substance use disorders are involved in 1 out of every 8 emergency department |
| 6 | visits by an adult in the United States; and |
| 7 | WHEREAS, nationally, 37% of incarcerated adults and 70.4% of youth in the juvenile justice system have a |
| 8 | diagnosed mental illness; and |
| 9 | WHEREAS, 11% of youth have a mood disorder, 10% of youth have a behavior or conduct disorder, and 8% of |
| 10 | youth have an anxiety disorder; and |
| 11 | WHEREAS, mental health is important at every stage of life, from childhood and adolescence through adulthood; |
| 12 | and |
| 13 | WHEREAS, in recognition of the importance of mental health and the advantages to individuals and our |
| 14 | communities of providing resources to identify and treat mental health conditions as early as possible, the General |
| 15 | Assembly passed HB 100 which will create a mental health services unit to fund a position for counselors, psychologists, |
| 16 | social workers and mental health therapists in schools with kindergarten through 5th grade; and |
| 17 | WHEREAS, to continue the work of HB 100, the General Assembly has introduced and is considering HB 300 |
| 18 | which would create a mental health services unit in 6th through 8th grade; and |
| 19 | WHEREAS, the COVID-19 pandemic and associated economic, social, and educational disruptions have served to |
| 20 | exacerbate mental health conditions in both adults and children, making the availability of mental health resources more |
