SENATE BILL NO. 288

AN ACT TO AMEND TITLE 21 OF THE DELAWARE CODE RELATING TO MOTORCYCLE SAFETY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1           Section 1. Amend §4348, Title 21 of the Delaware Code by making deletions as shown by strike through and  
2       insertions as shown by underline as follows:

3           § 4348. Additional lighting equipment.

4                   (d)(3) Flashing headlights may be installed upon any motor vehicle being used by a fire chief, assistant fire  
5       chief, fire engineer, fire police officer, police officer, a firefighter who is a member of any regularly established  
6       fire company or by an ambulance attendant who is a member of any regularly established ambulance service.  
7       Flashing lights shall only be installed if duly authorized by the fire chief or ambulance captain of the respective  
8       fire or ambulance company. The lights shall be used only in response to duty as a first responder. Only those  
9       firefighters or ambulance attendants of regularly established fire companies duly designated as first responders by  
10      their respective fire chief, or those ambulance attendants of other regularly established ambulance services duly  
11      designated as first responders by their respective ambulance captain, shall be authorized to use such flashing  
12      lights, notwithstanding § 4353(c) of this title. Nothing in this section shall be interpreted to grant emergency  
13      vehicle status to firefighters or ambulance attendants making use of such signals in their personal vehicles  
14      pursuant to § 4106 of this title. Flashing lights as used in this subsection shall mean a sudden and transient  
15      outburst of bright light either operated or activated by 4-way flashers and/or by a high and low beam headlight  
16      switch on the vehicle.

17                   a. Flashing headlights may be installed on motorcycles for the purpose of warning other vehicles of their  
18      presence requiring the exercise of unusual care in approaching, overtaking, or passing, notwithstanding § 4353 (c)  
19      of this title. Nothing in this section shall be interpreted to grant emergency status to motorcycle operators making  
20      use of such flashing headlights.

21           Section 2. This Act expires on January 1, 2025, unless otherwise provided by a subsequent act of the General  
22       Assembly.

### SYNOPSIS

This bill would create a pilot program whereby motorcyclists are permitted to use flashing headlights as a way to alert other drivers of their presence, without allowing the use of flashing lights that would otherwise be used on emergency vehicles. The bill aims to protect motorcyclists on Delaware's roads and has a sunset provision that will allow time for further traffic studies to determine the effectiveness of this pilot program.
