HOUSE BILL NO. 425

AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO THE LYME DISEASE OVERSIGHT BOARD.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend Chapter 1, Title 16 of the Delaware Code by making deletions as shown by strike through and  
2 insertions as shown by underline as follows:

3 § 140. Lyme Disease Education Oversight Board [Expires Aug. 29, 2024, pursuant to 80 Del. Laws, c. 402, § 2].

4 (a) The Lyme Disease Education Oversight Board (“the Board”) is established to implement health-care  
5 professional education on Lyme disease to improve understanding of the disease. For administrative and budgetary  
6 purposes only, the Board shall be placed within the Department of Health and Social Services. The Delaware Division of  
7 Public Health shall provide staff support for the Board.

8 (b) The Board shall consist of ~~9~~ 11 members who possess the qualifications and are appointed as follows:

9 (1) The Governor shall ~~appoint~~ appoint the following members:

10 a. Two ~~members who are~~ advocates for the prevention and treatment of Lyme disease, such as a Lyme  
11 disease patient or patient advocate.

12 ~~b. One member who is licensed to practice medicine in Delaware.~~

13 ~~c. One member who is licensed to practice nursing in Delaware.~~

14 ~~d. One member who is a licensed health-care professional other than physicians or nurses.~~

15 b. Two Delaware licensed physicians, including one board-certified infectious disease specialist, from a  
16 list of names provided by the Medical Society of Delaware.

17 c. One Delaware licensed nurse, from a list of names provided by the Delaware Nursing Association.

18 d. One infectious disease epidemiologist, from a list of names provided by the Medical Society of  
19 Delaware.

20 e. ~~One member~~ individual who has knowledge and experience in the ~~licensure and regulation~~ education  
21 ~~of health care.~~ health-care practitioners.

22 f. One Delaware licensed veterinarian or entomology specialist.

23 (2) The Pro Tempore of the Delaware State Senate shall appoint 1 member ~~of the Lyme Disease Prevention~~  
24 ~~Task Force established by Senate Joint Resolution No. 10 of the 147th General Assembly. Upon the resignation or~~  
25 ~~replacement of that member, the Pro Tempore shall appoint a member to represent the public at large.~~

26 (3) The Speaker of the Delaware House of Representatives shall appoint 1 member ~~of the Lyme Disease~~  
27 ~~Prevention Task Force established by Senate Joint Resolution No. 10 of the 147th General Assembly. Upon the~~  
28 ~~resignation or replacement of that member, the Speaker shall appoint a member to represent the public at large.~~

29 (4) The Director of the Division of Public Health, or the Director's designee.

30 (c) The Board shall:

31 (1) Determine the content of Lyme disease medical education materials, ensuring quality and balanced  
32 medical education by including the philosophies of the Centers For Disease Control, the guidelines established by the  
33 International Lyme and Associated Diseases Society, as well as the latest scientific evidence and research.

34 (2) Educate health-care professionals in the State that Lyme disease can be diagnosed clinically based on  
35 history and physical examination, and serologic antibody testing can confirm, but is not required to make, a clinical  
36 diagnosis.

37 (3) Educate health-care professionals to develop a high level of awareness of Lyme disease.

38 (4) In conjunction with the Medical Society of Delaware and the Delaware Nurses Association, develop  
39 continuing medical education credits and nursing continuing education units on Lyme disease and encourage health-  
40 care professionals to take the continuing education courses as soon as reasonably practicable.

41 (5) Host continuing medical education and nursing continuing education trainings in all 3 counties and, if  
42 reasonably practicable, at hospitals to encourage the largest possible attendance by health-care professionals.

43 (6) Deliver education in a variety of methods, using professional associations, medical journals, radio,  
44 Internet, conferences, and linking medical training with a public awareness campaign.

45 (d) ~~Appointment terms for the Board are as follows:~~ The Governor shall appoint members for an initial term of 1  
46 year, and thereafter shall appoint members for staggered terms so that no more than 3 members' terms expire in any 1  
47 calendar year. An appointed member serves for a term of up to 3 years and is eligible for reappointment.

48 ~~(1) The members appointed by the Pro Tempore of the Senate and the Speaker of the House and the member~~  
49 ~~who is an advocate for the prevention and treatment of Lyme disease are appointed for an initial term of 3 years.~~

50           (2) The member who is licensed to practice medicine and the member who is licensed to practice nursing are  
51 appointed for an initial term of 2 years.

52           (3) The member who is a health care professional other than physician or nurse and the member who has  
53 knowledge and experience in the licensure and regulation of health care are appointed for an initial term of 1 year.

54           (4) After the initial terms, members are appointed or reappointed for terms of 3 years, but each appointing  
55 authority may appoint or reappoint members for a term of less than 3 years to ensure that no more than 3 members'  
56 terms expire annually.

57           (e) The Board shall select a Chair and Vice Chair from among its members.

58           (f) A majority of members appointed to the Board shall constitute a quorum to conduct official business.

59           ~~(g) If a vote by the Board results in a tie, the Board's Chair may vote a second time to break the tie.~~

60           ~~(h)~~ (g) Members of the Board shall serve without compensation, except that they shall be reimbursed for  
61 reasonable and necessary expenses incident to their duties as members of the Board excluding mileage. The Department  
62 shall pay such expenses.

63           ~~(i)~~ (h) The Department shall submit to the Governor and the General Assembly an annual report that contains, at a  
64 minimum, all of the following information:

65           (1) The title, description, and schedule of continuing medical education and nursing continuing education  
66 courses related to Lyme disease education.

67           (2) Attendance of continuing medical education and nursing continuing education courses by the health-care  
68 professional population.

69           (3) Specific accounting of fees and costs.

#### SYNOPSIS

This bill makes needed changes to the Lyme Disease Oversight Board by adding 2 members including an infectious disease epidemiologist and a licensed veterinarian or entomology specialist.
