HOUSE SUBSTITUTE NO. 1 FOR HOUSE BILL NO. 431

AN ACT TO AMEND TITLE 21 OF THE DELAWARE CODE RELATING TO SPECIAL LICENSE PLATES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Three-fifths of all members elected to each house thereof concurring therein):

I	Section 1. Amend Subchapter 11, Chapter 21, 11tle 21 of the Delaware Code by making deletions as shown by
2	strike through and insertions as shown by underline as follows:
3	§ 2140K. Special registration plates for Whitetails unlimited.
4	(a) (1) The owner of any vehicle described in paragraph (a)(2) of this section may apply to the Department for
5	assignment to that vehicle for a special "Whitetails Unlimited" registration plate. The Division shall issue the plate once the
6	required number of applications is received.
7	(2) This section applies only to:
8	a. A private passenger vehicle; or
9	b. A truck with a 3/4-ton or less manufacturer's rated capacity.
10	(b) No fee in addition to the annual registration fee otherwise required by this title is required for registration under
11	this section; provided, however, that an original application under this section shall be subject to a \$10 administrative fee
12	which shall be deposited into a special fund and used by the Division of Motor Vehicles for the purpose of administering
13	this section and to fund Department projects notwithstanding Chapters 13 and 14 of Title 2 to the contrary.
14	(c) The Department shall reserve sufficient special license plates including the letter "WTU" and numbered
15	consecutively beginning with the numeral "1" as are necessary to implement this section.
16	(d) Upon receipt by the Department of information that the individual to whom the special plate has been issued
17	has died, the surviving spouse may transfer the plate to a vehicle owned by the spouse that meets the requirements of
18	paragraph (a)(2) of this section as a valid registration plate. No fee in addition to the annual registration fee otherwise
19	required by this title is required for registration. If no spouse exists, the Department shall write to the representative of that
20	person's estate, requesting that such plate be returned to the Department within 90 days.
