## HOUSE OF REPRESENTATIVES 151st GENERAL ASSEMBLY

## HOUSE BILL NO. 453

AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO THE GENERAL ASSEMBLY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend § 701, Title 29 of the Delaware Code by making deletions as shown by strike through and 2 insertions as shown by underline as follows: 3 § 701. Designation of meetings of General Assembly. (a)(1) The meetings of the General Assembly shall are to be designated by numbers with a new consecutive 4 5 number designated every 2 calendar years. The General Assembly sitting in 1961 and 1962 shall is to be designated as the 6 121st General Assembly. 7 (2) The session of the General Assembly commencing on the first Tuesday of January, 1961, shall is to be 8 designated as the first regular session of the 121st General Assembly. The session of the General Assembly 9 commencing on the first Tuesday of February, 1962, shall is to be designated as the second regular session of the 121st 10 General Assembly. 11 (3) The After the 121st General Assembly, a subsequent regular session of the General Assembly 12 commencing in odd years shall be known an odd year is to be designated as the first regular session of a General 13 Assembly and the a regular sessions session commencing in even years shall be known an even year is to be designated 14 as the second regular session of a numbered General Assembly. 15 (b) A special session of a General Assembly shall be so is to be designated through a distinguishing designation. 16 (c) This The method of designation shall be under this section must be used in all official references to the General 17 Assembly and its sessions. 18 Section 2. 34	certificate. a certificate of election.
35	(b) The House of Representatives may compel the delivery of the certificate of election of any of its members by
36	like proceeding. the process under subsection (a) of this section.
37	Section 4. Amend § 704, Title 29 of the Delaware Code by making deletions as shown by strike through and

40	(a)(1) The Senate and House of Representatives may compel the delivery of ballot boxes to either House, as
41	provided by § 5716 of Title 15. the Senate and, for that purpose, may order and cause the arrest of the Sheriff or other
42	person having custody of the ballot boxes and punish as a contempt the failure to deliver the ballot boxes.
43	(2) The House of Representatives may compel and enforce the delivery of ballot boxes to the House as the
44	Senate may by the process under paragraph (a)(1) of this section.
45	(b) Whenever there shall be When there is a vacancy in either House of the General Assembly, Assembly when

49	(d) Any order for the payment of costs by the contestant, in case of a contested election for members of the
50	General Assembly, shall be enforced by a writ issued by the Speaker or President, as the case may be, of the House in
51	which such election was contested, as provided by § 5908 of Title 15. If the election or eligibility of a member of the

52	Senate or House of Representatives is contested under subchapter 1 of Chapter 59 of Title 15, the President of the Senate of
53	Speaker of the House of Representatives, as the case may be, shall issue a writ to order the payment of costs by the
54	contestant under § 5908 of Title 15.

66	member or a committee of which such person the individual is a member.
67	(c) Whoever does any of the following is to be fined not more than \$1,000, or imprisoned not more than 12

76	(d) Nothing in this section shall is to be construed as a waiver by the General Assembly of its the General
77	Assembly's inherent right to issue subpoenas and to punish for contempt of the General Assembly without the intervention

83	of the intention to present such petition has either been served in writing upon the person or persons to be affected by such
84	act or published in a newspaper published within the county of the petitioner's residence, if there is one or, if there is none
85	then in a newspaper published within the State. Proof of such notice may be dispensed with if the object of the petition is of
86	such nature that no person other than the petitioner can be affected thereby. [Repealed.]

105	security and make payment thereof of these moneys in accordance with federal and state laws.
106	Section 9. Amend § 710, Title 29 of the Delaware Code by making deletions as shown by strike through and

108	§ 710. Compensation of Lieutenant Governor and members of General Assembly.
109	(a) The Lieutenant Governor shall receive an annual salary of \$76,250 for serving as President of the Senate, of
110	which \$13,725 shall be for performing other duties. as determined in the annual appropriations act.

111	(b) Effective July 1, 2001, each $\underline{A}$ member of the Senate and the House of Representatives shall is to receive an
112	annual salary, as determined in the annual appropriations act, for the period commencing on the day after Election Day in
113	the year in which the member is elected and extending through and including the day preceding Election Day in the year in
114	which the term expires. The salary shall be payable biweekly and shall be lagged in accordance with the PHRST payroll
115	system. received under this subsection is to be paid under § 2712 of this title.

138	amount of a second stipend of an equal or lesser amount. the compensation for the other position to which the member is
139	elected or appointed. Eligible recipients of a second stipend compensation for a second position may choose not to accept

141	(e)(1) The stipend or stipends included herein shall commence immediately when such member is elected or
142	appointed to such position or positions. Payments to such members shall be as described in § 2712 of this title. A member
143	of the Senate or the House of Representatives is to receive the compensation required under subsections (c) and (d) of this
144	section beginning on the following date:
145	a. For a member elected to a position under paragraphs (c)(1) or (2) of this section, the date the Senate or
146	the House, as appropriate, votes to elect the member to the position.
147	b. For a member elected to a position under paragraphs (c)(3), (4), (6), or (7) of this section, the date the
148	member's election is announced to a session of the Senate or the House, as appropriate.
149	c. For a member appointed to a position under paragraphs (c)(5) or (8) through (12) of this section, the
150	date the member's appointment is communicated to the Secretary of the Senate or Chief Clerk of the House, as
151	appropriate.
152	(2) The compensation received under subsections (c) and (d) of this section is to be paid under § 2712 of this
153	<u>title.</u>
154	(d) $(f)$ Any A member of the Senate or the House of Representatives who is elected or appointed to any of the
155	positions listed in a position under subsection (c) of this section and who is entitled to receive additional semimonthly
156	compensation as provided by subsection (e) under subsections (c) and (d) of this section shall continue is to receive such
157	semimonthly the compensation until the member's successor has been elected or appointed. appointed or the General
158	Assembly in which the member is elected or appointed expires, whichever comes first.
159	Section 10. Amend § 711, Title 29 of the Delaware Code by making deletions as shown by strike through and
160	insertions as shown by underline as follows:
161	§ 711. Expenses of members of General Assembly.
162	Every member of the General Assembly shall receive \$2,637.60 annually for expenses, payable semimonthly
163	commencing on the eleventh month, fifteenth day of the year in which the member is elected through the tenth month,
164	thirty-first day of the year in which the member's term expires.
165	Effective January 1, 1995, every member of the General Assembly shall receive annual expenses payable
166	semimonthly for the period commencing on the first of the eleventh month in the year in which the member is elected
167	through the thirty first day of the tenth month in the year in which the term expires. In any calendar month, the first
168	payment of 1/24 of the statutory or stipulated annual expenses shall be made on the fifteenth day of such month for the

period from the sixteenth day through and including the last day of the preceding month; the second payment of 1/24 of the

170	statutory or stipulated annual expenses shall be made on the last day of each month for the period from the first day through
171	and including the fifteenth day of the current month.
172	A member of the Senate and the House of Representatives is to receive \$7,481 annually for expenses. The
173	expenses received under this subsection are to be paid under § 2712(a) of this title.
174	Section 11. Amend § 901, Title 29 of the Delaware Code by making deletions as shown by strike through and
175	insertions as shown by underline as follows:
176	§ 901. Altering, defacing, concealing, etc., or concealing bills or acts; penalties.
177	(a)(1) Whoever wilfully adds to, alters, defaces, erases, obliterates, mutilates, blots, blurs, steals, hides, conceals,
178	destroys or misplaces, with intent to conceal, any It is unlawful to wilfully do any of the following to an act passed by the
179	General Assembly of this State or any or a bill pending before either branch a House of the General Assembly or any
180	committee thereof or any Assembly, a committee of a House of the General Assembly, or a joint committee of the 2 Houses
181	General Assembly.
182	(2) is guilty of a felony and shall be fined A violation of paragraph (a)(1) of this section is a felony and is to
183	be punished by a fine of not less than \$100 nor more than \$5,000 and costs of prosecution and shall also be imprisoned
184	imprisonment of not less than 1 year nor more than 10 years.
185	(b) A bill within the meaning of this section shall be taken as pending from the time of its introduction until signed
186	by the Speakers of both Houses. The bill shall then be taken for an act. For purposes of this section:
187	(1) "Act" means a bill that has been enacted under § 18 of Article III of the Delaware Constitution.
188	(2) "Bill pending" means a bill that is introduced but has not yet been enacted under § 18 of Article III of the
189	Delaware Constitution.
190	(c) Alterations or amendments An alteration or amendment of an act passed by the General Assembly or a bill
191	pending before a House of the General, a committee of a House of the General Assembly, or a joint committee of the
192	General Assembly made in the regular course of proceedings shall not be construed as proceedings, including under
193	Chapter 2 of Title 1 and §§ 904 and 906 of this title, is not a violation of this section.
194	(d) Nothing contained in this section shall This section does not prevent or limit either a House of the General
195	Assembly from punishing for contempts an individual who violates paragraph (a)(1) of this section for contempt according
196	to parliamentary usage, nor shall any such usage. A punishment for contempts contempt by a House of the General
197	Assembly does prevent or limit prosecutions a prosecution under this section.

## **SYNOPSIS**

This Act makes necessary updates to Delaware Code provisions codifying procedures related to the General Assembly to bring these provisions into compliance with current practice and to make technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.

This Act makes the following substantive changes to these provisions:

- (1) In Section 8, repeals a procedure that, after the enactment of the Delaware Constitution of 1897, is no longer part of the legislative process. And, in Sections 17, 18, and 19 makes conforming repeals.
- (2) In Section 9, updates the amount of additional compensation paid to members of the General Assembly who are elected to leadership positions or appointed to serve on a joint committee, consistent with the amounts authorized under the most recent report of the Compensation Commission.
- (3) In Section 10, updates the amount of the stipend paid to members of the General Assembly consistent with the amount authorized under the most recent report of the Compensation Commission.
- (4) In Section 13, updates the process for appointing a bill clerk for the Senate and House of Representatives and the duties of the bill clerk.
- (5) In Section 14, removes the Passed Bill Committee ("Committee"), which has not existed since the mid-1960s. The Committee's duties related to management and tracking of passed and enacted legislation are reassigned to the Secretary of the Senate and Chief Clerk of the House of Representatives, who have these duties currently. The Committee's duties related to engrossing legislation are reassigned to the Division of Research, which has these duties currently. The Division is authorized to correct manifest clerical, typographical, and grammatical errors discovered in the engrossment process and required to proofread the engrossment before release to ensure an accurate engrossment of the amendment to the legislation.
- (6) In Section 15 and 16, changes references to "print" or "printing" to "publish" or "publication" in recognition of 21st Century methods of distributing information.
- (7) In Section 22, replaces the requirement that a proposed amendment to the United States Constitution be approved by two-thirds of the members of the General Assembly with a requirement that it be approved by a simple majority vote. The two-third vote requirement is unconstitutional under the Delaware Constitution because it conflicts with Section 10 of Article II of the Delaware Constitution, which provides for the passage of legislation by the concurrence of a

majority of members elected to each house. The General Assembly cannot alter the requirement of a majority vote withou an amendment to the Delaware Constitution. See Section 512 of Mason's Manual of Legislative Procedure (2020).
