AN ACT TO AMEND TITLE 14 OF THE DELAWARE CODE RELATING TO THE CULTURAL RESOURCE INCENTIVE PROGRAM.

1 WHEREAS, in 2011, the Delaware General Assembly enacted legislation establishing a professional education
2 incentive scholarship program in memory of former State Representative Ada Leigh Soles (1937–2010), a life-long
3 supporter of public libraries, to assist public library and archives staff members in seeking advanced education in their
4 fields; and

5 WHEREAS, museums and cultural resource agencies are finding it increasingly challenging to attract
6 professionals in these fields who possess advanced degrees required to meet the U.S. Secretary of Interior Historic
7 Preservation Professional Qualifications Standards in history, architectural history, or archaeology, and to assist persons
8 already employed by such agencies and organizations to further their education in order to obtain such credentials; and

9 WHEREAS, such credentialing is required for organizations receiving federal funds available for work in the
10 cultural resources field; and

11 WHEREAS, this program would further strengthen efforts of the Division of Historical and Cultural Affairs to
12 recruit and retain a more diverse workforce, as HCA is currently challenged to find credentialed minority candidates for
13 federally-funded positions in the cultural resource field; and

14 WHEREAS, it has become increasingly clear that a program similar to the Ada Leigh Soles Memorial Professional
15 Librarian and Archivist Incentive Program, enacted in 2011 and found in Title 14, Subchapter III, § 3423, of the Delaware
16 Code, is needed to help such cultural resource agencies attract and retain qualified professionals in these fields; and

17 WHEREAS, in seeking an appropriate person for whom to name the said cultural resources incentive program, the
18 late Lewis M. Purnell (1921–2015) came immediately to mind, as a public-spirited citizen with a broad interest in Delaware
19 history, historic preservation, archaeology and related fields; and

20 WHEREAS, Mr. Purnell, known to his legions of friends as “Skipper,” retired with his wife, Matilda “Til” Horn
21 Purnell to their native Sussex County in the mid-1970s after having spent a career in the United States foreign service at
22 stations around the world, following Skipper’s earlier service in World War II; and

23 WHEREAS, a native of Georgetown and son of former Delaware State Senate President Pro Tempore Harold W.
24 T. Purnell, as a high school student in the 1930’s, Skipper had driven the young artist, Jack Lewis, around Sussex County
25 while Lewis worked on a series of watercolor paintings that later became part of his classic 1940 book, The Delaware
26 Scene; and

27 WHEREAS, a student at The Johns Hopkins University in the early 1940s, Skipper left college in 1942 to join the
28 American Field Service, serving as an ambulance driver with the British Army in North Africa and Italy and, having been
29 injured at the Battle of Monte Cassino in 1944, returned to the United States, where, in 1945, he entered the U.S. foreign
30 service; and

31 WHEREAS, the Purnells’ unique home on the shores of Herring Creek in coastal Sussex, consisting of several
32 18th century structures grouped together around a modern core, was itself an eloquent testimony to the commitment of
33 Skipper and his wife, Til, to the spirit of historic preservation; and

34 WHEREAS, Skipper, a true renaissance man, took a great interest in helping to further the study of Delaware
35 history and to preserve both archaeological and architectural treasures from our state’s rich past, serving for many years on
36 the Delaware Heritage Commission, among other volunteer service, and being a recipient of the Governor’s Heritage
37 Award; and

38 WHEREAS, naming a program designed to help those Delawareans who have chosen such a career path to further
39 their careers in honor of a man who devoted so much of his life to the furtherance of these fields in the State of Delaware
40 seems singularly appropriate.

41 NOW, THEREFORE:

42 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

43 Section 1. Amend Subchapter III, Chapter 34, Title 14 of the Delaware Code by making deletions as shown by
44 strike through and insertions as shown by underline as follows:

45 § 3447. Lewis M. “Skipper” Purnell Cultural Resources Memorial Scholarship.

46 (a) Purpose. It is the intent and purpose of this scholarship to enable and encourage academically talented
47 Delawareans to pursue careers as cultural resources professionals.

48 (b) Awards.

49 (1) The Office will award scholarships for graduate education in certificate or master’s degree programs of
50 museum studies and degrees required for meeting the U.S. Secretary of Interior Historic Preservation Professional
51 Qualifications Standards in history, architectural history, or archeology. Preference is given to persons currently employed
52 in Delaware by a public or nonprofit museum or cultural resource agency, any subdivision of state, county or municipal
53 government engaged in museum or cultural resources interpretation or management, or any institutional member of the
54 Delaware Museum Association. Preference is also given to persons employed by a State-recognized tribe under §§ 106 and
55 107 of Title 29 or persons who otherwise serve in an official capacity to a State-recognized tribe as nominated by the Chief
56 or Tribal Council of such tribe.

57 (2) The Office may also award scholarships for a course of study leading to a bachelor’s degree prior to the
58 master’s degree or for a doctoral degree following the master’s degree. Awards under this paragraph are limited to persons
59 who have been employed for a minimum of 6 months in Delaware by a public or nonprofit museum or cultural resource
60 agency, or any subdivision of state, county, or municipal government engaged in museum or cultural resources
61 interpretation or management, or any institutional member of the Delaware Museum Association.

62 (3) Selection criteria may include consideration of community service, academic achievement, and financial need.

63 (c) Renewal.

64 Renewal of awards is limited to the number of years that constitute the standard full-time completion rate. To be
65 eligible for renewal of an award, the recipient must meet academic progress standards set by the Office and communicated
66 in writing to the recipient at the time the initial award is granted.

67 Section 2. This Act takes effect upon enactment of House Bill No. 480.

68 Section 3. The 2023-2024 school year will be the first year that the scholarship will be awarded.

SYNOPSIS

This Act establishes a cultural resources professional scholarship for the purpose of enabling and encouraging academically talented Delawareans to pursue careers as cultural resource professionals. The scholarship is also available to persons already serving in positions with cultural resource agencies, such as the Delaware Division of Historical and Cultural Affairs or with organizations that are institutional members of the Delaware Museum Association, among others, further their education. This scholarship would strengthen Delaware’s ability to both recruit and retain a more diverse workforce and would help the state meet federal credentialing requirements for federally-funded projects. The scholarship is named for the late Lewis M. “Skipper” Purnell, one of Delaware’s leading historical preservationists and husband of Mrs. Matilda “Til” Purnell, a great Delaware environmentalist in her own right.

This Substitute Bill differs from the original in that it makes this a scholarship rather than a loan reimbursement program. It is written to be placed in the code after the significant changes to Chapter 34 made by House Bill 480. Because it is designed to exist under the new Delaware Higher Education Office’s role, enactment is contingent on the passage and enactment of HB 480. It also is a different section number than the original bill based on the changes being made to the chapter by HB 480.
