DELAWARE STATE SENATE

SENATE BILL NO. 44

AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO THE OFFICE OF NEW AMERICANS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend Chapter 87, Title 29 of the Delaware Code by making deletions as shown by strike through and  
2 insertions as shown by underline as follows:

3 Subchapter I-A. Office of New Americans.

4 § 8751. Legislative Findings.

5 The General Assembly finds and declares as follows:

6 (1) In 2018, Delaware was home to 91,230 foreign-born individuals, which comprise 9% percent of the  
7 State's population.

8 (2) Throughout this State's history, immigrants have played a critical role in this State's economic, cultural,  
9 and political growth and success.

10 (3) Policies that promote the attraction, retention, and inclusion of immigrants and refugees will help enhance  
11 this State's economy and diversity, thereby improving the lives of all residents and helping to remove barriers that may  
12 undermine immigrants' full potential.

13 (4) Immigrants currently fill skilled positions throughout this State's economy and are a vital part of this  
14 State's economy and tax base. In 2018, immigrant business owners in this State generated more than \$51,000,000 in  
15 business revenue and immigrant spending power increased to \$2,700,000,000.

16 (5) 32% of immigrants in this State have a bachelor of arts, bachelor of science, or graduate degree, compared  
17 to 31% of United-States-born Delawareans.

18 (6) Organizations are providing leadership in this State's immigrant integration efforts through programs and  
19 services that connect newcomers and longtime Delawareans to economic opportunity.

20 (7) It is essential for this State's future that skilled, energetic, and entrepreneurial immigrants are attracted,  
21 retained, and integrated. Immigrants help to bolster this State's economy and strengthen the social, civic, and cultural  
22 fabric.

23           (8) This State enforces and provides for many services, licenses, and educational and economic opportunities,  
24 which makes it imperative to coordinate the work of state agencies, leverage relationships with partner and nonprofit  
25 organizations, and recommend policies and programs that support immigrant inclusion. Immigrants on the path to full  
26 civic and economic participation will benefit from a welcoming environment and policies that do all of the following:

27           a. Increase immigrant access to English language instruction and workforce development and  
28 employment.

29           b. Reduce exploitation and fraud against immigrants.

30           c. Connect immigrants to legal services and assist on the path to naturalization.

31           d. Provide individuals with meaningful access to State resources and opportunities regardless of English  
32 proficiency.

33           (9) In recognition of these facts and in promotion of the stated goals, the creation of the Office of New  
34 Americans will help improve the lives and economic prosperity of immigrants and of Delawareans generally.

35           § 8752. Definitions.

36           For purposes of this chapter:

37           (1) “Advisory Committee” means the Advisory Committee to the Office.

38           (2) “Department” means the Department of State.

39           (3) “Director” means the Director of the Office.

40           (4) “Office” means the Office of New Americans.

41           (5) “Secretary” means the Secretary of the Department.

42           § 8753. Office of New Americans; establishment and purpose; director.

43           (a) The Office of New Americans is established within the Department to help improve the lives and economic  
44 prosperity of immigrants and Delawareans generally.

45           (b) The Secretary shall appoint and fix the salary of a Director to lead the Office. The Director serves at the  
46 pleasure of the Secretary and is exempt from the classified service or state service, as defined under Chapter 59 of this title.

47           § 8754. Office of New Americans; powers and duties.

48           The Office shall do all of the following:

49           (1) Respond to inquiries from State agencies, the media, immigrant-serving organizations, and the public  
50 about immigration issues in this State.

51           (2) Serve as point of contact for State licensing boards and the Division of Professional Regulation.

- 52           (3) Serve as an information clearinghouse for State agencies on immigration-related policy issues and  
53 coordinate among agencies as appropriate.
- 54           (4) Analyze economic, demographic, and other trends impacting immigrants in this State and make policy  
55 recommendations.
- 56           (5) Ensure that this State is gathering relevant data to inform the State's policy making on immigrant issues.
- 57           (6) Develop strategies to attract, retain, and integrate immigrants into this State.
- 58           (7) Convene stakeholders in business development and international trade promotion programs to increase  
59 capacity to utilize immigrant contributors.
- 60           (8) Disseminate information to new and prospective immigrant residents of this State who wish to invest  
61 capital, launch businesses, or apply their skills in this State.
- 62           (9) Convene municipal and county officials to boost peer learning on increasing immigration in locations in  
63 this State struggling with population loss and economic decline.
- 64           (10) Convene college and university officials to foster learning on strategies for immigrant and international  
65 student retention.
- 66           (11) Provide matching grant funds for high-quality immigration and economic development programs that can  
67 demonstrate corporate or philanthropic investment.
- 68           (12) Disseminate information about available services to assist new and prospective immigrant residents of  
69 this State on the path to naturalization.
- 70           (13) Disseminate information about legal services available to immigrants in civil legal matters, including  
71 housing, family, and immigration.
- 72           (14) Disseminate information about English language instruction and resources available to immigrant  
73 residents of this State.
- 74           (15) Convene stakeholders in State agencies, immigrant-serving organizations, and the public to identify and  
75 reduce exploitation and fraud against immigrants.
- 76           (16) Convene stakeholders in immigrant-serving organizations to promote race, sex, gender, age, income, and  
77 LGBTQ equity and to identify and reduce inequities.
- 78           (17) Develop strategies to provide immigrants with meaningful access to State resources and opportunities  
79 regardless of their level of English proficiency.
- 80           (18) Communicate with federal and international stakeholders to support the resettlement process for refugees  
81 who have been identified for resettlement in this State.

82                   (19) Evaluate the success of activities and adjust activities as appropriate.

83                   § 8755. Advisory Committee; establishment and staffing.

84                   (a) The Advisory Committee to the Office of New Americans is established within the Office and shall serve in an  
85 advisory capacity to the Office in matters regarding immigrants in this State.

86                   (b) The Office shall staff and administer the Advisory Committee.

87                   § 8756. Advisory Committee; membership, terms, designees.

88                   (a) The Advisory Committee consists of the following members, or a designee selected by a member serving by  
89 virtue of position:

90                   (1) The Director of the Office of New Americans.

91                   (2) The Director of the Delaware State Housing Authority.

92                   (3) The Secretary of the Department of Labor.

93                   (4) The Secretary of the Department of Education.

94                   (5) The Secretary of the Department of Health and Social Services.

95                   (6) A member of the Human and Civil Rights Commission, appointed by the Commission.

96                   (7) The following members, appointed by the Governor:

97                   a. One member from an organization that attracts, retains, and integrates immigrants into this State's  
98 economic, cultural, and civic affairs.

99                   b. One member from an institution of higher education who has a primary focus on immigration issues.

100                   c. One member with expertise in promoting language access plans or one member from an agency  
101 focused on providing English language instruction to speakers of other languages.

102                   d. One member from an agency working to increase immigrants' access to healthcare services.

103                   e. One member from a refugee resettlement agency.

104                   f. One member of the public.

105                   (b) A member appointed by the Governor serves at the pleasure of the Governor.

106                   (c) A member of the Advisory Committee with the ability to designate another individual to attend an Advisory  
107 Committee meeting shall provide the designation in writing to the chair. An individual attending a meeting for a member as  
108 a designee has the same duties and rights as the member.

109                   § 8757. Advisory Committee; procedures.

110                   (a) The Director is the chair of the Advisory Committee. As chair, the Director shall do all of the following:

111                   (1) Set the date, time, and place for meetings of the Advisory Committee.

- 112           (2) Supervise the preparation and distribution of meeting notices, agendas, minutes, correspondence, and  
113 reports of the Advisory Committee.
- 114           (3) Preside over meetings of the Advisory Committee.
- 115           (4) Maintain order during a meeting of the Advisory Committee and decide all questions of order.
- 116           (b) A quorum of the Advisory Committee is a majority of the members of the Advisory Committee.
- 117           (c) The Advisory Committee acts by a vote of the majority of the members of the Advisory Committee.
- 118           (d) The Advisory Committee may adopt rules to carry out the purpose and duties of the Advisory Committee.
- 119           § 8758. Advisory Committee; power and duties.
- 120           (a) The Advisory Committee shall do all of the following:
- 121               (1) Make recommendations to the Governor, Secretary, and Director on policies, procedures, regulations, and  
122 legislation to attract, retain, and integrate immigrants into this State's society.
- 123               (2) Serve as the Office's liaison to immigrants on policies, procedures, regulations, and legislation that affect  
124 immigrants, in order to ensure that State government is accessible, accountable, and responsive to the needs of  
125 immigrants.
- 126               (3) Serve as a resource to all departments, commissions, and agencies under the Governor's jurisdiction to  
127 ensure that government entities are cognizant of the needs of immigrants and that the entities' respective services and  
128 programs are accessible to immigrants.
- 129               (4) Work with the Office to monitor the practices of State agencies relating to the attraction, retention, and  
130 integration of immigrants to maximize the efficiency and accessibility to State government.
- 131               (5) Perform other duties as the Governor and Secretary may assign in planning for services and programs for  
132 immigrants.
- 133           (b) The Advisory Committee may conduct studies and issue reports on request and as necessary on issues affecting  
134 immigrants in this State.
- 135           (c) The Advisory Committee shall conduct at least 1 public hearing each year to receive testimony and public  
136 comments on improving the attraction, retention, and integration of immigrants in this State.

#### SYNOPSIS

This Act establishes the Office of New Americans to help improve the lives and economic prosperity of new Americans who come to Delaware and of all Delawareans generally.
