## DELAWARE STATE SENATE 152nd GENERAL ASSEMBLY

## SENATE BILL NO. 71

AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO REPORTING SUSPECTED ANIMAL CRUELTY.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

| 11 | neglect. The system shall endeavor to coordinate community resources and provide assistance or services to children and    |
| 12 | families identified to be at risk, and to prevent and remedy child abuse and neglect.                                      |
| 13 | (d) In implementing law-enforcement's role in the child protection system, the law-enforcement agency                      |
| 14 | investigating a report of child abuse or neglect shall do all of the following:  |
| 15 | (1) Report every case of child abuse or neglect to the Department as required by under § 903 of this title.                |

| 39 | (a) A person who reasonably suspects animal cruelty may report the suspected animal cruelty to the Office of           |
| 40 | Animal Welfare for investigation.  |
| 41 | (b)(1) A person who in good faith participates in reporting suspected animal cruelty has immunity from any             |
| 42 | liability, civil or criminal, that might otherwise exist as a result of making the report.                             |
| 43 | (2) The immunity provided under this section extends to the person's participation in any judicial proceeding          |
| 44 | resulting from the good faith report of suspected animal cruelty.  |
|    | SYNOPSIS   |

This Act requires law-enforcement agencies, the Department of Services for Children, Youth and Their Families, and the Department of Justice to report suspected animal cruelty to the Office of Animal Welfare that is discovered while performing their responsibilities in child welfare cases. This Act also provides immunity to people who in good faith, report suspected animal cruelty.

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
