## HOUSE CONCURRENT RESOLUTION NO. 42

WHEREAS, 1 in 5 adults in the United States experience mental illness each year, but less than half of them

## RECOGNIZING THE MONTH OF MAY 2023 AS MENTAL HEALTH AWARENESS MONTH.

2 receive treatment; and 3 WHEREAS, over 100 Americans, teens through older adults, die by suicide each day, and suicide is the second 4 leading cause of death among Americans aged 10-34; and 5 WHEREAS, mental illness and substance use disorders are involved in 1 out of every 8 emergency department 6 visits by an adult in the United States; and 7 WHEREAS, nationally, 37% of incarcerated adults and 70.4% of youth in the juvenile justice system have a 8 diagnosed mental illness; and 9 WHEREAS, 11% of youth have a mood disorder, 10% of youth have a behavior or conduct disorder, and 8% of 10 youth have an anxiety disorder; and 11 WHEREAS, 50% of all lifelong cases of mental illness begin by age 14, and 12 WHEREAS, mental health is important at every stage of life, from childhood and adolescence through adulthood; 13 and 14 WHEREAS, in recognition of the importance of mental health and the advantages to individuals and our 15 communities of providing resources to identify and treat mental health conditions as early as possible, the 151st General 16 Assembly passed HB 100 and HB 300 which will create a mental health services unit to fund a position for counselors, 17 psychologists, social workers and mental health therapists in schools with kindergarten through 5th grade, and in 6th 18 through 8th grade; and 19 WHEREAS, to continue the work of HB 100 and HB 300, the General Assembly has introduced and is considering HB 200 which would create a mental health services unit in schools with 9th through 12th grade; and 20

22	exacerbate mental health conditions in both adults and children, making the availability of mental health resources more

26	Senate concurring therein, that May is recognized as Mental Health Awareness Month.

28	raise mental health awareness and continue helping Delawareans to live longer, healthier, more productive lives.
