## DELAWARE STATE SENATE 152nd GENERAL ASSEMBLY

## SENATE CONCURRENT RESOLUTION NO. 54

PROCLAIMING MAY 11, 2023, AS "HOME CARE ADVOCACY DAY" IN THE STATE OF DELAWARE.

1	WHEREAS, data from the U.S. Census Bureau indicates 20% of Delaware's population is already over the age of
2	65; and
3	WHEREAS, the Delaware Department of Health and Social Services projects that between 2015 and 2030
4	Delaware's population will see an estimated 40% increase in the 60 and older population; and
5	WHEREAS, surveys from the American Association of Retired Persons (AARP) suggest that the vast majority of
6	American seniors would like to age in their own homes and communities; and
7	WHEREAS, as individuals age, they are more likely to experience some form of physical disability, have
8	difficulty completing activities of daily living, and require some form of memory care; and
9	WHEREAS, support in the home is essential for seniors to successfully age in place; and
10	WHEREAS, AARP estimates that 21% of American adults serve as volunteer caregivers for a loved one; and
11	WHEREAS, professional home care affords many seniors a cost-effective option for support services in the home
12	and can also lessen the demands on family and volunteer caregivers; and
13	WHEREAS, a robust and capable workforce is vital to responding to the needs of Delaware's rapidly aging
14	population and to supporting the health and wellbeing of those who need and rely on direct care services; and
15	WHEREAS, according to the University of Delaware Center for Applied Demography & Survey Research,
16	Delaware's home care workforce is declining despite increased demand for home care services; and
17	WHEREAS, social and economic forces, including the COVID-19 pandemic, have irreversibly changed how our
18	families live, work, and provide care; and
19	WHEREAS, the home care workforce requires public sector recognition, support, and investment in order to build
20	a robust home care infrastructure in order to ensure that individuals receive the care necessary to allow them to live
21	independent lives and age with dignity.

NOW, THEREFORE:
