HOUSE OF REPRESENTATIVES 152nd GENERAL ASSEMBLY

HOUSE BILL NO. 155

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO OFFENSES INVOLVING DEADLY WEAPONS AND DANGEROUS INSTRUMENTS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

I	Section 1. Amend Part E, Title 11 of the Delaware Code by making deletions as shown by strike through and
2	insertions as shown by underline as follows:
3	§ 1442. Carrying a concealed deadly weapon; class G felony; class D felony.
4	(a) A person is guilty of carrying a concealed deadly weapon when the person carries concealed a deadly weapon
5	upon or about the person without a license to do so as provided by § 1441 of this title.
6	(b) Carrying a concealed deadly weapon is a class G felony, unless the deadly weapon is a firearm, in which case it
7	is a class D felony.
8	(c) It shall be a defense that the defendant has been issued an otherwise valid license to carry a concealed deadly
9	weapon pursuant to terms of § 1441 of this title, where:
10	(1) The license has expired,
1	(2) The person had applied for renewal of said license within the allotted time frame prior to expiration of the
12	license, and
13	(3) The offense is alleged to have occurred while the application for renewal of said license was pending
14	before the court.
15	(d) It shall be a defense that the defendant complied with § 1456(b).
16	§ 1456. Unsafe storage of a firearm; class A or B misdemeanor.
17	(a) (1) A person is guilty of unsafe storage of a firearm when the person intentionally or recklessly stores or leaves
18	a loaded firearm in a place other than a vehicle within the reach or easy access of an unauthorized person, the unauthorized
19	person obtains the firearm, and all of the following do apply applies:
20	a. The firearm was not stored in a locked box or container.
21	b. The firearm was not disabled with a tamper-resistant trigger lock which was properly engaged so as to
22	render the firearm inoperable by a person other than the owner or other lawfully-authorized user.

23	c. The firearm was not stored in a location that a reasonable person would have believed to be secure
24	from access by an unauthorized person.
25	d. The unauthorized person did not obtain the firearm as the result of an unlawful entry by any person.
26	(2) For the purposes of this section:
27	a. "Stores or leaves" does not mean when the firearm is carried by or under the control of the owner or
28	other lawfully-authorized user.
29	b. "Unauthorized person" means a child or person prohibited by state or federal law from owning or
30	possessing a firearm.
31	(b) [Repealed.] A person is guilty of unsafe storage of a firearm in a vehicle when the person knowingly leaves a
32	firearm unattended in a vehicle, and the firearm is not stored in any of the following:
33	(1) A locked box or container.
34	(2) A locked firearms rack that is on a motor vehicle.
35	(3) Locked in the trunk of the vehicle.
36	(c) (1) Unsafe storage of a firearm is a class B misdemeanor if paragraphs (c)(2)a., b., or c. of this section do not
37	apply.
38	(2) Unsafe storage of a firearm is a class A misdemeanor if the unauthorized person does any of the following:
39	a. Commits or attempts to commit a crime with the firearm.
40	b. Uses the firearm to inflict serious physical injury or death upon any person, including the unauthorized
41	person.
42	c. Transfers or attempts to transfer the firearm to another unauthorized person.
43	(3) Unsafe storage of a firearm in a vehicle under subsection (b) is a class A misdemeanor.
44	(d) The Superior Court has jurisdiction over an offense under this section.
45	(e) It is not an offense under this section if the firearm was manufactured in or before the year 1899 or is a replica
46	of such firearm if the replica is not designed or redesigned for using rimfire or conventional centerfire fixed ammunition.
47	(f) It is not a defense to subsection (b) of this section that the defendant has been issued an otherwise valid license
48	to carry a concealed deadly weapon pursuant to terms of § 1441 of this title.

SYNOPSIS

This bill makes the unsafe storage of a firearm in a vehicle a class A misdemeanor if the person knowingly leaves a firearm unattended in a vehicle and the firearm is not stored in a locked box or container, a firearms rack that is on the motor vehicle, or locked in the trunk. This bill also provides that compliance with unsafe storage of a firearm in a vehicle is a defense to carrying a concealed deadly weapon.
