HOUSE BILL NO. 185

AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO HEALTH CARE INSURANCE AND
ELIMINATION OF THE STATE SHARE WAITING PERIOD.

1 WHEREAS, health care premiums are not prorated, so if a newly hired benefit eligible employee's hire date is any
2 date other than the first of a month and they enroll in health care coverage, the employee would be responsible for paying
3 the entire employee share of the monthly premium.

4 NOW, THEREFORE:

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

6 Section 1. Amend § 5201, Title 29 of the Delaware Code by making deletions as shown by strike through and
7 insertions as shown by underline as follows:

8 § 5201. Definitions.

9 For purposes of this chapter:

10 (8) A "regular officer or employee" ~~shall be~~ means ~~one who has been continuously employed by this State in~~
11 ~~each calendar month during 3-month period immediately preceding the first day of any given month (exclusive of legal~~
12 ~~holidays and allowable leave) and who works the regularly scheduled full-time hours of the employing agency, or at~~
13 ~~least 30 or more hours per week or 130 hours per month (with allowable interruptions) in a position of a continuing~~
14 ~~nature on a regular schedule expected to last at least 1 year from the date of initial appointment. The appointing~~
15 ~~authority shall determine at the time of appointment the qualifications of an appointee regarding the continuing nature~~
16 ~~and appointment duration criteria of this paragraph. An employee appointed to temporary or seasonal positions and~~
17 ~~members of boards and commissions who were not receiving coverage under the State group health insurance contract~~
18 ~~on January 1, 1993, shall not be considered a "regular officer or employee" for the purposes of this chapter. A "regular~~
19 ~~officer or employee" called to active duty with Guard or Reserve for other than training purposes shall continue to~~
20 ~~receive state contributions toward health insurance coverage for a period of up to 2 years. A "regular officer or~~
21 ~~employee" shall also include an employee who is receiving disability benefits pursuant to § 5253(b) of this title.~~

22 Section 2. This Act is effective January 1, 2024.

SYNOPSIS

This legislation prioritizes recruitment and retention of State employees by removing the 3-month waiting period for the state to pay its share of premium or subscription charges for health care coverage under § 5202 of Title 29 for benefit eligible state employees hired on or after January 1, 2024 by revising the definition of a “regular office or employee.”
