DELAWARE STATE SENATE 152nd GENERAL ASSEMBLY

SENATE BILL NO. 165

AN ACT TO AMEND TITLE 24 OF THE DELAWARE CODE RELATING TO PHARMACY.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

3 § 2502. Definitions.

4 For purposes of this chapter:

5 () "Collaborative pharmacy practice" means the practice of pharmacy whereby one or more pharmacists provides

6 patient care and drug therapy management services not otherwise permitted to be performed by a pharmacist to

7 patients under a collaborative pharmacy practice agreement(s) with one or more practitioners which defines the

8 nature, scope, conditions, and limitations of the services to be provided by the pharmacist(s).

9 () "Collaborative pharmacy practice agreement" means a written and signed agreement between one or more

10 pharmacists and one or more practitioners that provides for collaborative pharmacy practice.

11 (21)() "Practice of pharmacy" means the interpreting, evaluating, and dispensing of a practitioner's or prescriber's

12 order. The "practice of pharmacy" includes the proper compounding, labeling, packaging, and dispensing of a drug

13 to a patient or the patient's agent, and administering a drug to a patient. The "practice of pharmacy" includes the

14 application of the pharmacist's knowledge of pharmaceutics, pharmacology, pharmacokinetics, drug and food

15 interactions, drug product selection, and patient counseling. The "practice of pharmacy" also includes all of the

16 following:

17 a. Participation in drug utilization and/or drug regimen reviews.

18 b. Participation in therapeutic drug selection, substitution of therapeutically equivalent drug products.

- 19 c. Advising practitioners and other health-care professionals, as well as patients, regarding the total scope
- 20 of drug therapy, so as to deliver the best care possible.

21	d. Monitoring drug therapy.		
22	e. Performing and interpreting capillary blood tests to screen and monitor disease risk factors or facilitate		
23	patient education, the results of which must be reported to the patient's health-care practitioner; screening results		
24	to be reported only if outside normal limits.		
25	f. Conducting or managing a pharmacy or other business establishment where drugs are compounded or		
26	dispensed.		
27	g. [Repealed.]		
28	h. Administration of injectable medications, biologicals and adult immunizations pursuant to a valid		
29	prescription or physician-approved protocol approved by a physician duly licensed in the State under subchapter		
30	III of Chapter 17 of this title. Pharmacists shall request which physician or physicians and notify the physician		
31	or physicians as designated by the patient of such administration within 72 hours. The notice shall include the		
32	patient's name, the name of the immunizations, inoculations or vaccinations administered, and the date of		
33	administration and may be submitted by phone, fax, post or electronically. Upon request a copy of the protocol		
34	will be made available to the designated physician or physicians without costs. Upon request, a copy of the		
35	protocol will be made available to the designated prescriber or prescribers without cost. All vaccine		
36	administrations shall be reported to DELVAX within 72 hours of administration. This report to DELVAX shall		
37	include the patient's name, the name of the immunization, inoculations, or vaccinations administered, site of		
38	injection, Lot and expiration, the facility that provided vaccination, and the date of administration, and shall be		
39	submitted electronically. Pharmacists, pharmacy interns, and nationally certified pharmacy technicians who		
40	have completed an accredited training program, are currently trained in CPR, and have notified the Delaware		
41	Board of Pharmacy, may administer immunizations via a prescriber's order or protocol for patients 3 years of		
42	age and older.		
43	i. Dispensing contraceptives or dispensing and administering injectable hormonal contraceptives under		
44	Chapter 30O of Title 16.		
45	j. Ordering, performing, and interpreting tests authorized by the Food and Drug Administration, and		
46	waived under the federal Clinical Laboratory Improvement Amendments of 1988 [42 U.S.C. § 263a].		
47	k. Initiating drug therapy for health conditions in accordance with § 2525 of this title.		
48	1. Collaborative pharmacy practice in accordance with a collaborative pharmacy practice agreement.		
49	(22)() "Practitioner" or "prescriber" means an individual who is authorized by law to prescribe drugs in the course		
50	of professional practice or by collaborative pharmacy practice agreement or research in any state.

<u>SYNOPSIS</u>

This Act amends Chapter 25, Title 24 of the Delaware Code relating to the Practice of Pharmacy. The amendments authorize pharmacists to engage in "collaborative pharmacy practice" with one or more "practitioners" meaning individuals who are authorized by law to prescribe drugs in the course of professional practice. Pharmacists may also do so pursuant to a "collaborative pharmacy practice agreement," which means a written and signed agreement between one or more pharmacists and one or more practitioners that provides for a collaborative pharmacy practice.
