AN ACT TO AMEND TITLE 16 OF THE DELAWARE CODE RELATING TO THE BEHAVIORAL HEALTH CONSORTIUM AND THE PRESCRIPTION OPIOID DISTRIBUTION COMMISSION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

1 Section 1. Amend Subchapter VIII-A, Chapter 51, Title 16 of the Delaware Code by making deletions as shown by
2 strike through and insertions as shown by underline as follows and redesignating accordingly:

3 Subchapter VIII-A. Behavioral Health Consortium; Prescription Opioid Distribution Commission

4 § 5195. Behavioral Health ~~Consortium; Prescription Opioid Distribution Commission.~~ Consortium.

5 (a) ~~The following are established:~~

6 (1) ~~The Behavioral Health Consortium, referred to in this subchapter as the “Consortium.”~~ “Consortium,” is
7 established.

8 (2) ~~The Prescription Opioid Settlement Distribution Commission, a subcommittee of the Consortium, referred~~
9 ~~to in this subchapter as the “Commission.”~~

10 (b) (1) The Consortium shall provide oversight of the State’s private and public bodies or entities that affect
11 behavioral health-care and substance use treatment to ensure the delivery of quality care.

72 (d) *Terms of the Consortium members.* — Governor appointed members are appointed for a term of ~~2 years.~~ 2
73 years and may not serve more than 3 terms or a total of 6 years. The terms may be consecutive or nonconsecutive. The
74 Governor, Speaker of the House of Representatives, or President Pro Tempore of the Senate may appoint a member for a
75 term of less than 2 years to ensure terms expire on a staggered basis.

76 § 5196. Prescription Opioid Settlement Distribution Commission.

77 (a) As used in this subchapter:

78 (1) “Commission” means the Prescription Opioid Settlement Distribution Commission.

79 (2) “Impact Fund” means the Prescription Opioid Impact Fund under § 4803B of this title.

80 (3) “Settlement Fund” means the Prescription Opioid Settlement Fund under § 4808B of this title.

81 (4) “Statewide opioid settlement agreement” means as defined in § 4802B of this title.

83 (1) Delaware is a high harm state with significant numbers of overdose deaths reported each year.

84 (2) The powerful, addictive qualities of opioids cause people who are suffering from substance use disorder to
85 face a long road to recovery. The challenges of recovering from an addiction to opioids also has a tremendous impact
86 on families, friends, and other loved ones, and first responders and the health-care system must expend significant
87 resources to address the opioid crisis.

120 (a) ~~The Commission shall make recommendations to the Consortium regarding~~ approve all distributions from the
121 money in the Settlement Fund and the Impact Fund.

122 (c) Except as noted under paragraph (b)(9) of this section, appointed members are appointed for a term of 2 years
123 and may not serve more than 3 terms or a total of 6 years. The terms may be consecutive or nonconsecutive. The appointing
124 authority may appoint a member for a term of less than 2 years to ensure terms expire on a staggered basis.

125 ~~(e) (d) The Attorney General and Governor, or their designees, shall co-chair~~ The Governor, or the Governor's
126 designee, shall chair the Commission Commission. The Commission may elect a member of the Commission to serve as
127 vice chair, with such duties as the Commission assigns. The chair of the Commission and shall be is responsible for guiding
128 the administration of the Commission by, at a minimum, doing all of the following:

129 (5) Ensuring that any reports produced by the Commission are distributed to members of the Delaware
130 General Assembly, the Governor, the Behavioral Health Consortium, the Director and the Librarian of the Division of

132 ~~(d) (e)~~ (1) A quorum of the Commission, or any committee of the Commission, is a majority of its current
133 members. Official action by the Commission, including making ~~findings and recommendations,~~ recommendations and
134 distributing funds, requires the approval of the majority of the Commission members present at a public meeting where a
135 quorum of the Commission is present.

136 (2) The chair and members of the Local Government Committee are selected in the same manner as other
137 committees under ~~subsection (f)~~ subsection (g) of this section.

138 (4) ~~The Behavioral Health Consortium shall provide~~ Chair of the Commission shall coordinate administrative
139 support to for the Commission.

140 ~~(f)~~ (g) The Commission ~~co-chairs~~ chair may create additional committees. The Commission ~~co-chairs~~ chair shall
141 appoint a member of the Commission to serve as the chair of each committee and the initial committee members.
142 Additional committee members may be appointed or removed by the chair of each committee. Individuals who are not
143 members of the Commission may serve as a member of a committee.

144 § 5196B. Distributions from the Prescription Opioid Settlement Fund and the Prescription Opioid Impact Fund.

145 (a) (1) The ~~Consortium~~ Commission shall distribute the money in the ~~Prescription Opioid Settlement Fund~~
146 ~~(Settlement Fund)~~ and the ~~Prescription Opioid Impact Fund (Impact Fund)~~ based on the recommendations of the
147 ~~Commission~~ by awarding grants, by directing the Secretary of the Department of Health and Social Services to enter into
148 contracts, or by distributing funds to State agencies and local governments to be administered as directed by the
149 Commission.

150 (2) If the ~~Consortium~~ Commission does not adopt a recommendation of the Commission, the Consortium
151 approve a grant or funding to a State agency or local government, the Commission shall provide a written explanation
152 of the decision and the Commission may revise that recommendation to the Consortium. applicant may be offered the
153 opportunity to revise and resubmit the application.

154 (3) ~~The Consortium may not make a distribution from the Settlement Fund or Impact Fund without a~~
155 ~~conforming recommendation from the Commission for the distribution.~~

156 (b) The disbursement of money from the Settlement Fund and the Impact Fund, ~~distributed by the Consortium,~~
157 Fund shall be made by the State Treasurer upon authorization by all of the following, on a form designed for this purpose
158 by the chair of the ~~Consortium~~ Commission and the State Treasurer:

160 (2) The Director of the Office of Management and Budget.
161 (3) The Controller General.
162 (4) The co-chairs of the Joint Finance Committee.

163 (c) The Director of the Office of Management and Budget may waive the requirements under Chapter 69 of Title

168 (e) The ~~Behavioral Health Consortium~~ Prescription Opioid Settlement Distribution Commission shall distribute
169 the money in the Impact Fund based upon the recommendations of the ~~Prescription Opioid Settlement Distribution~~
170 ~~Commission. Fund.~~

171 § 4808B. Prescription Opioid Settlement Fund.

172 (g) The ~~Behavioral Health Consortium~~ Prescription Opioid Settlement Distribution Commission shall distribute
173 the money in the Settlement Fund based upon the recommendations of the ~~Prescription Opioid Settlement Distribution~~
174 ~~Commission. Fund.~~

SYNOPSIS

This Act makes the following updates to the Behavioral Health Consortium:

- Expands the charge of the Consortium to include all aspects of behavioral health care, in addition to substance use disorder.
- Adds term limits for appointed members.
- Modifies the membership to remove nonoperational organizations and include representation from the Maternal and Child Death Review Board and Delaware's Veteran community.
- Removes the Behavioral Health Commission's approval authority over the Prescription Opioid Settlement Distribution Commission's granting and contracting processes.

Additionally, this Act makes the following updates to the Prescription Opioid Settlement Distribution Commission:

- Revises the Commission's organization to reflect one Chairperson. The Commission may elect a vice chair from among its members.
- Updates authorities related to the distribution of the Prescription Opioid Settlement Fund and the Prescription Opioid Impact Fund.
- Ensures any reports produced by the Commission are distributed to the Behavioral Health Consortium.

This Act also makes minor technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.

This Substitute differs from the original House Bill No. 169 in that it incorporates the conforming changes in House Amendment No. 1 to House Bill No. 169 directly into the body of the bill.
