## HOUSE OF REPRESENTATIVES 149th GENERAL ASSEMBLY

## HOUSE BILL NO. 61

AN ACT TO AMEND TITLE 30 OF THE DELAWARE CODE RELATING TO PERSONAL INCOME TAX. BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE:

- 1 Section 1. Amend Chapter IX, Chapter 11, Title 30 of the Delaware Code by making deletions as shown by strikethrough
- 2 and insertions as shown by underline as follows:
- 3 § 1199. Habitat for Humanity of New Castle County Fund.
- 4 (a) There is hereby established a Habitat for Humanity of New Castle County Fund for individuals who claim an
- 5 overpayment of taxes to designate an amount to be deposited in such an account or individuals who have an income tax
- 6 liability to designate an amount to be paid to that Fund, pursuant to subsections (b) and (c) of this section.
- 7 (b) An individual who claims an overpayment of taxes on an income tax return may designate that \$1.00 or more
- 8 shall be deducted from the refund that would otherwise be payable to the individual and paid to the Habitat for Humanity of
- 9 <u>New Castle County Fund.</u>
- 10 (c) An individual who has an income tax liability may, in addition to the obligation, include a donation of \$1.00 or
- 11 more to be paid to the Habitat for Humanity of New Castle County Fund.
- 12 (d) The Division of Revenue shall provide a space on the Delaware income tax return form or schedule whereby
- 13 an individual may voluntarily designate a contribution of an amount of \$1.00 or more to the Habitat for Humanity of New
- 14 Castle County Fund.
- 15 (e) The Division of Revenue shall determine the total amount designated pursuant to this section and shall transfer
- 16 such amount to the Habitat for Humanity of New Castle County.
- 17 § 1200. Central Delaware Habitat for Humanity Fund.
- 18 (a) There is hereby established a Central Delaware Habitat for Humanity Fund for individuals who claim an
- 19 overpayment of taxes to designate an amount to be deposited in such an account or individuals who have an income tax
- 20 <u>liability to designate an amount to be paid to that Fund, pursuant to subsections (b) and (c) of this section.</u>

- 22 shall be deducted from the refund that would otherwise be payable to the individual and paid to the Central Delaware

- 31 § 1201. Sussex County Habitat for Humanity Fund.
- 32 (a) There is hereby established a Sussex County Habitat for Humanity Fund for individuals who claim an
- 33 overpayment of taxes to designate an amount to be deposited in such an account or individuals who have an income tax
- 34 <u>liability to designate an amount to be paid to that Fund, pursuant to subsections (b) and (c) of this section.</u>
- 35 (b) An individual who claims an overpayment of taxes on an income tax return may designate that \$1.00 or more
- 36 shall be deducted from the refund that would otherwise be payable to the individual and paid to Sussex County Habitat for
- 37 <u>Humanity Fund.</u>
- 38 (c) An individual who has an income tax liability may, in addition to the obligation, include a donation of \$1.00 or
- 39 more to be paid to the Sussex County Habitat for Humanity Fund.
- 40 (d) The Division of Revenue shall provide a space on the Delaware income tax return form or schedule whereby

- 42 <u>Humanity Fund.</u>
- 43 (e) The Division of Revenue shall determine the total amount designated pursuant to this section and shall transfer
- 44 <u>such amount to the Sussex County Habitat for Humanity.</u>
- 45 § 1202. Food Bank of Delaware Fund.
- 46 (a) There is hereby established a Food Bank of Delaware Fund for individuals who claim an overpayment of taxes
- 47 to designate an amount to be deposited in such an account or individuals who have an income tax liability to designate an
- 48 amount to be paid to that Fund, pursuant to subsections (b) and (c) of this section.

- 49 (b) An individual who claims an overpayment of taxes on an income tax return may designate that \$1.00 or more
- 50 shall be deducted from the refund that would otherwise be payable to the individual and paid to Food Bank of Delaware
- 51 <u>Fund.</u>
- 52 (c) An individual who has an income tax liability may, in addition to the obligation, include a donation of \$1.00 or
- 53 more to be paid to Food Bank of Delaware Fund.
- 54 (d) The Division of Revenue shall provide a space on the Delaware income tax return form or schedule whereby
- 55 <u>an individual may voluntarily designate a contribution of an amount of \$1.00 or more to the Food Bank of Delaware Fund.</u>
- 56 (e) The Division of Revenue shall determine the total amount designated pursuant to this section and shall transfer
- 57 such amount to the Food Bank of Delaware.

## **SYNOPSIS**

This bill will add 4 new check-off donation boxes on the Delaware personal income tax return whereby individuals may choose to donate a portion of their tax refund, or designate an amount in addition to the tax they owe that will be transferred by the Division of Revenue to one of the following organizations: Food Bank of Delaware, Sussex County Habitat for Humanity, Central Delaware Habitat for Humanity, or Habitat for Humanity of New Castle County.
