AN ACT TO AMEND CHAPTER 18, TITLE 22 OF THE DELAWARE CODE RELATING TO MUNICIPAL SPECIAL DEVELOPMENT DISTRICTS.

24	(1)(i) Create a special development district;
25	(2)(ii) Levy ad valorem or special taxes; and
26	(3)(iii) Issue bonds and other obligations.
27	(2) For any purpose stated in subsection (b)(3) of this section, any municipality may:
28	(i) Create a special development district;
29	(ii) Levy ad valorem or special taxes; and

44	payment, or reimbursement of a payment, of Other Obligations. Such agreement shall be between the municipality and

57	(3) Payment of the principal and interest on loans, including developer loans, money advances or any indebtedness
58	for any of the purposes stated in § 1802(b)(1) and (2) of this title, including the refunding of bonds previously issued under

60	Section 5. Amend §1805(a), Title 22 of the Delaware Code by making deletions as shown by strike through and
61	insertions as shown by underline as follows:
62	§ 1805. Actions necessary before issuing bonds. Special fund.
53	(a) Before issuing bonds pursuant to this section By resolution, the governing body of the municipality shall may:
54	(1) Designate by resolution an area or areas within the municipality as a special development district even
65	though no bonds authorized by this chapter have been issued by the municipality with respect to that special
66	development district or are then outstanding;
67	(2) Subject to subsection (b) of this section, adopt a resolution creating a special fund with respect to the
68	special development district; and
69	(3) Provide for the levy of an ad valorem or special tax on all real property within the special development
70	district at a rate or amount designed to provide adequate revenues to pay the principal of, interest on, and redemption
71	premium, if any, on the bonds, to replenish any debt service reserve fund, and for any other purpose related to the
72	ongoing expenses of or security, including debt service coverage requirements, for the bonds, or to secure payment by
73	the municipality of its obligations under an agreement described in § 1802(b)(3) of this title. Ad valorem taxes shall be
74	levied in the same manner, upon the same assessments, for the same period or periods, and as of the same date or dates
75	of finality as are now or may hereafter be prescribed for general ad valorem real property tax purposes within the
76	district, and shall be discontinued when all of the bonds have been paid in full. Special taxes shall be levied pursuant
77	to § 1813 of this title.

81	(a) When no bonds are outstanding, the municipality may use money in the special fund for payment or
82	reimbursement of debt service on Other Obligation that the municipality is obligated to pay under an agreement
83	described in § 1802(b)(3).
84	(b) When no bonds are outstanding with respect to a special development district and no Other Obligations are
85	outstanding:
86	(1) The special development district shall be terminated; and
87	(2) Any moneys remaining in the special fund on the date of termination of the special development
88	district shall be paid to the general fund of the municipality, as the case may be.
89	Section 7. This Act shall become effective upon its enactment into law

SYNOPSIS

This Act amends the definition of "municipality" in 22 Del. C. 1801(4) to allow the City of Dover to take advantage of the economic development opportunities afforded by Municipal Special Development Districts, and enables such municipality to pledge the special tax levied on the property in the special development district to the payment of bonds issued by other issuers in the State for the purposes of the municipal special development district financing act.
