## DELAWARE STATE SENATE 149th GENERAL ASSEMBLY

## SENATE BILL NO. 55

AN ACT TO AMEND TITLE 24 OF THE DELAWARE CODE RELATING TO PRIVATE INVESTIGATIVE, PRIVATE SECURITY AND ARMORED CAR AGENCIES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all members elected to each house thereof concurring therein):

- 1 Section 1. Amend § 1302, Title 24 of the Delaware Code concerning Private Investigators and Private Security Agencies,
- 2 by making deletions as shown by strike through and insertions as shown by underline as follows and by redesignating
- 3 accordingly:
- 4 § 1302 Definitions.
- As used in this chapter, unless the context requires a different definition:
- 6 (1) "Armored car company" or "agency" means any person that provides secured transportation and protection from
- 7 1 place or point to another place or point of money, currency, coins, bullion, securities, bonds, jewelry or other
- 8 valuables.
- 9 (2) "Board" means the Delaware Board of Examiners of Private Investigators and Private Security Agencies.
- 10 (3) "Branch office license" means a permit granted by the Board entitling a person to operate as a security services
- 11 contractor or investigations company at a location other than the principal place of business as shown in the Board
- 12 records.
- 13 (4) "Commissioned security officer" means any security officer to whom a security officer commission has been
- issued by the Board.
- 15 (5) "Computer forensic specialist", means persons who interpret, evaluate, test, or analyze pre-existing data from
- 16 computers, computer systems, networks, or other electronic media, provided to them by another person where that
- 17 person owns, controls, or possesses said computer, computer systems, networks, or electronic media.
- 18 (6) "Deadly weapon" has the meaning given in the definition of "deadly weapon" in § 222 of Title 11.
- 19 (7) "Director" means the officer in charge of the Professional Licensing Section of the Division of the Delaware

| 60 | (19) "Security officer" means any individual employed by a security services contractor or the security department       |
| 61 | of a private business to perform the duties of a security guard, security watchperson, security patrol, armored car      |
| 62 | guard or courier guard.  |
| 63 | (20) "Security officer commission" means an authorization granted by the Board to an individual employed as a            |
| 64 | security officer to carry a firearm.   |
| 65 | (21) "Security services contractor" means any guard company, armored car company or courier company as defined           |
| 66 | herein.  |
| 67 | (a) "Armed" shall mean any private security guard or armored car guard who carries or has immediate access to a          |
| 68 | firearm in the performance of their duties.  |
| 69 | (b) "Armored car agency" shall mean any person that provides armed secured transportation and protection from one        |
| 70 | place or point to another place or point of money, currency, coins, bullion, securities, bonds, jewelry, negotiables or  |
| 71 | other valuables in a specially-equipped motor vehicle.   |
| 72 | (c) "Armored car guard" shall mean an individual employed by an armored car agency to perform duties as described        |
| 73 | under the definition of armored car agency.  |
| 74 | (d) "Board" shall mean the Delaware Board of Examiners of Private Investigators and Private Security Agencies.           |
| 75 | (e) "Commissioned security guard" shall mean an individual employed to (i) safeguard and protect persons or property     |
| 76 | or (ii) deter theft, loss or concealment of any tangible or intangible personal property on the premises he/she is       |
