HOUSE OF REPRESENTATIVES 149th GENERAL ASSEMBLY

HOUSE BILL NO. 372

AN ACT TO AMEND TITLE 4 OF THE DELAWARE CODE RELATING TO CONCENTRATED ALCOHOLIC BEVERAGE.

1	WHEREAS, with the increase in binge drinking and overconsumption of alcohol, both nationally and in Delaware,
2	new forms of alcohol consumption have occurred; and
3	WHEREAS, nationally, states have seen the creation of powdered alcohol, which is a powder that when
4	reconstituted with a liquid forms an alcoholic drink; and
5	WHEREAS, public health professionals and state government officials have raised concerns about powdered
6	alcohol, stating that the convenience of the packets could intentionally or unintentionally result in stronger than standard
7	drinks and harmful overconsumption; and
8	WHEREAS, the American Medical Association released a June 14, 2016, press release calling for the nationwide
9	ban of powdered alcohol; and
10	WHEREAS, Delaware would become the 37th state to ban powdered alcohol consumption, possession, and
11	distribution if this Act is enacted; and
12	WHEREAS, banning powdered alcohol ensures a proper response to a potential public health crisis.
13	NOW, THEREFORE:
14	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all
15	members elected to each house thereof concurring therein):
16	Section 1. Amend § 101, Title 4 of the Delaware Code by making deletions as shown by strikethrough and
17	insertions as shown by underline as follows:
18	§ 101. Definitions.
19	As used in this title, in addition to their usual meaning:
20	(2) "Alcoholic liquor" or "alcoholic liquors" include the 5 varieties of liquor defined in this section (alcohol,
21	spirits, wine, beer and alcoholic cider) as well as every liquid or solid, patented or not, containing alcohol, spirits, wine,
22	beer or alcoholic cider and capable of being consumed by a human being, and any liquid or solid containing more than

1 of the 5 varieties defined in this section is considered as belonging to that variety which usually has the higher

24	percentage of alcohol. A concentrated alcoholic beverage shall be an "alcoholic liquor" for purposes of this title.
25	"Alcoholic liquor" or "alcoholic liquors" does not include a concentrated alcoholic beverage. Notwithstanding any
26	other definition in this chapter, "alcoholic liquor" shall does not include solids and confections that contain 2% or less
27	alcohol by weight, so long as the package which contains the product and/or_or_any menu or other medium noticing
28	the product for sale-shall, if the product contains between 1/2 of 1% alcohol by volume and 2% alcohol by weight, be-is
29	labeled with the word "alcoholic", the phrase "contains alcohol", or some other indication that the product contains
30	alcohol.
31	(13) "Concentrated alcoholic beverage" shall mean means any powders or powders, crystals, liquid liquids, or
32	any other substances which, after being mixed with sugar, water water, or any other nonalcoholic materials, ferments
33	or otherwise becomes a wine, beer beer, or other alcoholic beverage.
34	Section 2. Amend § 903, Title 4 of the Delaware Code by making deletions as shown by strikethrough and
35	insertions as shown by underline as follows:
36	§ 903. Offenses carrying penalty of fine of not more than \$100 or imprisonment for 1 month on failure to pay fine.
37	Whoever:
38	(16) Being the holder of a license to sell alcoholic liquor, fails to post in a conspicuous place a sign which
39	clearly reads, "According to the Surgeon General, women should not drink alcoholic beverages during pregnancy
40	because of the risk of birth defects," defects"; or
41	(17) Manufactures, distributes, sells, offers for sale, possesses, purchases, or uses a concentrated alcoholic

shall be imprisoned for 30 days. Justices of the peace shall have original jurisdiction to hear, try, and finally determine

shall, in addition to the payment of costs, be fined not more than \$100, and, on failure to pay such fine and costs,

This Act makes it unlawful for a person to manufacture, distribute, sell, offer for sale, possess, purchase, or use a concentrated alcoholic beverage.

This Act also makes technical corrections to conform existing law to the standards of the Delaware Legislative Drafting Manual.
