SENATE CONCURRENT RESOLUTION NO. 22

WHEREAS, brain injuries are a serious public health concern due to their devastating initial and long term

2	impacts on the patient, their families, and community; and
3	WHEREAS, a brain injury occurs in the United States every nine seconds due to falls, vehicular crashes o
4	incidents, assault, or sporting activity, meaning that more than 3.5 million children and adults sustain such an injury each
5	year; and according to the National Institutes of Health, by the year 2020, it will surpass many diseases as the major cause
6	of death and disability; and
7	WHEREAS, 153 people in the United States die every day (over 50,000 per year) due to traumatic brain and
8	related injuries, and the Center for Disease Control and Prevention informs us that traumatic Brain injuries contribute to
9	about 30% of all injury deaths; and
10	WHEREAS, according to the Delaware Trauma System Registry, 1,397 Delawareans were hospitalized in 2010
11	and 1,170 were hospitalized in 2017 with a traumatic brain injury; and
12	WHEREAS, the Center for Disease Control and Prevention has tracked 1 of every 60 people in the United States
13	(more than 5.3 million Americans) who live with a traumatic brain injury related disability, and the consequences of severe
14	traumatic brain injury impacts their relationships with family and friends, their ability to be employed, and their ability to
15	participate in activities of daily living such as household tasks, or driving; and
16	WHEREAS, the Center for Disease Control and Prevention calculates that acute care and rehabilitation of brain
17	injury patients in the United States costs about \$9 billion to \$10 billion per year, not including indirect and additional costs
18	such as lost earnings, work time, and productivity; and social service costs of up to \$1.8 million per survivor of severe
19	traumatic brain injury over their lifetime; and
20	WHEREAS, Delaware is not among the 26 states that have a traumatic brain injury registry or a State Head Injury
21	Coordinator to collect and analyze data that could be utilized to expand traumatic brain injury services, provide public
22	education to promote the prevention of injuries, and provide additional information on contributing factors for traumatic
23	brain injuries and disabilities that affect our communities; and

and seatbelts, preventing falls, cushioning playgrounds, teaching safe play, and avoiding risky behaviors.

Representatives concurring therein, that March 2019, is recognized as Brain Injury Awareness Month.
