SENATE BILL NO. 52

AN ACT TO AMEND TITLE 11 OF THE DELAWARE CODE RELATING TO THE DELAWARE CRIMINAL CODE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF DELAWARE (Two-thirds of all members elected to each house thereof concurring therein):

24	(4) "Acquittal of inclusive offense" means a finding of guilt of an included offense is an acquittal of the

26	(5) "Adulterated" means varying from the standard of composition or quality prescribed by or under any
27	statute providing criminal penalties for such variance, or set by established commercial usage.

33	(10) "Authorized prescription" means a prescription issued by a licensed practitioner who has a patient-
34	practitioner relationship with the intended recipient of the prescription drug.
35	(11) "Bump stock" means an after-market device that increases the rate of fire achievable with a semi-
36	automatic rifle by using energy from the recoil of the weapon to generate a reciprocating action that facilitates repeated
37	activation of the trigger.
38	(12) "Catastrophe" means any of the following:
39	a. Serious physical injury to 5 or more persons.
40	b. Substantial damage to 5 or more buildings or habitable structures.
41	c. Substantial damage to a vital public facility that seriously impairs its usefulness or operation.
42	(13) "Catastrophic agent" means an explosive, incendiary device, timing or detonating mechanism for an
43	incendiary device, poison or poisonous gas, deadly biological or chemical contaminant or agent, or radioactive
44	substance.
45	(14) "Chemically impaired" means, except as authorized by law, an individual is or has any of the following:
46	a. Less able than an individual would ordinarily have been, either mentally or physically, to exercise clear
47	judgment, sufficient physical control, or due care due to consumption of alcohol, a controlled substance, another
48	intoxicating substance, or a combination of alcohol, a controlled substance, or another intoxicating substance.
49	b. An alcohol concentration of .08 or more, meaning any of the following:
50	1. An amount of alcohol in a sample of an individual's blood equivalent to .08 or more grams of
51	alcohol per 100 milliliters of blood.

52	2. An amount of alcohol in a sample of an individual's breath equivalent to .08 grams per 210 liters
53	of breath.
54	c. Blood containing any amount of the following substances, or a preparation or mixture containing 1 of
55	them:
56	1. A Schedule I controlled substance under § 4714 of Title 16.
57	2. Cocaine, as described in § 4716 of Title 16.
58	3. Amphetamine, including its salts, optical isomers, and salt of its optical isomers, as described in §
59	4716 of Title 16.
60	4. Methamphetamine, including its salt, isomer or salt of an isomer thereof, as described in § 4716 of
61	<u>Title 16.</u>
62	5. Phencyclidine, as described in § 4716 of Title 16.
63	6. A designer drug, as defined in § 4701 of Title 16.
64	(15) "Child" means a person less than 18 years old, unless a specific provision of this part provides otherwise.
65	(16) "Child pornography" means a visual depiction of a person less than 18 years old engaged in sexual
66	conduct regardless of any of the following:
67	a. Whether the conduct is actual or simulated.
68	b. Whether the depiction has been created, adapted, modified, or edited to merely appear as though the
69	person is engaged in sexual conduct.
70	(17) "Circumstance element" means any objective element that is not a conduct or result element.
71	(18) "Combat event" means any match, contest, or event that features boxing, mixed martial arts, or any other
72	combative sport.
73	(19) "Commercial animal" means an animal that is all of the following:
74	a. Grown, raised, or produced in the State for sale or resale of a product of the animal.
75	b. Sold or resold by a person that has all necessary licenses for the sale or resale of a product of the
76	animal.
77	c. Sold or resold by a person that receives at least 25% of the person's annual gross income from that sale
78	or resale of a product of the animal.
79	(20) "Commercial electronic mail" means any electronic mail message that is sent to a receiving address or
80	account for the purposes of advertising, promoting, marketing, or otherwise attempting to solicit interest in any good,
81	service, or enterprise.

82	(21) "Computer services" includes computer access to computer networks, data processing, and data storage.
83	(22) "Computer system" means a computer, its software, related equipment, or communications facilities.
84	(23) "Conduct element" means a part of an offense that requires a person's act or failure to perform a legal
85	<u>duty.</u>
86	(24) "Consequence" means a result element of an offense and the attendant circumstance elements that
87	characterize the result.
88	(25) "Contents of a communication" includes any information concerning the identity of a party to the
89	communication or the existence, substance, or meaning of that communication.
90	(26) "Controlled substance" means a drug, substance, or immediate precursor in Schedules I through V of
91	Subchapter II of Chapter 47 of Title 16, and includes designer drugs.
92	(27) "Conviction" means a prosecution that resulted in 1 of the following:
93	a. A judgment of conviction that has not been reversed or vacated.
94	b. A verdict of guilty that has not been set aside and is capable of supporting a judgment.
95	c. A plea of guilty or nolo contendere accepted by the court.
96	(28) "Correctional officer" means an individual employed to supervise and control individuals incarcerated in
97	or in the custody of a correctional institution or the Division of Youth Rehabilitative Services.
98	(29) "Counterfeit mark" means any unauthorized reproduction or copy of intellectual property or intellectual
99	property affixed to any item knowingly sold, offered for sale, manufactured, or distributed, or identifying services
100	offered or rendered without the authority of the owner of the intellectual property.
101	(30) "Criminal negligence" means as defined in § 205(b)(4) of this title.
102	(31) "Criminal street gang" means any ongoing organization, association, or group of 3 or more persons,
103	whether formal or informal, that has all of the following:
104	a. A common name or common identifying sign or symbol.
105	b. Members who individually or collectively engage in or have engaged in a pattern of criminal gang
106	activity.
107	c. As one of its primary activities, the commission of criminal offenses.
108	(32) "Criminally negligent mistake" means an erroneous belief that a person is criminally negligent in
109	forming or holding.
110	(33) "Cruelty" means any act or omission whereby unnecessary or unjustifiable physical pain, suffering, or
111	death is caused or permitted.

112	(34) "Damage", when referring to property, means impairing a property's usefulness or value by any means,
113	and includes deleting or altering computer programs or other electronically recorded data, or impairing access to
114	computer services.
115	(35) "Dangerous instrument" means any instrument, article, or substance that, under the circumstances in
116	which it is used or threatened to be used, is readily capable of causing death or serious physical injury. "Dangerous
117	instrument" includes disabling sprays, such as pepper spray, and electronic devices designed to incapacitate an
118	individual, such as tasers.
119	(36) "Data" means information of any kind in any form.
120	(37) "Deadly force" means force that a person intends to cause, or knows creates a substantial risk of causing,
121	death or serious physical injury. "Deadly force" includes intentionally firing a firearm under either of the following
122	<u>circumstances:</u>
123	a. In the direction of another person.
124	b. At a vehicle in which the person believes another person to be riding.
125	(38) "Deadly weapon" includes any of the following:
126	a. A firearm, whether operable or inoperable.
127	b. A bomb; switchblade knife; knife, other than a folding knife, 3 inches or less in length in its closed
128	position; billy; blackjack; bludgeon; metal knuckles; slingshot; or razor.
129	c. A dangerous instrument, when it is used with intent to cause death or serious physical injury.
130	(39) "Deadly weapon designed for the defense of one's person" includes a pistol, revolver, stiletto, or steel or
131	brass knuckles. "Deadly weapon designed for the defense of one's person" does not include a toy pistol, pocketknife,
132	knife used for sporting purposes or in domestic households, or surgical instrument.
133	(40) "Dealer" means a person in the business of buying, selling, or lending on the security of goods, including
134	a pawnbroker.
135	(41) "Deceiving", "deceive", or "deception" means any of the following:
136	a. Creating or reinforcing a false impression as to any fact.
137	b. Preventing another person from acquiring information that would adversely affect the other person's
138	judgment of a transaction.
139	(42) "Defendant" means a person accused or convicted of committing a criminal offense.
140	(43) "Defense" means a provision in this part that explicitly uses the word "defense," other than a general
141	defense provision. A defense negates potential liability for an offense.

142	(44) "Defraud" means to obtain anything of value through deception.
143	(45) "Deliver" or "delivery" means the actual or constructive transfer from one person to another, regardless
144	of whether there is an agency relationship.
145	(46) "Dependent child" means either of the following:
146	a. An individual less than 18 years old.
147	b. An individual more than 18 years old but less than 19 years old who is enrolled in high school.
148	(47) "Deprive" means to do any of the following:
149	a. Withhold property of another person permanently or for so extended a period as to appropriate a major
150	portion of its economic value, or with the intent to restore it only upon payment of a reward or other
151	compensation.
152	b. Dispose of property of another person so as to make it unlikely that the owner will recover it.
153	(48) "Destructive weapon" means any of the following:
154	a. A bomb or bomb shell.
155	b. A firearm silencer.
156	c. A shotgun that meets any of the following conditions:
157	1. Has 1 or more barrels less than 18 inches in length.
158	2. Is modified to have an overall length of less than 26 inches.
159	d. A machine gun or weapon that is adaptable for use as a machine gun.
160	(49) "Drug paraphernalia" means as defined in § 4701 of Title 16, but does not include items that are
161	traditionally intended for use with tobacco products, such as pipes, paper, or accessories.
162	(50) "Dwelling" means a structure or vehicle in which a person usually lodges.
163	(51) "Electronic communication" means any communication made in whole or in part through the use of
164	facilities for the transmission of communications by the aid of electronic, microwave, radio, cable, satellite, or other
165	connection between the point of origin and the point of reception furnished or operated by a common carrier.
166	(52) "Electronic mail" means any message that is automatically passed from an originating address or account
167	to a receiving address or account.
168	(53) "Enterprise" means any of the following:
169	a. Sole proprietorship, partnership, corporation, trust, or governmental or other legal entity.
170	b. Union, association, or group of persons associated in fact, even if not a legal entity.

171	(54) "Entry" means a person introduces a body part or a part of an instrument, by whatever means, into or
172	upon premises.
173	(55) "Exception to liability" means a provision in this part stipulating a modification or refinement of a single
174	offense or a related group of offenses, other than a defense or a general defense provision. An exception to liability
175	negates potential liability for an offense.
176	(56) "Excuse defense" means a defense described in Subchapter II of Chapter 3 of this part.
177	(57) "Firearm" means any weapon from which a bullet, projectile, or other object may be discharged by force
178	of combustion, explosive, gas, or mechanical means, regardless of whether the weapon is loaded or stored in multiple
179	pieces. "Firearm" does not include a B.B. gun.
180	(58) "Force" means the exercise of physical power, violence, or pressure against a person or thing, and
181	includes confinement or restraint.
182	(59) "Funerary object associated with interment" means any of the following:
183	a. An item of human manufacture or use that has been intentionally placed with human remains at the
184	time of interment in a burial site, or later as a part of a death rite or ceremony of a culture, religion, or other group.
185	b. A gravestone, monument, tomb, or other structure in or directly associated with an existing burial site.
186	(60) "Gambling device" means a device, machine, table, paraphernalia, or equipment designed for use in the
187	playing phases of any gambling activity. "Gambling device" does not include a lottery ticket.
188	(61) "Gender identity" means a gender-related identity, appearance, expression, or behavior of an individual,
189	regardless of the individual's assigned sex at birth.
190	(62) "General defense" means the provisions of Chapter 3 of this part.
191	(63) "Genitalia" means any of the following:
192	a. A vagina, labia minora, labia majora, or clitoris.
193	b. A penis or scrotum.
194	(64) "Handgun" means a pistol, revolver, or other firearm designed to be fired when held in 1 hand.
195	(65) "Harm to another person" means loss, disadvantage, injury, or anything so regarded by the person
196	affected, including acts done to a third person in whose welfare the person is interested.
197	(66) "High managerial agent" means an officer of an organization, or any other organizational agent in a
198	position of comparable authority as to the formulation of organizational policy or the managerial supervision of
199	subordinate employees.

(67) "Human remains" means any part of the body of a deceased individual in any stage of decomposition.

201	(68) "Improperly terminated" means a prosecution that is terminated for reasons that do not include an
202	acquittal and takes place after the first witness is sworn but before the verdict. "Improperly terminated" does not
203	include either of the following circumstances:
204	a. The person consents to the termination or waives, by motion to dismiss or otherwise, the right to object
205	to the termination.
206	b. The trial court declares a mistrial in accordance with law.
207	(69) "Incendiary device" means an item designed to ignite by hand, chemical reaction, or spontaneous
208	combustion, and includes bombs and other explosives.
209	(70) "Inchoate offense" means any offense defined in Chapter 5 of this title.
210	(71) "Intentionally" means as defined in § 205(b)(1) of this title.
211	(72) "Intercept" or "interception", when referring to a communication, means visual acquisition, aural
212	acquisition, or the recording by any means of all or part of the contents of the communication.
213	(73) "Internet pharmacy" does not include a pharmacy for which the Delaware State Board of Pharmacy has
214	issued a valid permit or license. "Internet pharmacy" means a person who meets all of the following conditions:
215	a. Maintains a website that solicits, receives, or offers to solicit or receive prescription drug orders.
216	b. Dispenses or delivers, or intends to dispense or deliver, prescription drug orders to patients in this State
217	through the mail or other delivery service.
218	(74) "Intoxication" means a disturbance of mental or physical capacities resulting from the introduction of a
219	substance into the body.
220	(75) "Involuntary intoxication" means intoxication that does not meet the definition of "voluntary
221	intoxication".
222	(76) "Issue a check" means a person meets all of the following conditions:
223	a. Is the drawer of the check or signs in a capacity as representative or agent of the principal drawer or
224	obligor.
225	b. Delivers or causes the check to be delivered to a person who acquires a right against the drawer as to
226	the check by reason of delivery.
227	(77) "Juror" means a person who has received notice of summons to appear for jury service.
228	(78) "Justification defense" means a defense described in Subchapter I of Chapter 3 of this part.
29	(79) "Knowingly" means as defined in 8 205(b)(2) of this title

230	(80) "Law enforcement officer" means a public servant that a law or government agency authorizes to engage
231	in or supervise the prevention, detection, investigation, or prosecution of offenses.
232	(81) "Leaf marijuana" means the dried leaves and flowering tops of the plant cannabis sativa L.
233	(82) "Loiters" means to stand or sit idly without a legitimate reason for doing so.
234	(83) "Lottery ticket" means a policy, number, certificate, or device that entitles the holder to receive property
235	upon a contingency based in chance, including number series. "Lottery ticket" does not include entry in a savings
236	promotion raffle that conforms with the requirements of § 933 of Title 5, unless the chance to win a prize requires
237	consideration other than deposit of a specified minimum amount of money in a savings account or other savings
238	program.
239	(84) "Mental illness or serious mental disorder" means any condition of the brain or nervous system
240	recognized as a mental disease by a substantial part of the medical profession. "Mental illness" does not mean
241	intoxication or an abnormality manifested only by repeated criminal or otherwise antisocial conduct.
242	(85) "Mislabeled" means varying from the standard of truth or disclosure in labeling prescribed by or under
243	any statute providing criminal penalties for such variance, or set by established commercial usage.
244	(86) "Mitigation" means a provision in this part stipulating the conditions for decreasing the punishment for
245	an offense. A mitigation establishes a partial reduction of potential liability for an offense.
246	(87) "Motor vehicle" means an automobile, motorcycle, van, truck, trailer, semitrailer, truck tractor and
247	semitrailer combination, or any other vehicle which is self-propelled, designed to be operated primarily on a roadway
248	as defined in § 101 of Title 21, and in, upon, or by which a person or property is or may be transported. "Motor
249	vehicle" does not include a device that is included in the definitions of "moped", "off-highway (OHV)", "triped",
250	"motorized scooter or skateboard", "motorized wheelchair" or "electric personal assistive mobility device", as those
251	terms are defined in § 101 of Title 21.
252	(88) "Neglect of a child" means as "neglect" or "neglected child" are defined in § 901 of Title 10.
253	(89) "Night" means a period between 30 minutes after sunset and 30 minutes before sunrise.
254	(90) "Nonexculpatory defense" means a defense, bar to prosecution, or bar to pleading, trial, or sentencing
255	described in Subchapter III of Chapter 3 of this part.
256	(91) "Oath" includes an affirmation and every other mode authorized by law of attesting to the truth of a
257	statement.
258	(92) "Obscene" means an actual or simulated material or performance that meets all of the following

conditions:

259

260	a. The average person, applying contemporary adult community standards, would find that, taken as a
261	whole, appeals to the prurient interest.
262	b. Depicts or describes, in a patently offensive way, any of the following:
263	1. An ultimate sexual act.
264	2. A sadomasochistic sexual act.
265	3. Masturbation.
266	4. Excretory functions.
267	5. Lewd exhibition of the genitals.
268	c. Taken as a whole, lacks serious literary, artistic, political, or scientific value.
269	(93) "Obtain" means either of the following:
270	a. In relation to property, to bring about or receive a transfer or purported transfer of any interest in
271	property.
272	b. In relation to labor or services, to secure performance of the labor or services.
273	(94) "Oral or object penetration" means any of the following:
274	a. Placing any object, substance, or body part inside the anus or vagina of another individual.
275	b. An individual's placing of an object inside another individual's mouth, intending the act to be sexual in
276	nature.
277	(95) "Organization" means any person, but does not include individuals.
278	(96) "Originating address" or "originating account" means the sequence of characters used to specify the
279	source of any electronic mail message.
280	(97) "Overdose" means an acute condition including physical illness, coma, mania, hysteria, or death resulting
281	from the consumption or use of an ethyl alcohol, a controlled substance, another substance with which a controlled
282	substance was combined, a noncontrolled prescription drug, or any combination of these, including any licit or illicit
283	substance.
284	(98) "Owner" means a person, other than the defendant, who has possession of or any other interest in the
285	property involved, even if such interest or possession is unlawful, and without whose consent the defendant has no
286	authority to exert control over the property.
287	(99) "Party officer" means a person who holds any position or office in a political party, whether by election,
288	appointment, or otherwise.
289	(100) "Pass a check" means a person meets all of the following conditions:

290	a. Is a payee, holder, or bearer of a check that purports to have been drawn and issued by another.
291	b. Delivers the check for a purpose other than collection to a third person who acquires a right as to the
292	check by reason of delivery.
293	(101) "Patient-practitioner relationship" means as defined in § 4701 of Title 16.
294	(102) "Pattern of criminal gang activity" means the commission of 2 or more incidents of conduct, the last of
295	which occurred within 3 years of a prior offense, that constitute felony violations of offenses involving violence
296	coercion, sexual activity, controlled substances, property damage, or deadly weapons, and were committed under any
297	of the following circumstances:
298	a. On separate occasions.
299	b. By 2 or more persons.
300	(103) "Pattern of racketeering activity" means the commission of 2 or more incidents of conduct that meet all
301	of the following conditions:
302	a. The last incident of conduct occurred within 10 years of a prior incident of conduct.
303	b. Are related to the affairs of the enterprise.
304	c. Are not so closely related to each other and connected in time and place that they constitute a single
305	event.
306	d. Constitute at least 1 of the following:
307	1. An activity defined as "racketeering activity" under 18 U.S.C.A. § 1961(1)(A), (1)(B), (1)(C), or
308	<u>(1)(D).</u>
309	2. A felony under this part.
310	(104) "Payment card" means any instrument or device issued by an issuer for use of the cardholder in
311	obtaining anything of value on credit, by withdrawing funds from a deposit account, or through use of value stored or
312	the card. "Payment card" includes the number assigned to the card, even if the physical instrument or device is not used
313	or presented.
314	(105) "Peace officer" means a person who, by virtue of the person's office or public employment, is vested by
315	law with a duty to make arrests for offenses, whether that duty extends to all offenses or is limited to specific offenses
316	and regardless of the person's jurisdiction.
317	(106) "Penal custody" means custody in a detention facility or a facility of the Department of Corrections.
318	(107) "Person" means any of the following:
319	a. A human being who has been born and is alive.

320	b. Where appropriate, a public or private corporation, trust, firm, joint stock company, union,
321	unincorporated association, partnership, government, or governmental instrumentality.
322	(108) "Personal benefit" means any of the following:
323	a. A personal gain or advantage to the recipient.
324	b. A gain or advantage conferred on the behalf of another person in whose welfare the person is
325	interested.
326	(109) "Personal identifying information" includes name, address, birth date, Social Security number, driver's
327	license number, telephone number, financial services account number, savings account number, checking account
328	number, payment card number, identification document or false identification document, electronic identification
329	number, educational record, health care record, financial record, credit record, employment record, e-mail address,
330	computer system password, mother's maiden name, or similar personal number, record or information.
331	(110) "Physical evidence" means any object, document, record, or other physical item that is or will be used
332	as evidence in an official proceeding.
333	(111) "Physical injury" means either of the following:
334	a. If the injured person is a child: impairment of physical condition or pain.
335	b. In all other instances: impairment of physical condition or substantial pain, including physical harm
336	that would normally cause substantial pain.
337	(112) "Place open to public view" means any place where it is not reasonable to expect to see the conduct
338	without prior knowledge or consent.
339	(113) "Position of trust, authority, or supervision" means both of the following apply to a person:
340	a. Has regular direct contact with 1 or more children because of the person's familial relationship,
341	profession, employment, vocation, avocation, or volunteer service.
342	b. In the course of contact defined in section (111)a. of this definition, the person assumes responsibility,
343	whether temporary or permanent, for the care or supervision of 1 or more children.
344	(114) "Practitioner" means a physician, dentist, veterinarian, scientific investigator, pharmacy, hospital, or
345	other person licensed, registered, or otherwise permitted to distribute, dispense, administer, or conduct research on a
346	controlled or noncontrolled substance in the course of professional practice or research in this State.
347	(115) "Previous pattern of abuse or neglect."
348	a. The term means 2 or more incidents of conduct that satisfy both of the following:

SYNOPSIS

Delaware's existing Criminal Code was adopted in 1973 and was based on the Model Penal Code. Since that time, the Criminal Code has quadrupled in size and provisions related to crimes expanded to other parts of the Code without consideration to the general effects of the change on the Criminal Code's overall structure, its terminology, or its application, creating numerous inconsistencies, redundancies, ambiguities and contradictions. In 2014, the General Assembly established the Criminal Justice Improvement Committee to review opportunities for efficiencies in the Delaware Criminal Code, including identifying: "disproportionate, redundant, outdated, duplicative, or inefficient statutes" and "crimes that should or should not constitute potential jail time." The Criminal Justice Improvement Committee Working Group was created to accomplish the Criminal Justice Improvement Committee's stated goals and has worked diligently for the last three years, in concert with other criminal justice stakeholders, to restore the criminal code to a clear, readable, and proportional code. The recommendations found in their Final Report are the bases for this Act and its companion bill.

This Act is one of two bills that seek to bring back clarity and consistency to the Criminal Code. This Act repeals and replaces Title 11, Part I, Chapters 1 through 15 of the Delaware Criminal Code and replaces those provisions with an improved code that is easy to understand, consolidates offenses and introduces rational and proportional sentencing structures. This Act, and its companion bill, will take effect 20 months from the date of enactment, to allow for a smooth integration of the improved code into existing structures, give public and private criminal justice stakeholders an opportunity to familiarize themselves with the improved code, and provide an opportunity to develop for the first time model jury instructions and sentencing guidelines. A Commentary, which explains how the current criminal code relates to the improved code, will be publicly available during this transition period. The 20 months will also give time to introduce technical corrections bills that will make changes to the Code necessitated by the improved code (e.g., update cross references to Title 11, Part I, found in other Titles), as well as incorporate legislative decisions passed by the 148th and 149th General Assembly that were not captured by the improved code.
